7. [16:11] The Chief Whip moved: That, notwithstanding Rule 161(3), the House considers the finalisation of the *Western Cape Unauthorised Expenditure Bill* [B 7 – 2013] should the principle of the Bill be approved.

8. Ms L Brown moved without notice: That the House extends its condolences to the family and friends of Dr Pat Gorvalla, a leading business woman, a former member of the Council of the University of the Western Cape and President of the Anglican Women's Fellowship (AWF), who passed away during the past week.
