1. The House met at 14:15.

- 2. The Speaker took the Chair and read the prayer.
- 3. [14:17] The Chief Whip moved without notice: That, notwithstanding Rule 198, precedence be given to the Subject for Discussion.

Agreed to.

 [14:18] The House discussed the following subject in the name of honourable M N Gillion: The failure of the DA-run Western Cape government to address social challenges in the Province.

[17:53] Ms M M Maseko moved without notice: That the House notes with great sadness the passing of the Bangani family, who perished in a fire in their home, where the family of eight, including five children, lived in Taiwan Informal Settlement in Khayelitsha; further bids them: Rest well, Nontlupheko Bangani, Dumile Bangani, Wanda Bangani, Sisipho Bangani, Abongile Bangani, Athi Bangani, Endinako Bangani and Lili Bangani. May their spirits rest in peace.

10. Mr N E Hinana moved without notice: That the House expresses its gratitude to the greatest woman, Nokhawulezile Jadi, from Siyahlala in Philippi who joyfully celebrated her 100th birthday party on 5 May 2018; further wishes that the community may drink from her well of wisdom.

11. Mr T A Simmers moved without notice: That the House notes the success of the Eden District Municipality's firefighters, who outshone 10 other Western Cape firefighting units in an obstacle course competition in celebration of International Firefighters Day on 4 May 2018; acknowledges the firefighters of the Western Cape, who offer us an invaluable service, for which we are ever grateful.

Ms L J Botha moved without notice: That the House notes the tragic murder of 20-yearold Zenith Daniels from Delft; further notes that Zenith was last seen on Sunday evening by her family when she left home with friends, and that her body was later found in an open veld; extends its condolences to the family and friends of Zenith Daniels; and calls on the SAPS to find and arrest those who had committed this gruesome murder.

13. Ms P Z Lekker moved without notice: That the House notes and condemns the killing of a young man in the Siqalo Informal Settlement service delivery protest; notes further that the man died when a taxi drove into a group of protesters; and conveys condolences to the family and friends of Mohammad Tauriq Mohammad, who was 19 years old.

14. Mr R D Mackenzie moved without notice: That the House commends and congratulates Mr Freddie Blom on his birthday and for reaching the milestone age of 114 years; furthermore wishes him and his wife Auntie Netta well; and also congratulates them on celebrating 48 years of marriage.

15. Ms L J Botha moved without notice: That the House notes the celebration of International Nurses Day, which takes place around the world on 12 May 2018; further notes that this day celebrates the contributions made by these individuals, who play such a pivotal role in our society, and also marks the anniversary of Florence Nightingale's birth; and on this note ends with a quote from Florence Nightingale, which encapsulates the contributions that nurses make in our society: "I attribute my success to this - I never gave or took any excuse. The greatest heroes are those who do their duty in the daily grind of domestic affairs whilst the world whirls as a maddening dreidel."

Ms P Z Lekker moved without notice: That the House notes that the killing of women and children continues unabated in the province; further demands of the provincial government, following the discovery of the unidentified body of a young woman who was apparently raped, stabbed to death and dumped in a field in Delft, to introduce more awareness programmes to create a safer environment for women and children, who are targeted in the province.

Mr C M Dugmore moved without notice: That the House notes the killing of the elderly parents of education expert Prof Graeme Bloch and his wife, ANC stalwart and political activist Cheryl Carolus, and grandparents of their children; notes that it is suspected the two were robbed and murdered in their house in Rosebank over the weekend; conveys condolences to the family, their friends and comrades; and calls on the police to bring the perpetrators to book speedily.

21. Ms C F Beerwinkel moved without notice: That the House congratulates and supports the newly formed Action to Action Group in Kuils River, that has registered with the Department of Social Services so that they can fill the gap in services and projects that aim to uplift the local community, and also to build strong community and family values and to assist community members to equip themselves with the necessary skills to become self-sufficient.
