10. Mr B D Kivedo moved without notice: That the House congratulates Mr Kristoff Mark Isaacs a Science and Mathematics Educator at the rural Chatsworth Primary school near Malmesbury, for being awarded a bursary to pursue specialist studies in Mathematics and Science at the University of Utrecht in the Netherlands, and that he is one of only 4 bursary recipients from the Western Cape and the only one in the employ of the WCED.

11. Ms B A Schäfer moved without notice: That the House congratulates the Democratic Alliance on winning 17 out of the 19 by-elections yesterday and in particular, Helen Carsten's from Ward 5 for achieving an unprecedented 99.65% win.

14. Mr M Mnqasela moved without notice: That the House deplores the unscrupulous rumours spread regarding the wellbeing of a well-known and loved businessman, Mr Mzoli Ngcawuzele yesterday, announcing him as dead, whereas he is well and remains in good health.

Ms S W Davids moved without notice: That the House commends the Minister of Land affairs, Mr Gugile Nkwinti for his intervention in finalising and paying out within three months the restitution claimants of the Rooikamp and Lulle Street areas of Witzenberg who has been waiting for eighteen years for this restitution.
