3. [14:16] The Speaker made a general announcement regarding the sitting of the Western Cape Provincial Parliament in accordance with Rule 1A of the Standing Rules pertaining to Members in remote attendance by electronic means.
4. [14:19] The Chief Whip of the Majority Party (Ms W F Kaizer-Philander) moved: That, notwithstanding the provisions of Rule 18, the hours of sitting on Thursday, 21 September 2023, shall be: 10:00 to adjournment.

Mr G Bosman moved without notice: That the House sends its condolences to the friends and family of Kyle Smith; notes that he unfortunately died of natural causes in hospital last weekend; notes that Kyle was the double bassist of the Cape Philharmonic Orchestra; notes that Smith was a soloist in last year's Classical Music Concert, presented by the CPO and the Artscape Theatre when he performed the Burlesque for Double Bass and Orchestra by Allan Stephenson; notes that he was a student of CPO principal double bassist Roxane Steffen and was doing his post-graduate performance diploma at UCT,

where he graduated with a Diploma in Music Performance; notes that he was also selected to play as a member of the German Youth Orchestra; notes that the much-loved musician began his musical journey when he was six years old at the New Apostolic Church, where he first played the recorder and then moved on to the violin, without formal lessons; notes that, in 2014, he started playing the double bass at Beau Soleil Music Centre, with Dorothy Holder; notes that, after Grade 12, he was accepted to do a certificate programme at the Stellenbosch University under the tutelage of Steffen in 2017 and 2018; notes that, in 2019, he applied for his Diploma in Music Performance at UCT and graduated in 2022; notes that he had played for many orchestral ensembles, in which he held principal bass positions, including the Cape Philharmonic Youth Orchestra; and may he forever rest in peace.

13. Mr G Bosman moved without notice: That the House sends its condolences to the friends and families of Spencer Mbadu; notes that Spencer was born in 1955 in Kensington and his family was later forcefully removed to Guguletu; notes that, from the age of four he tried his hand at a number of musical instruments (guitar, voice, drums and piano) before he chose the bass as an instrument of choice in 1972; further notes that Spencer Mbadu was a giant of a musician and bass guitar and he was a generous soul, always willing to pass on his knowledge to emerging bassists; notes that he has influenced a generation of bass guitarists who followed in his footsteps; and may he forever rest in peace.

Mr F C Christians moved without notice: That the House expresses condolences and our heartfelt sympathies with the Ackerman family on the passing away of Raymond Ackerman who died at the age of 92; notes that his passing away leaves a massive void in the retail industry (Georgina Crouth in *Daily Maverick* of 7 September 2023); notes that Ackerman was the founder of the retail giant, Pick n Pay; notes that he took the company that he founded in 1967 to a billion rand business; notes that today Pick n Pay has more than 2 000 branches across South Africa and Southern Africa and salutes his entrepreneurial vision and humanitarian spirit; notes that he was a man who inspired many to rise above their circumstances; and our prayers are with his wife, Wendy, daughters, Suzanne and Kathryn, and sons, Jonathan and Gareth, and the extended family.

Ms A P Bans moved without notice: That the House notes and expresses dismay at the recent wave of attacks on law enforcement officers; notes that in the last six weeks there has been an increase in attacks on law enforcement officers, including on members of the South African Police Service (SAPS) in the Western Cape; and strongly condemns these attacks and urges all policing bodies, including the SAPS, to prioritise the collection of illegal firearms as part of their efforts to ensure officers' safety.
