- 2. The Speaker took the Chair and read the prayer.
- 3. [14:16] The Speaker made a general announcement regarding the Rules of the House.

- 7. [15:19] The Chief Whip of the Majority Party moved: That in terms of section 6(3)(b) of the *Remuneration of Public Office Bearers Act*, 1998, (Act 20 of 1998) the upper limits of the salary and allowances of the Premier as proclaimed by the President of the Republic of South Africa by Proclamation No 13, 2017, published in *Government Gazette* 40605 of 9 February 2017, be determined as the salary and allowances of the Premier of the Western Cape with effect from 1 April 2016.

Agreed to.

8. [15:25] Mr B D Kivedo moved without notice: That the House expresses its condolences with Mr Allen Paulse, the Municipal Manager of the Oudtshoorn Municipality, and his family for the tragic loss of their 23-year-old son Dino Paulse who died in a motor vehicle crash over the past weekend. May his soul rest in peace.

Agreed to.

9. Mr K E Magaxa moved without notice: That the House commends and welcomes former President Thabo Mbeki as the newly inaugurated chancellor of UNISA, Africa's biggest university, and notes that one of the greatest intellectuals are now giving direction and shaping the future of a truly African university.

10. Mr N E Hinana moved without notice: That the House commends and congratulates Siphelele Xabendlini, a matriculant from Philippi, for receiving 100% in Physical Science and becoming the top achiever in the Western Cape, and congratulates his school and his parents with such a commendable result.

Ms P Z Lekker moved without notice: That the House, noting with concern the attacks on places of worship like mosques in the province, which started with the smearing of blood at Kalk Bay Mosque and followed by the placing of a pig snout at the entrance of Simon's Town Mosque, unreservedly condemns such heinous acts and calls for religious tolerance.
