2. The Speaker took the Chair and read the prayer.
3. [14:17] The Speaker made a general announcement regarding the sitting of the Western Cape Provincial Parliament in accordance with Rule 1A of the Standing Rules pertaining to Members in remote attendance by electronic means.

The Speaker made an announcement in accordance with the new Standing Rule 151, all Notices of Motion by Members are required to be delivered to the Secretary for placing on the Order Paper. These motions, duly submitted, will be published on the Order Paper.
9. [16:42] Motions without Notice (*in accordance with Standing Rule 150*).
10. Ms D M Baartman moved without notice: That the House congratulates the learners and teachers of the Protea Heights Academy, the Wesbank Secondary School, the Spine Road High School and the Bredasdorp High School who took part in the SITA CSR Robotics Challenge; notes that the competition saw learners from across the country showcase their innovative and ingenious designs, which ranged from a robotic bin that automatically separates recyclable metal to a wearable device to assist blind learners; congratulates especially teacher Mr Donald Cook and Grade 9 learners Zoë Coetzee, Anzia Coetzee, Mande Mari Darby and John William Shepherd of the Bredasdorp High School who designed an automated cart to keep elderly people who have fallen supplied with prescription medication; notes that this design took second place overall in the competition, winning R600 000 in cyber laboratory equipment for their school; and notes that the dedication, hard work and intelligence of the learners from these schools are inspiring and gives one hope for a better future for the Western Cape.
