[09:33] The Chief Whip of the Majority Party (Ms W F Kaizer-Philander) moved: That, in terms of section 3 of the Members of the Western Cape Provincial Parliament Code of Conduct Act, 2002 (Act 3 of 2002), Advocate P Burgers be appointed Registrar of Members' Interests for a period of three years with effect from 1 March 2024.
