MINUTES OF PROCEEDINGS

PARLIAMENT OF THE PROVINCE OF THE WESTERN CAPE

WEDNESDAY, 22 MAY 2019

- 1. Members assembled in the Chamber at 10:30.
- 2. The Serjeant-at-Arms announced the Honourable the Judge President of the High Court, Judge President J M Hlophe who was received by Members standing.
- 3. The Honourable the Judge President took the chair and informed Members that there will be an opportunity for silent for prayer or meditation.
- 4. The following members made and subscribed the oath or solemn affirmation before the Honourable the Judge and took their seats:

It is hereby notified for general information that under and by virtue of the power vested in me by section 110(1), read with sections 128(1) and 111(1) of the Constitution of the Republic of South Africa, 1996, as well as section 19(3), read with sections 38(1) and 20(1) and 20(2) of the Constitution of the Western Cape, 199, I, John Mandlakayise Hlophe, Judge President of the Western Cape High Court, Cape Town, have fixed Wednesday, 22 May 2019, at 10:30, as the date and time, and the Chamber of the Western Cape Provincial Parliament, Cape Town, as the place for the nomination and election of a Premier of the Western Cape and thereafter for the nomination and election of Speaker and Deputy Speaker of the Provincial Parliament.

The Honourable the Judge President announced that in terms of Rule 2 of the Rules for the election of Premier and Speaker, Mr Romeo Adams shall act as Returning Officer, while Ms Nicolle Petersen and Mr Jabulani Nkabinde have been appointed as Assistant Returning Officers. He further announced that the oath or solemn affirmation had already been administered to the Returning Officer and Assistant Returning Officers as required by the Rules.
- 9. The meeting proceeded to the election of a Premier.
- 10. The Honourable the Judge President reminded members that, in terms of the national Constitution and the Western Cape Constitution as well as the Rules, each nomination must be submitted on the prescribed form. He further drew the attention of members specially to section 128(1) of the national Constitution and section 38(1) of the Western Cape Constitution, in terms of which no person may be elected as Premier unless he or she is qualified to take his or her seat as a member of the Provincial Parliament.
- 11. The Honourable the Judge President informed members that in terms of Item 6 in Part A of Schedule 3 to the national Constitution and Item 6 of Schedule 2 of the Western Cape Constitution no debate would be allowed.
- 12. The Honourable the Judge President called for nominations.
- 13. Mr B S Madikizela, seconded by Mr D Maynier, nominated Mr A R Winde for election as Premier.
- 14. Mr L L Mvimbi, seconded by Mr P Marran, nominated Mr C M Dugmore for election as Premier.
- 15. The Returning Officer reported to the Honourable the Judge President that the nomination papers had been properly completed.
- 16. There being more than one candidate nominated, the Honourable the Judge President announced that a secret ballot would be taken in terms of Item 6 of Part A of Schedule 3 of the national Constitution and Item 6 of Schedule 2 of the Western Cape Constitution and suspended proceedings for preparation of ballot papers.

- 25. The Honourable the Judge President informed members that in terms of Item 6 in Part A of Schedule 3 to the national Constitution and Item 6 of Schedule 2 of the Western Cape Constitution no debate would be allowed.
- 26. The Honourable the Judge President called for nominations.
