5. [14:16] The Chief Whip of the Majority Party (Mr G Bosman) moved without notice: That, notwithstanding the provisions of Rule 20(1), precedence be given to the Subject for Discussion.

[14:17] The Chief Whip of the Majority Party (Mr G Bosman) moved without notice: That, owing to the introduction of the Appropriation Bill by the national Minister of Finance on 21 May 2025, the decisions on the principle (3 April 2025) and the finalisation (7 April 2025) of the Western Cape Appropriation Bill, referred back to the House by the Premier for reconsideration in accordance with Rule 168 of the Standing Rules, be rescinded.

Mr G Brinkhuis moved without notice: That the House recognises the great achievements of Ms Gaireyah Fredericks, a local writer from Paarl in the Drakenstein Municipality; further recognises that she is a single mother of four sons who, despite her economic challenges, has struggled to complete her tertiary education and has completed an honours degree in Afrikaans at the University of the Western Cape and a master's in Art and Creative Writing at Rhodes University; notes she has experienced many challenges to complete and to have her book *Een Voet Innie Kabr* (One foot in the grave) published; further notes that, in commemoration of Women's Day in 2024, Al Jama-ah Western Cape hosted the launch of the book *Een Voet Innie Kabr* at the Paarl Museum in Paarl; acknowledges that she has recently received an award from the Eugène Marais Literary Prize for prose for her debut work *Een Voet Innie Kabr*; acknowledges that she was awarded first prize by the Diana Ferrus Literacy Prize for Poems for her poem, "Swaa dra"; notes that she has been nominated for the University of Johannesburg literary prize for *Een Voet Innie Kabr*; and congratulates her on her achievements.

Mr T R C Walters moved without notice: That the House notes with profound sorrow the passing away of Naaïm Davids; notes that his remarkable contributions to the rugby community in both the Boland and the Western Cape have had a significant and lasting impact that will not be forgotten; notes that Naaïm was much more than just a player – he was a true legend in the realm of rugby and a beacon of leadership who inspired countless individuals, both on and off the field; notes his dedicated passion for the sport and his commitment to nurturing talent that made him an invaluable asset to the rugby fraternity; extends our heartfelt condolences to his family during this incredibly challenging time; may his soul rest in peace; and may his loved ones find comfort in the cherished memories they hold dear.

Mr T R C Walters moved without notice: That the House notes with deep sadness the untimely passing away of Cornal Hendricks, former Springbok rugby player and community hero; acknowledges that he was more than just an outstanding athlete; notes that he was a symbol of courage, faith and resilience whose journey inspired many beyond the rugby field; further recognises that his life story stands as a testament to perseverance in the face of adversity, and that his contributions extend beyond sport, touching the lives of countless South Africans; remembers him not only as a remarkable player, but also as a leader and

proud son of the South African soil who brought pride to his people through his dedication and spirit; extends our heartfelt condolences to his mother Rachel, his family and friends, his teammates and the entire rugby fraternity during this time of immense loss; and celebrates the legacy of Cornal Hendricks and honours his memory by continuing to support and uplift the values he embodied: resilience, hope and unity.

Ms W F Kaizer-Philander moved without notice: That the House thanks the Western Cape Department of Cultural Affairs and Sport, in partnership with the Witzenberg Municipality and the Hamlet Sport Forum, for the official opening of a new multi-use sports facility in Prince Alfred Hamlet; acknowledges the importance of this investment in sports infrastructure for smaller towns, where access to quality recreational spaces remains limited; recognises that the facility will create new opportunities for young boys and girls in the community to participate in sport, to develop their talents and to benefit from the social and health advantages associated with structured physical activity; and further thanks all stakeholders involved for their commitment to youth development, community upliftment and equitable access to sports across the Western Cape.

Ms W F Kaizer-Philander moved without notice: That the House thanks the Western Cape Department of Cultural Affairs and Sport (DCAS) for its investment in the upgrading of the Witzenville sports field in Tulbagh (Witzenberg Municipality); acknowledges the installation of new floodlights at the facility, which now allow local sports clubs, the youth and community organisations to utilise the field safely during evening hours; expresses appreciation for the continued commitment of the Western Cape Government to expanding access to quality sports infrastructure, particularly in rural areas where such facilities play a vital role in youth development, community upliftment and social cohesion; and further thanks the Witzenberg Municipality for its role in facilitating the project and in ensuring local residents benefit from well-maintained and accessible recreational spaces.

Ms B M van Minnen moved without notice: That the House congratulates the church choir of the URC Macassar on the gold medal that they won at the 2025 ATKV Suidoosterfees church choir competition; praises their conductor, Roger Rooi-Horne, for his outstanding leadership; acknowledges the choir's meaningful cultural contribution over the past 43 years; wishes them all the best as they prepare to hopefully participate in the 2026 World Choir Games; and calls on the community to support the choir to help to ensure their continued success.

Mr D W Bryant moved without notice: That the House congratulates CapeNature, the Endangered Wildlife Trust and their partners on the remarkable rediscovery of the Blyde River flat gecko (*Afroedura rondavelica*), unseen for over 30 years and found during a challenging helicopter-assisted expedition in the Blyde River canyon; applauds this achievement as a triumph for conservation science, reaffirming the gecko's survival and confirming its distinct features for the re-evaluation of its conservation status; commends all involved for their dedication to protecting South Africa's unique and threatened species; and reaffirms South Africa's responsibility, as a biodiversity hotspot, to safeguard its natural heritage for future generations.

Mr D W Bryant moved without notice: That the House congratulates CapeNature, the Grootvadersbosch Conservancy, Helihack and all volunteer biologists on the extraordinary rediscovery of the Boosmansbos long-tailed forest shrew, last seen 46 years ago; applauds the dedicated efforts of this passionate team whose innovative use of pitfall traps and logistical coordination in a remote wilderness area led to the successful sighting of this critically endangered subspecies; recognises the vital role of collaborative biodiversity conservation and the protection of the Boosmansbos wilderness area as a world heritage site; commends Dr Marienne de Villiers and her team for their persistence in uncovering one of the Western Cape's most elusive mammals and contributing valuable data to conservation science; and celebrates this remarkable find as a symbol of hope for ongoing ecological research and the protection of South Africa's natural heritage.

27. Mr N P Masipa moved without notice: That the House congratulates the Zion Christian Church (ZCC) on the successful hosting of its 2025 Easter pilgrimage in Moria; notes that, founded in 1910, the ZCC has grown to become the largest church in Southern Africa, grounded in the values of peace, healing and unity; notes that the church has long been a pillar of social cohesion, by upholding the rule of law and promoting justice, even during the apartheid era; notes that its annual Easter pilgrimage draws millions of congregants from across Southern Africa and the United Kingdom, reconnecting families and strengthening community bonds; notes that the impact of the church is especially evident in rural and township areas, workplaces, government institutions, businesses and through the provision

of bursaries that uplift communities; and commends Bishop Dr Barnabas Lekganyane and the ZCC leadership for their unwavering commitment to faith, unity and the upliftment of society.

28. Mr N P Masipa moved without notice: That the House congratulates Kaizer Chiefs on their historic 2–1 triumph over Orlando Pirates in the 2025 Nedbank Cup final, held at the Moses Mabhida Stadium in Durban on the weekend of 10 May; notes that this victory marks the club's 14th Nedbank Cup title, making Kaizer Chiefs the most successful team in the competition's history; further acknowledges the visionary leadership of Kaizer Motaung who founded the club on 7 January 1970 after playing for Orlando Pirates, and whose foresight transformed the team into a dominant force in African football; recognises the significant economic impact of this high-profile fixture, with the eThekweni Municipality establishing additional fan zones to accommodate overflow crowds; notes that similar opportunities exist for cities such as Cape Town to benefit from the tourism and business stimulation that derbies provide; commends Kaizer Chiefs for maintaining one of the largest and most loyal fan bases on the continent, consistently drawing strong attendance in the premier soccer league –even during seasons without major trophies; and congratulates Kaizer Motaung, the players, the management and the supporters of Kaizer Chiefs with their 2025 Nedbank Cup victory and their enduring contribution to the growth and success of South African football.

Mr P Johnson moved without notice: That the House congratulates the Prince Albert Municipality and a generous private sponsor on the successful completion of the newly paved entrance at the local traffic department; commends this outstanding example of public–private collaboration, which has enhanced both the functionality and appearance of the facility; notes that the construction was carried out by a contractor appointed by the sponsor, with the municipality ensuring quality control and strict adherence to occupational health and safety standards; and applauds all involved for their commitment to service delivery and community upliftment.

Mr N P Masipa moved without notice: That the House congratulates the Paarl Boys' High School on their historic 25–10 victory over Grey College, marking only their 10th win and contributing to an unprecedented back-to-back defeat for the Bloemfontein rugby powerhouse; notes that this milestone reflects the strength of the Paarl Boys' High School's rugby programme and adds a new chapter to one of South Africa's most iconic school sports rivalries; notes that the Paarl Boys' High School (Boishaaai) is known for its strong traditions rooted in good conduct, scholarship and sportsmanship; notes that these values are deeply ingrained in the school's culture, shaping its environment and the development of its learners; acknowledges the role of these prestigious schools in producing future Springboks and fostering national rugby excellence; recognises the significant economic and cultural boost such interschool derbies bring to the town of Paarl; and commends the Paarl Boys' High School for using sport and education to shape young South Africans into responsible and capable citizens.

Ms D R Stephens moved without notice: That the House notes with great sadness the multiple tragic motor vehicle crashes that have occurred in Cape Town and on the West Coast over the past few days; notes that, among these incidents was a particularly devastating crash in which a Golden Arrow bus driver tragically lost his life while in service to the public; extends our deepest and heartfelt condolences to the families, friends and colleagues of all those who have lost loved ones in these tragic events; notes that our thoughts and prayers are with them during this time of mourning and loss; may the souls of the departed rest in peace; and may their families find strength and comfort in the days ahead.

Mr B Ngqentsu moved without notice: That the House congratulates the Kaizer Chiefs Football Club on their victory over Orlando Pirates FC in the Nedbank Cup final; notes that Kaizer Chiefs is one of the biggest football clubs in the continent that has seen a 10-year trophy drought; and hopes that this great victory marks a significant return to winning big silverware.

35. Ms R Windvogel moved without notice: That the House congratulates the national relay team with their showing in the World Relays Championships in China where they won gold and bronze; and expresses pride in our athletes who have raised our national flag with pride.

Mr B Ngqentsu moved without notice: That the House notes with pride and warmly congratulates the South African under 20 men's national team, Amajita, on their historic qualification for the 2025 U20 Africa Cup of Nations (AFCON) final; notes that their hard-fought 1–0 victory over Nigeria, secured by a brilliant goal from Tylon Smith and an assist from Neo Rapoo, showcased the team's determination, discipline and growing maturity throughout the tournament; notes that special recognition is given to standout players, such as Siviwe Nkwali from Khayelitsha in the Western Cape, whose exceptional performances – including multiple Man of the Match awards – have been instrumental to the team's success; commends coach Raymond Mdaka and his technical team for their leadership in guiding Amajita to their first final in 28 years, a remarkable achievement that has reignited pride in South African football; notes the team's resilience, after an early setback against Egypt, demonstrates their character and unity; acknowledges the South African Football Association (SAFA) and its president, Dr Danny Jordaan, for their commitment to

developing young talent; and, as the nation rallies behind Amajita, wishes them strength and victory in the final in the confidence that they will continue to make South Africa proud.

Ms R Windvogel moved without notice: That the House notes with pride and heartily congratulates Mr Thela, the talented Cape Town-based DJ and artist, with his remarkable achievement in winning the Best Gqom-Kwaito Award at the 2025 Metro FM Music Awards for his hit song “Ekhaya”; notes that this prestigious accolade, presented on 3 May 2025 at the Mbombela Stadium, is a testament to his exceptional skill, dedication and contribution to the Gqom-Kwaito genre; notes that Mr Thela’s victory not only celebrates his individual artistry but also elevates the genre, reinforcing its cultural impact and growing influence in South Africa’s music scene; commends the Metro FM Music Awards for recognising and honouring outstanding local talent; applauds Mr Thela’s well-deserved triumph as his success serves as an inspiration to aspiring musicians and is a reminder of the vibrant creativity in our nation; and wishes him continued growth, innovation and many more milestones in his flourishing career.
