1. The House met at 14:15.
2. The Speaker took the Chair and read the prayer.
3. [14:16] The Speaker made a general announcement regarding the sitting of the Western Cape Provincial Parliament in accordance with Rule 1A of the Standing Rules pertaining to Members in remote attendance by electronic means.
4. [14:18] The Chief Whip of the Majority Party (Mr G Bosman) moved: That, notwithstanding the provisions of Rule 20(1), precedence be given to the Subject for Discussion.  
Agreed to.
5. [14:19] The House discussed the following subject in the name of Mr N P Masipa:  
The impact of VAT increases on Provincial expenditure and the cost of living.

9. [17:15] Mr G Bosman moved: That the House notes that the Hon Rachel Windvogel, during the sitting of the House on 3 April 2025, made unfounded and inaccurate claims against Minister Ivan Meyer alleging that his visit to Taiwan constituted a betrayal of the country and posed a threat to trade relations with China; notes that the Hon Minister Meyer travelled to Taiwan in his personal capacity and did not engage in any formal discussions or represent the Western Cape Government during his private visit nor did he act in his capacity as a provincial leader; further notes the right of individuals, including public representatives, to travel freely without political interference; notes that the assertion in the House by the Hon Windvogel is a contravention of Rule 59; and resolves that the Hon Windvogel unreservedly apologises for deliberately misleading the House and withdraws her comments which negatively reflected on the integrity and dignity of a Member of the House.

Declarations made on behalf of the ANC, EFF, NCC, FF Plus, Al Jama-ah, ACDP and DA.

Question put: That the Motion be adopted.

10. [17:34] Ms R Windvogel, having disregarded the authority of the Chair, was ordered to leave the Chamber for the remainder of the day's sitting.

Whereupon the Members of the ANC withdrew from the Chamber.

11. [17:36] Motions with Notice (*in accordance with Standing Rule 151*).

The Speaker made an announcement in accordance with the Standing Rule 151, all Notices of Motion by Members are required to be delivered to the Secretary for placing on the Order Paper. These motions, duly submitted, will be published on the Order Paper.

12. [17:37] Motions without Notice (*in accordance with Standing Rule 150*).

13. Ms D Stephens moved without notice: That the House notes and congratulates three extraordinary BMX riders who completed an inspiring journey from Burgersfort in Limpopo to Cape Town, arriving on Monday 14 April 2025 in our city; further notes that their journey was not only a physical and mental feat of endurance, but a powerful symbol of hope and determination; notes that, through their efforts, they successfully raised funds and created awareness for their local BMX club – a vital initiative that engages young people in sport, discipline and community; acknowledges that their commitment to a positive path offers a real alternative to the cycle of crime, gangsterism and drug abuse that too often plagues our communities; notes that these young athletes are more than just riders, they are role models, mentors and ambassadors for change; congratulates these BMX riders on their achievement and commends them for their contribution to youth development, crime prevention and social upliftment; and notes that their message is clear: with the right support and opportunities, our youth can rise above their circumstances and achieve greatness.

14. Mr D W Jacobs moved without notice: That the House with immense admiration and heartfelt gratitude extends its congratulations to LET'S CONNECT, an NGO in Manenberg for the exemplary work they have accomplished in service to the community and society; notes that its unwavering commitment to making a difference, its boundless passion for change and its relentless pursuit of excellence have set an inspiring example for organisations everywhere; notes that, from the very beginning, LET'S CONNECT has demonstrated a steadfastness to resolve and address the most pressing issues faced by our society; notes that, whether tackling inequality, promoting education, improving healthcare or championing environmental conservation, its initiatives have consistently exemplified the values of compassion, innovation and perseverance; notes that it has not only transformed the lives of countless individuals in Manenberg, but also on the Cape Flats at large, and has fostered a culture of hope and optimism that resonates far beyond its immediate sphere of influence; and salutes the NGO.

15. Ms B M van Minnen moved without notice: That the House recognises the valuable and enabling role that e-centres play throughout the province by providing free internet and digital services – particularly in rural and underserved communities; further acknowledges

that the tabled budget has allocated funding for two additional e-centres in the upcoming financial year, which is a testament to this government's leadership in expanding and improving services where they are most needed; commends the Department of the Premier for its ongoing initiative and leadership through innovation; and notes that these e-centres are critical to the strategy for job creation, education and fostering active citizenry.

Agreed to.

16. Ms B M van Minnen moved without notice: That the House notes that, on Tuesday 15 April 2025, 200 residents of the City of Cape Town were affected and displaced by a fire in the Silahliwe Nkanini Informal Settlement in Lwandle, also known as the David Kanti Informal Settlement; thanks and congratulates the Cape Town Fire Department for their timeous work in fighting the fire, as well as the ward and proportional representation (PR) councillors for their work in trying to assist the residents and calling for donations to assist people at this time; commends the City of Cape Town for its excellent Fire Department and the firefighting efforts to prevent, contain and extinguish fires, such as this one, that stopped it spreading further, particularly at a time of the year that sees winds accelerate and intensify these situations; notes that, fortunately, no lives were lost but that does not take away from the pain and trauma of people losing their homes and possessions; and our thoughts are with them at this time.

17. Ms B M van Minnen moved without notice: That the House recognises the City of Cape Town's measures to prevent fires in informal settlements, including educating people about the importance of fire breaks between dwellings, promoting community awareness and ensuring access to fire suppression equipment; and notes that a very important fire prevention measure is the prevention of cable theft and illegal electricity connection, and residents are urged to be aware of the risks posed by this and to work together with the City to prevent this kind of situation from reoccurring.

Agreed to.

18. Mr D W Bryant moved without notice: That the House congratulates and commends all firefighters in the Western Cape who have bravely battled a total of 11 149 wildfires during the peak season; recognises the courage and dedication of these men and women who serve on the front lines to protect our biodiversity and all who depend on it; and further extends a special vote of thanks to the Disaster Risk Management teams of the City of Cape Town and the Cape Winelands District Municipality for their outstanding leadership and tireless efforts in managing the majority of these incidents, these men and women are not only brave, but embody the values this government holds in service to its people.

19. Mr N P Masipa moved without notice: That the House notes the successful collaboration between the Western Cape Department of Economic Development and Tourism, Transnet Port terminals and fruit exporting industry, including Agbiz, Hortgro, SATI, FPEF and the KAL Group, in funding and installing two 500 kVA generators at the Cape Town Port container terminal; acknowledges that this initiative will enhance the terminal's capacity during peak export seasons, ensuring efficient handling of perishable goods and reducing delays caused by operational disruptions; recognises the importance of public-private partnerships in driving economic growth, improving logistics efficiency and supporting

South Africa's export-oriented industries; commends all stakeholders involved for answering the Premier's call to step up their proactive and solutions-driven approach, aligns with the Western Cape's Growth for Jobs Strategy and strengthens the province's role as a key contributor to the national economy; and encourages continued collaboration between the government, Transnet and industry leaders to modernise and optimise the Port of Cape Town further for the benefit of all South Africans.

20. Ms N D Nlondlo moved without notice: That the House notes and congratulates Dr Mana Mildred Ramakaba-Lesiea on being awarded the prestigious Isithwalandwe/Seaparankwe by the National Executive Committee of the African National Congress in recognition of her lifelong dedication to the liberation struggle and democracy; further notes that Ms Lesiea, born in 1933 in Langa, Cape Town, joined the ANC in 1954 and played a critical role in various resistance campaigns, including the fight against Bantu Education, pass laws and forced removals in the Western Cape; further notes and appreciates that, as a committed activist, she was instrumental in the Treason Trial support campaigns, the Anti-Pass Campaign and the revival of women's structures and that her unwavering resolve saw her detained multiple times, banned and continuously involved in underground ANC activities, where she mobilised communities and the youth in defiance of apartheid oppression; recognises and commends Dr Ramakaba-Lesiea's immense contributions, including her leadership in the United Democratic Front, the South African Youth Congress and the ANC Women's League, as well as her service as a ward councillor and Member of Parliament post-1994; appreciates that her bravery, resilience and dedication to the freedom of South Africa continue to inspire generations; and congratulates and salutes her for this well-deserved honour and acknowledges her lifelong service to the struggle and the empowerment of our people.

21. Ms A P Bans moved without notice: That the House notes and extends its deepest condolences on the passing away of Deputy National Director of Public Prosecutions, Advocate Rodney de Kock; further notes that, as a pioneer in the legal fraternity, he was the first black South African to be appointed as an Attorney General and played a crucial role in transforming South Africa's legal system; further notes that his dedication to justice was evident throughout his career, from co-founding the National Association of Democratic Lawyers in 1987, alongside stalwarts like Dullah Omar and Pius Langa, to serving as Attorney General and later Director of Public Prosecutions in the Western Cape; acknowledges that his fearless commitment to upholding the rule of law and ensuring access to justice for all South Africans remains an enduring legacy; further notes and appreciates that, following his appointment as Deputy National Director of Public Prosecutions in 2020 by President Cyril Ramaphosa, Advocate De Kock led critical efforts, including South Africa's exit strategy from the Financial Action Task Force grey-listing and that his integrity, humility and dedication earned him the respect of the legal profession and the broader society; sends heartfelt condolences to his family, friends' colleagues, and the National Prosecuting Authority; and notes that his untimely passing away after a brief battle with brain cancer is a profound loss to the nation.

22. Mr B Ngqentsu moved without notice: That the House notes and congratulates BMX riders Gauta Mahlakoane, Karabo Mokoo and Maxwell Ndou on their incredible cycling journey from Limpopo to Cape Town, an inspiring effort to raise funds and awareness for their community bicycle club, which empowers the youth to stay away from crime and drugs; and further salutes their courage, determination and commitment to uplifting their community through positive action.

23. Mr M K Sayed moved without notice: That the House expresses its deepest condolences on the passing away of our beloved comrade, Cde Mirriam Ntombizanele Sifile (Cde Charty), a dedicated ANC veteran, former ward councillor of ward 1 (Nduli), former Speaker of the Witzenberg Municipality, and former member of both the ANC Boland Region and the Western Cape provincial executive committees; further notes and honours her lifelong commitment to the struggle for justice, her exemplary leadership in local government and her tireless work as a founding member of the Ceres Advice Office, where she championed community development and access to essential services; further notes that Cde Sifile's legacy of service, equality and progress will continue to inspire us as we strive to build a better society; and extends heartfelt sympathy to her family, friends and comrades during this difficult time.

Agreed to.

24. Mr G Brinkhuis moved without notice: That the House notes a tragedy which occurred in the early hours of Sunday 6 April 2025 when a fire spread through an informal settlement in New Rest, Wellington; further notes that one woman lost her life in the fire which destroyed 200 informal houses leaving more than 1 200 people homeless and destitute; acknowledges the much needed and immediate response from NGOs such as Gift of the Givers, the Paarl-based Rural Islamic Welfare Association (RIWA) and the Women on Farms Project; notes that since the devastating fire, RIWA has been providing cooked meals to the destitute families daily; further notes that RIWA has embarked on a national appeal drive for clothing, blankets, school uniforms and other basic necessities; recognises that RIWA has displayed great teamwork by coordinating the distribution of food and clothing with fellow NGOs such as the Women on Farms Project; and recognises the need for more rapid response to assist families in such disasters.

Agreed to.

25. Mr D G Jacobs moved without notice: That the House rises to dip its flag to those youngsters who have lost their lives in the ongoing gang violence in the Western Cape, in particular those in the coloured communities; notes that in 2024, the NCC stood in this House to sponsor a debate to address this continued bloodshed due to gang violence; further notes that this has not stopped, and week after week, mothers, fathers, brothers and sisters find themselves next to open graves saying their final goodbyes to yet another youngster; notes that we feel the pain of those families staying in the communities and that their tears are our tears and their pain is our pain; and notes that we say rest well to the young ones, that their blood will not be in vain and that we shall overcome.
