[12:34] The Deputy Speaker announced that the vacancy in the representation of the Democratic Alliance in the Western Cape Provincial Parliament has been filled by the nomination of Mr I Sileku with effect from 24 November 2022. Hon Member Sileku had taken the oath in the Speaker's office on 24 November 2022.

12. [12:36] Response to statements by Members by Ms M M Wenger, Minister of Finance and Economic Opportunities and Mr R I Allen, Minister of Police Oversight and Community Safety.

13. [13:00] Motions with Notice (*in accordance with Standing Rule 151*).

The Speaker made an announcement in accordance with the new Standing Rule 151, all Notices of Motion by Members are required to be delivered to the Secretary for placing on the Order Paper. These motions, duly submitted, will be published on the Order Paper.

15. Ms C Murray moved without notice: That the House congratulates Pick n Pay for adopting bitcoin payments at its retail stores; notes that this follows a recent trial that occurred at 29 of its stores in the Western Cape; notes that, not only is this an innovative step towards ensuring financial inclusion, but it is also an important development in achieving a cashless society; and we look forward to them pioneering in this regard.

16. Mr A P van der Westhuizen moved without notice: That the House commends the efforts by the agricultural sector and related role players in the Western Cape for maintaining peace and calm on farms across the province despite the worrying attempts by certain individuals to incite discord on Wednesday 2 November 2022 in commemoration of the tenth anniversary of the farm worker strikes of November 2012.

17. Mr D America moved without notice: That the House congratulates firefighters from the City of Cape Town, the Cape Winelands District Municipality and CapeNature for extinguishing two potentially disastrous veld fires in the Du Toitskloof Pass and on Table Mountain over the last month; notes that their rapid and efficient responses demonstrate that the Western Cape is prepared for the summer fire season; and they should be commended.

18. Ms W F Kaizer-Philander moved without notice: That the House congratulates the Groote Schuur Hospital for prioritising the mental health of its staff; notes that, on 1 November Minister Mbombo officially opened their Wellness Centre, which houses several facilities, such as a gym, a yoga class and a meditation room; notes that all-in-all this centre will be accessible to more than 4 000 staff members; and notes that, by taking care of our healthcare workers, we take care of our patients.

19. Mr G Bosman moved without notice: That the House sends its condolences to the family of the retired Cape Town Netball Federation President Marsha Wagenaar, who passed away after a short illness on 29 October; notes that, with dedication and professionalism, Wagenaar worked to promote netball in the Western Cape for many years and inspired countless young athletes to excel in their disciplines; and acknowledges her loss and will hold her memory in mind as Cape Town hosts netball's premier event next year.

20. Mr G Bosman moved without notice: That the House congratulates Mr Ernest Mnyaka, a petrol attendant and poet from Malmesbury, who recently published his first volume of Xhosa poetry, *Waphela Umda kaLoval* (*The end of the road for a thug*); notes that Mnyaka's poetry reflects on his experiences in prison and his previous life of crime, and acts as a commitment to build a new life; notes that Mnyaka acts as a true example of the restorative power of the written word; and wishes him great success in his future endeavours.

Mr G Bosman moved without notice: That the House congratulates the winners of the recent Western Cape Cultural Affairs Awards and Western Cape Sports Awards, which were held in October this year; notes that the winners of these awards are living examples of the incredible dedication and talent present in the Western Cape's cultural and sporting sectors; notes the sectors' heartening progress in recovering from COVID-19; and commends all the winners.

Ms P Z Lekker moved without notice: That the House notes with deep sadness the untimely passing away of Comrades Mustapha Isaacs from ward 116 in Mitchells Plain; notes that the Comrade passed away peacefully in his sleep; notes that he will be remembered for his selfless service and dedication to the ANC and to the community; may his soul rest in peace and may his friends find comfort.

Mr M Kama moved without notice: That the House notes with deep sadness the passing away of legendary netball veteran, Marsha Wagenaar, who died recently after suffering a severe stroke; and notes that “Tannie” Marsha was a retired Cape Town Netball Federation President and a former Acting Principal at the Cavalleria Primary School in Kraaifontein.

24. Mr C M Dugmore moved without notice: That the House congratulates Brazil’s newly elected President, Luiz Inácio Lula da Silva; notes that Da Silva won Brazil’s election with 50,9% of the vote; and South Africa is looking forward to working with the government of Brazil under his leadership.

25. Mr M Kama moved without notice: That the House congratulates King Misuzulu kaZwelithini on his coronation; and notes that he was officially made King of the AmaZulu after a long battle for the

26. Mr K Brinkhuis moved without notice: That the House notes that the University of Stellenbosch will award the degree Doctor of Philosophy (DPhil) *honoris causa* to Ms Zubeida Jaffer; further notes that this award-winning journalist is from Wynberg; recognises that she is one of five distinguished individuals to receive this highest accolade from the Stellenbosch University at the 2022 graduation ceremony; further recognises that she started her career at the *Cape Times* daily newspaper in 1980; acknowledges her role as a black journalist often arrested and tortured for writing about the brutality of the apartheid system; further acknowledges that, despite the security risks, she assisted in developing local-community newspapers, such as *Grassroots*, during the anti-apartheid struggle; recognises that she was also the founding editor of Independent Newspapers’ Parliamentary Bureau, serving 14 newspapers across South Africa; further recognises that she was the first woman in Africa to have won the coveted Foreign Journalist Award from the National Association of Black Journalists in the United States; acknowledges that her work has earned her several local and international awards, including the Achiever Award from a leading Cape Town community newspaper, *Muslim Views*; further acknowledges that she is also an author of several books and her own memoirs; and congratulates Ms Zubeida Jaffer.

27. Ms N Makamba-Botya moved without notice: That the House calls on the Western Cape Department of Social Development to extend its Sanitary Dignity Programme beyond only school learners; notes that the Department can achieve this through sponsoring and working with non-government organisations that are already involved in such projects; further notes that the Department’s current programme for learners should be applauded but it can be expanded to reach even more needy women, especially in townships, informal settlements and rural areas.

28. Mr G Bosman moved without notice: That the House notes the exceptional achievements of two of the Western Cape’s finest actors who have exemplified the highest standards of our province’s cultural sector and demonstrated their talent on the world stage; notes that 11-year-old Caleb Payne was recently honoured with a Youth Artist Academy Award in the category of Feature Film Leading Youth Artist for his role in the 2021 film *Good Life*; notes that this is the first time any South African has won this award and that it places Caleb in the

auspicious company of previous winners, such as Julia Roberts, Leonardo DiCaprio and Zendaya; notes that, at the same time, renowned actress Kim Engelbrecht has been nominated for an international Emmy award for her work on the locally produced series *Reyka*, for which she has already won a SAFTA award; commends these artists from our province on their achievements and their representation of our country on the world stage; and wishes them well in their future endeavours.

29. Mr A P van der Westhuizen moved without notice: That the House welcomes the Vredendal Regional Court's fining of three Saudi nationals R2 million for illegally harvesting a large quantity of flora without documentation; notes that the trio, who were also found guilty of money laundering and were ordered to leave South Africa, admitted in court that they had travelled to the country with the sole purpose of acquiring the flora and exporting it to their home country; recognises that this recent incident highlights the fact that plant poaching is not simply a petty crime, but forms part of an intricate international web of syndicates dedicated to the theft of our natural heritage; and requests that Minister Barbara Creecy and the national Department of the Environment, Forestry and Fisheries provide support in the form of funding and engage with her counterparts in law enforcement to provide urgent support to stamp out this criminality.

30. Mr R D Mackenzie moved without notice: That the House notes the passing away of Graham Power who was the founder and chairperson of the Power Group; notes that, throughout his life, Mr Power made great strides as a formidable business leader in the fields of civil engineering and construction; notes that he also won many awards and had received various honours from the City of Cape Town for his efforts to help transform our society; and his family and loved ones will remain in our thoughts.

31. Mr R D Mackenzie moved without notice: That the House commends the Western Cape Government and City of Cape Town on the jointly developed Human Settlements Project in Mitchells Plain; and recognises the Western Cape Government's ongoing commitment to accelerate Mitchells Plain's housing delivery while fostering social inclusion by creating integrated and sustainable human settlements in an open-opportunity society.

32. Ms D M Baartman moved without notice: That the House notes that the Beaufort West district library burned down last week, which contained the historical archives of many families in the municipality; notes that many children in the area relied on these books not only for their academic ambitions or to remember their history, but to escape into different worlds and adventures, to meet new people and to explore places we only ever see on the big cinematic screen; notes that it is still unclear what the cause of the fire was and calls on the local municipality and relevant law enforcement agencies to investigate this matter speedily; and expresses deepest sympathy with the people of Beaufort West and, despite this set-back, we must rebuild Beaufort West.

33. Ms D M Baartman moved without notice: That the House commends the Western Cape Minister of Health for opening the new Bergsig Mental Health Ward at the Nelspoort Hospital on Monday 7 November; notes that Nelspoort is located approximately 50 km north-east of Beaufort West; notes that the Nelspoort Hospital is classified as an intermediate care facility and that it has both TB and psychiatric beds; notes that the total project cost was estimated at R18,6 million, which allowed for the renovation of the existing wards, Bergsig, Omega and Lusthof, and for improving the environment of care for current mental healthcare operational requirements; notes that the total area renovated is about 3 740 square metres; notes that the Bergsig ward has been completed and the estimated date of completion for the Omega and Lusthof wards is January 2023; and thanks the Department of Health for investing in infrastructure for the people in our rural constituencies and for caring deeply about Nelspoort.

Ms L M Maseko moved without notice: That the House welcomes the signing of a Memorandum of Intention between the Western Cape Provincial Parliament and the Bavaria State Parliament; notes that this document will allow greater exchange about parliamentary best practices so that both institutions can enhance their roles as legislators and while executing oversight work; notes that, by building partnerships with different stakeholders, our efforts are strengthened to further whole-of-society approaches going forward.
