The Leader of the Opposition – Mr K E Magaxa: That the House has no confidence in the Premier.

Debate concluded.

Mr M G E Wiley moved as an amendment to the draft resolution:

That all the words after "that" be omitted and be substituted by:

The House has full confidence in the Premier, noting the following achievements of the provincial administration under her leadership as Premier since 2009;

- (1) The continued improvements in governance and financial management, as evidenced by the dramatic increase in clean audits by all departments and entities, as assessed by the Auditor-General, the presidential monitoring directorate and the CSIR and which places this province head and shoulders above the other provinces as well as the national departments.
- (2) The Province has the lowest unemployment and highest job-creation statistics and best economic growth and investment rates.
- (3) The Province has the best education results, most importantly the highest university exemption pass rate.
- (4) Every municipality in the Western Cape has significantly improved audit reports to the extent that virtually every one now enjoys a clean bill of health and consequently improved service delivery, the only exceptions being some ANC-led municipalities.

(5) The Democratic Alliance continues to increase its political market share at the expense of the ANC, routinely winning municipal wards.
