2. The Speaker took the Chair and read the prayer.
3. [14:16] The Speaker made a general announcement regarding the sitting of the Western Cape Provincial Parliament in accordance with Rule 1A of the Standing Rules pertaining to Members in remote attendance by electronic means.
4. [14:19] The Chief Whip moved without notice: That, notwithstanding the provisions of Rule 20(1), precedence be given to the Subject for Discussion.

11. [17:05] Motions without Notice (*in accordance with Standing Rule 150*).

12. Mr G Bosman moved without notice: That the House congratulates Chris Ncekana, a dancer from Gugulethu, for joining the Moulin Rouge in Paris, France; notes that Ncekana's journey began in Athlone when he was just six years old, where he was trained by some of the very best, such as Phyllis Spira, Hope Nongqongqo Pamela, Adele Blank, and Phillip Boyd; further notes that Chris has been described as someone who has from the start looked like a very promising and talented dancer and his teachers always knew he would be very successful; notes that he has made all of us very proud; and wishes him nothing but even more success.

Agreed to.

13. Ms L M Maseko moved without notice: That the House congratulates Mr Carl Pophaim after being appointed as the new Member of the Mayoral Committee (MMC) for Human Settlements in the City of Cape Town; notes that Mr Pophaim is a young and talented Councillor who has distinguished himself in the Human Settlements portfolio and has served on the City's Portfolio Committee for Human Settlements for nearly five years and the Planning Appeals Advisory Panel, among others; and further notes that his youthful vigour and unwavering dedication are promising assets that will undoubtedly drive progress and innovation in his new position.

Agreed to.

14. Mr K Brinkhuis moved without notice: That the House notes that 27 September 2023 marks the 54th commemoration of the martyrdom of Imam Abdullah Haron; further notes that Imam Haron was detained by the Security Branch of the police under the Terrorism Act on 28 May 1969, during the month of Prophet Muhammed's birthday; recalls that the Imam who was 45-years-old when he died after he was brutally tortured to death while in detention at the Caledon Square and Maitland police stations respectively; further recalls that he was held incommunicado for 123 days and denied the right to see his wife, Ms Galiema Haron, and their three children; acknowledges that Imam Haron was an anti-apartheid activist and a robust and resilient community leader who fought for the oppressed people; further acknowledges the re-opened inquest hearings findings that the Imam was brutally tortured to death by members of the Security Branch; notes that the judgment into the killing of the Imam will be handed down on 9 October 2023; and calls for support for justice to the Haron family and several other families whose loved ones were killed by Security Branch members of the then apartheid government.

Agreed to.

15. Mr M Kama moved without notice: That the House congratulates the South African Council on Sport (SACOS) on the 50th anniversary of its founding and recognises the work that this council did during the dark days of apartheid, especially through their slogan: no normal sport in an abnormal society; and wishes the Frank van der Horst exhibition, which is linked to the SACOS celebrations, well and recognises the contribution made by personalities, such as Professor van der Horst, in pursuing non-racial sport in South Africa, especially as we look forward to the Springboks, probably the most representative South African squad in any world cup thus far, bringing the Webb Ellis Cup home again.

16. Mr M K Sayed moved without notice: That the House notes and congratulates the Mdzananda Animal Clinic in Khayelitsha for its outstanding initiative in introducing a new school education programme; notes that this programme is specifically designed to equip Grade 4 learners, aged 11 to 12, with valuable knowledge about animal care; and notes that their commitment to the community and the welfare of animals is truly inspirational.

Agreed to.

17. Mr M K Sayed moved without notice: That the House notes and expresses utmost admiration and extends warmest congratulations to a Grade 9 and 12 Mathematics teacher, Lizette Schroeder, from the Protea Heights Academy in Brackenfell; notes that Lizette has been awarded the prestigious title of “Best Teacher in the Western Cape”; notes that this remarkable achievement is a testament to her dedication, passion and unwavering commitment to the field of education; and further calls on the WCED to provide the necessary support to teachers in schools in poor working-class communities to be able to achieve the same level in pursuit of quality education for all.

18. Ms N D Nkondlo moved without notice: That the House notes and extends heartfelt congratulations to two remarkable young entrepreneurs, Siyabulela Ndabambi and Mfundzo Nyiki, both 27-year-old, hailing from Harare, Cape Town, who have achieved a significant milestone by successfully launching their business venture of Iqula Colognes in Khayelitsha; and notes that this achievement is not just a personal accomplishment, but a representation of the potential within our community.

19. Mr M Kama moved without notice: That the House notes and congratulates the Cape Town-born sports presenter, Julia Stuart, for her outstanding achievement in joining the Premier League Production in London; and notes that Julia will host the preview show “Team Talks” at 18:00 (British time) on Fridays, which will be aired on SuperSport Premier League channel 203 at 19:00 in SA.

Agreed to.

20. Mr G Bosman moved without notice: That the House takes note of the Cultural Affairs Awards that took place on 26 September 2023; notes that the awards honoured individuals and organisations that have made exceptional contributions in the areas of arts, culture, heritage, language, libraries, archives, museums, heritage and geographical names; and further notes that the winners shine as a beacon of hope for communities throughout the province because they have done tremendous work in their respective fields.

Agreed to.

21. Mr F C Christians moved without notice: That the House notes that, between October 2022 and March 2023, 283 criminal cases were dropped from court roll due to “police mistakes”; notes that included in this total are 77 cases of GBV reported by women; notes that these are administrative errors that could have been avoided; notes that these errors are a glaring indictment of the SAPS in the Western Cape; notes that it points out the level of inefficiency evident at police stations; notes that the SAPS stands accused of having failed the women in the GBV cases; notes that 68 case files out of 283 were not presented in court; notes that it is shocking that 104 cases out of 283 were dropped because of incomplete investigations; further notes that the Knysna, Vredendal and George police stations were top of the list where important documents were missing; notes that the Lutzville, Kraaifontein and Kuils River police stations were responsible for incomplete investigations that hampered the work of the courts; and calls for justice to prevail for the women mentioned in the GBV cases, that these cases be re-examined and re-admitted to the court roll, and that the perpetrators in the “police mistakes” be identified and suffer the disgrace of dismissal from the SAPS.

22. Mr M I Sileku moved without notice: That the House takes note of the recent flooding that devastated our city and rural towns across the province; notes that various roads have been washed away, up to 12 000 people have been affected, and an unknown number of individuals have unfortunately passed away; notes that proactive steps were taken by the Western Cape Government and the Provincial Disaster Management Centre was activated on Sunday after the South African Weather Service confirmed that the storm would be more severe than was initially anticipated; further notes that the disaster response of the Western Cape Government to the severe weather has since shifted from saving lives to recovery and humanitarian aid coordination; further notes that mop-up operations have since started and various roads have since been reopened; notes that, while rebuilding commences, the Western Cape Government is also considering asking for the deployment of SANDF engineers to assist with rebuilding critical infrastructure in the Western Cape; and notes that this House is dedicated to the diverse group of individuals and organisations that have contributed to relief and emergency services across our province, this includes not only the dedicated efforts of first responders, but also the generosity of ordinary citizens who prepared meals, offered financial support, donated groceries and provided invaluable assistance.

23. Mr A P van der Westhuizen moved without notice: That the House notes with approval the Western Cape Department of Agriculture's launch of a Provincial Veterinary Week; notes that animal health is an important part of a successful agriculture sector, especially as it relates to the exportation of meat products; and further notes that the support offered by the Department in this regard is to the benefit of our farmers and enables them to grow their agri-businesses and to create much-needed employment in the Western Cape.

24. Mr C M Dugmore moved without notice: That the House extends its deepest regret at the passing away of Lieutenant Commander Gillian Elizabeth Hector (executive officer), Master Warrant Officer William Masela Mathipa (coxswain) and Warrant Officer Class One Mmokwapa Lucas Mojela (coxswain in training) while performing a naval exercise off the Simonstown coast last week; and conveys its deepest condolences to the family and friends of these navy marines while calling upon the House to observe a moment of silence at the beginning of the next sitting, as well as requesting that the Premier declares a provincial day of mourning for these men and woman who served our country based in our city and province.

25. Mr M K Sayed moved without notice: That the House congratulates the Herzlia High School on winning the under 14 Cape Metro's Kay Motsepe School Championship but notes with deep concern that these champions could not represent the region at the Western Cape provincial finals in Saldanha Bay this past weekend because the match was scheduled to be played on the Jewish Sabbath; and, while acknowledging the great work done to develop sport by some non-governmental organisations, calls on all sporting bodies or organisations to respect the holy days of all believers.

26. Mr M K Sayed moved without notice: That the House urgently calls on the provincial government to address the critical safety concerns plaguing the Hillside Primary School in Mitchells Plain; notes that the perilous situation, marked by drug trafficking on the nearby hill and recurring break-ins, demands immediate attention and collective efforts; seeks substantial investments in infrastructure and personnel to fortify security measures in order to ensure the safety and well-being of learners and staff; moreover implores the

Education Department's Safe Schools Unit to amplify its responsiveness and support in addressing these distressing issues by forging a secure environment that is conducive to learning and growth; and, as time is of the essence, beseeches prompt action to protect our educational sanctum.

Agreed to.

27. Ms N D Nkondlo moved without notice: That the House welcomes the AGOA Forum to be hosted in November 2023 in Johannesburg, Gauteng, to discuss the future of this agreement and its possible extension to 2025; notes that this strategic move signifies a promising step in the right direction that is opening doors to amplified trade opportunities and economic growth; notes that, in reimagining AGOA during this third review, the alignment of AGOA to Africa's industrialisation programme creates opportunities for US companies and investors to access mutually reinforcing economic benefits in the manufacturing sector eg car components, green technology and agri-processing given the much-developed agri-sector in the country; notes that this "African common position on AGOA" lays a strong basis for the extension of AGOA as African countries have already been unanimous on advocating for the extension of AGOA and SA was nominated to put forward the African case to be discussed in the AGOA Forum meeting in November 2023; and notes that these are positive developments that we must all support and continue to embrace in anticipation of an extension of and an enhanced AGOA in 2025.

28. Mr M Kama moved without notice: That the House notes the anniversary yesterday of the death in detention of Imam Abdullah Haron, a revered anti-apartheid activist and founder of the Claremont Muslim Youth Association; solemnly remembers his unwavering commitment to justice and equality; notes that he was held captive for 123 agonising days while enduring unspeakable torture by the apartheid security branch; notes that his sacrifice remains etched in our collective memory; with the anticipated judgment on 9 October 2023, a just resolution is anticipated that provides the much-needed closure for his grieving family and a testament to the pursuit of truth and justice; and may his legacy inspire generations to stand against oppression and prejudice.
