11. Mr T A Simmers moved without notice: That the House notes and congratulates the Griqua National Conference of South Africa (GNC) who, on 2 July 2017, will be observing their 113th year since establishment.

Agreed to.

12. Mr B D Kivedo moved without notice: That the House congratulates Cape Town-born, South African trail runner Ryan Sandes on coming first in the Western States 100 mile race, considered as one of the most challenging traces in the world, that took place in California last weekend, in a time of 16 hours and 19 minutes.

13. Ms T M Dijana moved without notice: That the House commends the police for their brilliant work in fighting crime in the province, after the arrest of three men in the biggest drug haul in which 253 boxes of cocaine worth R500 million were confiscated in the Overberg village of Villiersdorp.

16. Mr F C Christians moved without notice: That the House congratulates soccer player Chad Block (14) from Hanover Park on being selected by the South African Schools' Football Association (SASFA) to participate in the 2017 Phuket Cup International in Thailand in December.

Mr B D Kivedo moved without notice: That the House, on evidence by the Standing Committee on Education's oversight visit to the school on Tuesday 27 June, congratulates the principal and the whole school community of the Silverstream Primary School for good management to excel beyond expectations, despite being located in an area that is rife with social pathologies and ills.

22. Mr M Mnqasela moved without notice: That the House welcomes the amount of R22,2 million that will be spent over the next four years on building the new metropolitan south-east cemetery in Mfuleni and extending existing cemeteries.

Mr M Mnqasela moved without notice: That the House notes, acknowledges and celebrates the water-saving efforts of the 46-year-old Khayelitsha resident Mthuthuzeli Zebukwane who, with his household, has since 2013 used grey water from their baths and dish washing to flush their toilet manually; and recognises this man and his family's actions as an example of active citizenry and an example to all of us, and one that we ought to follow.
