- 3. [14:16] The Speaker requested Members to rise and observe a moment of silence at the sudden passing on of National Parliament Member Timothy "T Z" Khoza and also wish MPs Nomalungelo Gina, Ian Ollis and Cynthia Majeke a speedy recovery.
- 4. [14:17] The Speaker welcomed the former clerk of the Legislative Assembly of Western Australia, Mr Peter McHugh in the House.
- 5. [14:18] The Chief Whip moved without notice: That, notwithstanding Rule 198, precedence be given to the Order of the Day.

[16:36] Mr B D Kivedo moved without notice: That the House conveys its deepest condolences with the family and friends of Honourable Member Timothy Khoza (ANC) from Mpumalanga who passed away yesterday after being involved in a car crash near Paarl; three other Hon Members, Nomalungela Gina of the ANC, Ian Ollis of the DA and Cynthia Majeke of the UDM, sustained injuries during the accident and have been admitted to the Paarl Mediclinic; and also wishes a speedy recovery to all three Hon Members who sustained injuries while on their way to conduct oversight visits at schools.

Mr R D Mackenzie moved without notice: That the House notes the recent appointment of Ms Caroline Peters and Ms Rochelle Philander as Chairperson and Deputy Chairperson of the Mitchells Plain Hospital Board; and further noting that both women have strong community links and that they will focus on improving the services provided by the Mitchells Plain Hospital to the community.

 - (c) conveys its condolences with her family and friends; and
 - (d) calls on the DA's Premier to establish urgently a commission of inquiry into this carnage as the blood of future victims will be on this government's hands.
