Ms N D Nkondlo moved without notice: That the House notes and congratulates Ocean View Library on being crowned champions at the local coding tournament; notes that learners battled it out during the Library Coding Network Tournament entitled Coding4Mandela held at the Old Children's Library at the City Hall on Tuesday 18 July; notes that the libraries that participated are Camps Bay, Mowbray, Observatory, Belhar, Bonteheuwel, Goodwood, Durbanville, Milnerton, Bellville, Parow, Leonsdale, Ocean View, Hanover Park, Manenberg, Central, Pinelands, Pelican Park, Kuyasa, Rocklands, Bishop Lavis, Mfuleni, Mitchells Plain, Grassy Park, Khayelitsha, Adriaanse and Valhalla Park; notes that participating in coding competitions and coming out on top is a remarkable achievement that highlights their dedication, problem-solving skills and programming process; notes that, with this victory, the Ocean View Library has not only earned well-deserved recognition, but also demonstrated the potential of libraries as hubs for learning and innovation; and notes that they can serve as an inspiration to other libraries and communities to invest in similar educational programmes and events to promote digital literacy and technical skills.
