[17:56] Ms M M Wenger moved without notice: That the House implores all South Africans to promote inclusion, reconciliation, redress and non-racialism; and, therefore, condemns the symbols of oppression that promote the opposite, like the display of the old South African flag in Brian's Bar in Sea Point; and calls on each and every citizen to work together to build a country of which we can all be proud of.  
Agreed to.

11. Ms M N Gillion moved without notice: That the House congratulates Benny McCarthy on his appointment as Cape Town City's head coach as well as on his 2–0 victory record since his appointment.

Agreed to.

12. Mr B D Kivedo moved without notice: That the House conveys sincere condolences to our colleague Honourable Tertuis Simmers and his loved ones after the passing away of his mother-in-law Ms Sarah Cornelius Erasmus after 46 years of loyal service to the Western Cape Department of Health. May her soul rest in peace.

13. Ms L J Botha moved without notice: That the House mourns the loss of Florina (Flora) Daniels, a resident of Porterville, who passed away after a long battle with breast cancer; and sends condolences to her husband and family.

14. Ms D Gopie moved without notice: That the House congratulates the athlete Luvo Manyonga on a successful season, being unbeaten in all competitions and winning gold medals at both the World Championships and the Diamond League; and calls on the DA government to facilitate honouring him by naming the Bellville Velodrome and Durban Road after him.

Mr B D Kivedo moved without notice: That the House conveys its sincere condolences to the family and loved ones of Vallentino Williams (17), a Grade 10 learner at the Proteus Secondary School in Atlantis, who was murdered in cold blood on Sunday; and consoles the staff, learners and parent community of the school.

Mr M Mnqasela moved without notice: That the House condemns the barbaric acts and violent criminality that ensued in Kleinmond on Monday 28 August; reiterates that vandalism, damage to public and private property and looting cannot be tolerated; and calls on law-enforcement agencies to unleash the full might of the law and bring to book the perpetrators of these crimes.

27. Ms P Z Lekker moved without notice: That the House commends the police's swift response in the search of the 3-year-old Asaza Sauls of Wallacedene who went missing while going to the shop with her sister and who was found with a stranger in Philippi.

Mr M Mnqasela moved without notice: That the House notes the passing away of Ms Felicia Dunston, a DA activist and community worker, who was loved by her people, served her community with distinction and whose zest for community service left an indelible mark on her community; and conveys its sympathy and condolences to the family, the Blompark community and the DA.

Ms T M Dijana moved without notice: That the House condemns the recent cases of racism in the province, notably the one in Saldanha Bay where farmer Pieter Bester swore at municipality workers and called them the k— and h— words, which led to charges of crimen injuria against him, and the recent murder of a black man by a white man on the West Coast; and calls on the SAPS not to leave any stone unturned in its investigations.
