1. The House met at 14:15.
2. The Speaker took the Chair and read the prayer.
3. [14:16] The Speaker made a general announcement regarding the sitting of the Western Cape Provincial Parliament in accordance with Rule 1A of the Standing Rules pertaining to Members in remote attendance by electronic means.

10. Mr G Bosman moved without notice: That the House sends condolences to the friends and family of Eusebius McKaiser who tragically passed away on 30 May 2023.
Agreed to.
11. Mr L L Mvimbì moved without notice: That the House sends deepest and heartfelt condolences to the families, friends and the community of the five children who tragically died in a learner-transport crash; notes and welcomes the arrest of the perpetrator and how the law is moving swiftly to serve justice for the families of the deceased; and recognises and thanks the various local businesses for offering to assist the grieving families – may their businesses grow beyond expectation.

12. Mr M Kama moved without notice: That the House notes with pride and congratulates the Itsitsa Primary School in Mfuleni for winning four trophies at the Metro North District Music Competition held at the Saffier Primary School in Parow on Saturday 27 May 2023; notes that the competition featured seven primary schools from the Metro North District; notes that they competed in various music categories for places at the provincial music competition next month; and notes that initiatives, such as these ones, assist in keeping children off the streets and prevents them being swallowed by the vile gangsterism in Cape Town that is so popular.

13. Ms P Z Lekker moved without notice: That the House congratulates Mandisa “Mandy” Gavu on being nominated as Founder of the Year at the Africa Awards in Kenya; notes that Mandy hails from Gugulethu and is the founder of Gugs FM, a fast-growing radio station with a wide audience of a unique demographic that is young, growing and multicultural; and notes that she was nominated as the Mediapreneur of the Year in the under 30 category. Congratulations and good luck Mandy.

14. Mr F C Christians moved without notice: That the House notes with great pleasure and congratulates the Durbanville Library that celebrates 100 years of existence; notes that the library was established in 1904 in Vrede Street; notes that it moved in 1923 from the two rooms it occupied in the Durbanville City Hall to a storeroom of the Anglican Church (*Son* 27 May 2023); notes that the library moved to the Durbanville Civic Centre in 1960; notes that in 1973 it moved from the Civic Centre to its current location in Koeberg Road; notes that this library has the second highest circulation in the City of Cape Town with 8 169 members; notes that between January and April of this year their circulation grew by 1 492 new members; and commends the dedicated staff of the library and wishes them well for the future.

15. Mr D America moved without notice: That the House mourns the horrific murder of Pierre and Belinda de Kock, who tragically lost their lives on their farm this past weekend; recognises the urgent need for increased security measures in our rural communities, as well as the urgent requirement for the increased presence and support of law enforcement agencies; recognises the deep sorrow caused by the untimely passing away of Belinda and Pierre de Kock, as well as their immense contributions to the well-being of their community; shows solidarity with the community of Aurora and Piketberg; insists that the South African Police Service continues to intensify its efforts to catch the culprits who have not yet been caught; and sends our thoughts and prayers to the de Kock family, their loved ones and the community of Aurora during this time of tragic loss.

16. Mr P Marran moved without notice: That the House notes with concern the recent outbreak of avian flu that has resulted in the culling of over 500 000 birds and the dire impact this will have on the livelihoods of those in the poultry industry and on food security in the Western Cape; and call on Minister Meyer to provide a report on the extent of the outbreak and the measures that have been taken to mitigate further loss.

Mn D America stel sonder kennisgewing voor: Dat die Huis die gruwelike moord op Pierre en Belinda de Kock, wat tragies hul lewens op hul plaas die afgelope naweek verloor het, betreur; erkenning gee aan die dringende behoefte aan groter veiligheidsmaatreëls in ons landelike gemeenskappe, sowel as die dringende vereiste vir verhoogde teenwoordigheid en ondersteuning van wetstoepassingsagentskappe; erkenning gee aan die diepgaande smart wat veroorsaak is deur die ontydige dood van Belinda en Pierre de Kock, sowel as hul geweldige bydraes tot die welstand van hul gemeenskap; eensgesindheid toon met die gemeenskap van Aurora en Piketberg; aandring dat die Suid-Afrikaanse Polisiediens aanhou om sy pogings te intensifieer om die skuldiges wat nog nie gevang is nie, vas te trek; en die De Kock-familie, hul geliefdes en die gemeenskap van Aurora in ons gedagtes en gebede hou tydens hierdie tyd van tragiese verlies.
