4. [14:18] The Chief Whip of the Majority Party (Mr G Bosman) moved without notice: That, notwithstanding the provisions of Rule 20(1), precedence be given to the Subject for Discussion and the ratification of the Marine Oil Pollution (Preparedness, Response and Cooperation) Bill.

Agreed to.

5. [14:19] The House discussed the following subject in the name of Hon D W Bryant:
The state of local governments in the Western Cape governed by coalitions.

6. [15:26] FIRST ORDER

Consideration of report of the Standing Committee on Local Government, Environmental Affairs and Development Planning on the Marine Oil Pollution (Preparedness, Response and Cooperation) Bill [B 10D–2022] (NCOP), dated 17 June 2025 (see Announcements, Tablings and Committee Reports, no 62, dated 24 June 2025, p 255). (Ratification of final mandate.)

Declarations of vote made on behalf of the ANC, PA, FF Plus, NCC, ACDP, Al Jama-ah, GOOD and DA.

Question put: That the Report of the Standing Committee on Local Government, Environmental Affairs and Development Planning be adopted.

13. Mr D G Jacobs moved without notice: That the House congratulates the South African men's cricket team that has just emerged as victorious at the ICC World Test Cricket final in England; notes that this victory proves to the world that in the so-called country where bad things happen world champions live and play sport; notes that it also gives the next generation of cricket, football and rugby stars the opportunity to dream; further notes that victories like these allow those young ones playing street cricket in Elsies River or football on a patch of open land in Eldorado Park to dream and to grow; and salutes them and thanks them for keeping the flag flying high.

Agreed to.

14. Mr F Kamfer moved without notice: That the House congratulates the South African cricket team, the Proteas, led by captain Temba Bavuma, that won the World Test Championship (WTC); notes that the Proteas defeated Australia by five wickets at Lord's; notes that this marked the Proteas' first-ever WTC title; notes that, for decades, South Africa built a reputation of heartbreak, reaching finals but never clinching them; notes that this win finally silences the doubters; notes that Temba Bavuma, the first black African test captain, led the team to glory; and notes that his captaincy symbolises both progress in transformation and renewed national pride.

15. Ms R Windvogel moved without notice: That the House congratulates Professor Priscilla Baker, senior professor of analytical chemistry at the University of the Western Cape (UWC), after being honoured with the 2025 L'Oréal-UNESCO For Women in Science International Award as the Africa and Arab states laureate; notes that Prof Baker is one of only five recipients worldwide this year, and the only winner representing Africa and the Arab states; notes that she will be officially honoured at UNESCO's headquarters in Paris on 12 June; and notes that, growing up in Bellville South, Cape Town, Prof Baker certainly inspires us all to reach for the stars and we know she is an inspiration to many.

Ms P Z Lekker moved without notice: That the House notes with deep sadness and outrage the tragic killing of a 15-year-old girl from the Zisukhanyo Secondary School in Samora Machel, Cape Town, who was fatally shot while walking to school on the morning of Wednesday 12 June 2025; and notes that this incident is part of a disturbing pattern of vio-

lence in Cape Town communities where innocent school children, particularly in working-class areas, are routinely exposed to violent crime and gang activity.

17. Ms B Stoffel moved without notice: That the House notes the passing away of Major-General André Lincoln in May 2025; notes that Major-General Lincoln was a veteran of the liberation struggle; notes that, as a former uMkhonto weSizwe intelligence officer, he sacrificed much for the freedom and dignity we enjoy today; notes that his courage, patriotism and unwavering commitment to justice remain an inspiration to all South Africans; and notes that, in recognition of his outstanding contributions to both the liberation movement and law enforcement, Major-General André Lincoln was honoured with a state funeral and laid to rest with full provincial honours.

18. Mr N P Masipa moved without notice: That the House congratulates Jaydin Donough, a matriculant at the Belgravia High School, on the remarkable achievement of authoring four books, including *Shadows of the heart*, *Tales of nature* and *Stones in the graveyard*; notes that his works are written with the express purpose of inspiring his peers across the Cape Flats, particularly in his school and neighbouring communities; commends Councillor Rashid Adams of ward 49 for recognising Jaydin's talent and spearheading a fundraising initiative to support the publication of *Stones in the graveyard*; further acknowledges Jaydin's extraordinary contribution to youth literature; and celebrates his role as a beacon of hope and inspiration for young people in the Western Cape.

Mr N P Masipa moved without notice: That the House congratulates Anele Gqasana on being awarded a civic honour in recognition of his dedicated and selfless service to his community; notes that Mr Gqasana has played a leading role in combating gender-based violence, working tirelessly to build a safer and more just society for all; acknowledges the positive and lasting impact of his efforts, particularly in empowering vulnerable individuals and fostering a culture of accountability and support; further notes that this civic honour will be officially conferred on 26 June 2025, and represents a well-deserved recognition of his commitment to justice and safety; and extends sincere appreciation to Mr Gqasana for his unwavering dedication to the public good and commends him as an example of active citizenship in action.

20. Mr N P Masipa moved without notice: That the House congratulates Mr Temba Bavuma, captain of the Proteas, on leading the national cricket team to victory in the ICC World Test Championship final at Lord's; notes with pride that Mr Bavuma was born and raised in Langa, a community with a rich cricketing tradition, where his love for the game was first nurtured on township pitches; acknowledges that his journey from Langa to Lord's stands as a powerful symbol of perseverance, discipline and excellence, and serves as a beacon of hope for aspiring sportsmen and women from similar communities; recognises that his leadership and resilience under pressure have inspired a new generation of cricketers and united South Africans in celebration; and extends heartfelt congratulations to Mr Bavuma and the entire Proteas squad for this historic achievement and for making the nation proud.

Mr N P Masipa moved without notice: That the House congratulates Lifezone Sport International on successfully launching another international soccer exchange tour, DreamPossible9, which saw a group of talented young players from Kensington and Factreton fly to Sweden on 21 June 2025; notes that this remarkable initiative provides life-changing opportunities for the youth through sport, travel and cultural exchange – offering not only elite-level training and international tournament experience, but also fostering friendship, discipline and hope; further notes that this marks the ninth such exchange organised by Lifezone since 2009; acknowledges the critical role of families, local coaches and community supporters who helped raise funds and prepare these young athletes for the journey; and extends sincere congratulations to the Lifezone team for their continued commitment to youth development and for inspiring communities across the Cape Flats through sport.

Ms B M van Minnen moved without notice: That the House congratulates Kaylin Willscott on being named to the Wineland Media and ROTOCON 30 under 30 list; commends her commitment to social upliftment through wine and her leadership as a young woman in a traditionally male-dominated industry; and encourages continued support for young talent and women in the Western Cape’s wine sector.

Mr B Ngqentsu moved without notice: That the House notes that the Cape Town City Football Club, the only team representing Cape Town in the South African Premier Soccer League (PSL) following the relegation of another Cape Town-based team, Cape Town Spurs FC, in the 2023/24 season has also been relegated; notes that the relegation of Cape Town City marks another significant setback for top-flight football in Cape Town, a city with a rich footballing heritage and a passionate sporting community; notes that the PSL plays a critical role in youth development, talent scouting, local economic activity and job creation; notes that this development highlights the need for increased institutional support for professional football in the Western Cape, including grassroots development, investment in clubs and improved collaboration between the private sector, government and sports federations; and notes the need that the government must act decisively.

Ms R Windvogel moved without notice: That the House wishes Banyana Banyana all the best in the upcoming Women's Africa Cup of Nations (WAFCON) 2025, which takes place in Morocco from 5 to 26 July; notes that Banyana Banyana goes into the tournament as defending champions; and wishes coach Desiree Ellis and her players all the best, assures them that the nation is behind them and expresses the certainty that they will make the country proud.
