2. Mr A M Figlan moved: That the House appoints a committee to investigate whether the honourable Khaya Magaxa deliberately misled the House, when he said that the former Head of the Department of Human Settlements, Mbulelo Tshangana, said that the Western Cape Department of Human Settlements does not have a Housing waiting list.
3. Mr G C R Haskin moved: That the House debates the need for minimum norms and standards for school infrastructure.
4. Mr M Skwatsha moved: That the House discusses the massive shortage of clinics in poor and working class areas in the Western Cape.
5. Mr G C R Haskin moved: That the House debates the gangsterism crisis in the Western Cape.
6. Mr M Ozinsky moved: That the House debates the Democratic Alliance acceptance of King Dalindyebo membership, who has been convicted of 10 crimes including culpable homicide, arson and kidnapping, as a Member and what this says about the hypocrisy of the DA and its leadership and their link with gangsters.
