2. Ms D M Baartman: That the House debates the progress the Western Cape has made in delivering inclusive education for learners, with emphasis on implementing the objectives of Education White Paper 6.
3. Mr K Brinkhuis: That the House discusses the changing of by-laws from permits to registration for informal traders to remove the unnecessary red tape required for permits and thereby opening the informal trading sector to more indigent people who are struggling to survive.

VOORSTELLE MET KENNISGEWING

1. Mnr F C Christians: Dat die Huis die voorval debatteer waartydens 'n swanger leerder verhinder is om die Engels EAT V1-vraestel in die Nasionale Senior Sertifikaat 2022 af te lê.
2. Me D M Baartman: Dat die Huis die vordering debatteer wat die Wes-Kaap gemaak het met die verskaffing van inklusiewe onderwys vir leerders, met nadruk op die implementering van die oogmerke van die Witskrif op Onderwys 6.
3. Mnr K Brinkhuis: Dat die Huis die verandering van verordeninge bespreek wat registrasie in plaas van permitte vir informele handelaars vereis, en daardeur onnodige rompslomp verwyder wat vir permitte nodig was, en sodoende die informelehandelsektor toeganklik maak vir meer hulpbehoewende mense wat sukkel om te oorleef.
