Mr M Mnqasela: The challenges in the current structure of the Municipal Funding Model and proposed solutions.

FURTHER BUSINESS

NOTICE OF MOTIONS

1. Mr C M Dugmore: That the House, noting the current interpretation of the status of red-line diagrams by the Surveyor-General of Cape Town and the consequent impact on the property rights of individuals as well as those of the state and the right of access to the coast by the general public, requests the President of the Republic of South Africa to investigate the impact of the red-line diagrams across, not only along the Hessequa coastline between Gouritzmond and Stilstand, but including the entire coastline adjoining the Western Cape, and in particular to investigate the workings of the Cape Town Surveyor-General's office.
2. Mr B D Joseph: That the House:-
 - (a) commends the effort by a former Member of the Legislature, Nazier Paulsen, to contribute to ending the scourge of gangsterism and drugs in the Metro by volunteering to fight in a charity boxing match on 17 July 2015;
 - (b) notes that Mr Paulsen won the fight on a technical knockout in the third round;

- (c) further notes that the non-profit organisation (NPO), Maxim Kids operates two sports clinics in Kraaifontein and Khayelitsha and envisages establishing sports clinics in communities like Mitchell's Plain, Manenberg, Heideveld and Athlone.
3. Mr Q R Dyantyi: That the House debates the refusal by the DA-led City of Cape Town to release a damning KPMG forensic investigation report into corruptive tender irregularities for beach cleaning in 2012.
 4. Ms P Makeleni: That the House debates the state of local municipality sport facilities in the Western Cape after newspapers reports revealed that poor clubs have to fork out thousands of rands to host games because local municipal grounds are not fit for matches.
 5. Mr D Joseph: That the House debates land reform and food security in the Western Cape.
 6. Ms P Makeleni: That the House discusses the neglect of the poor and vulnerable by the provincial Department of Social Development under the DA-run Western Cape.
 7. Mr R D Mackenzie: That the House debates the recent launch of the Stabilization Unit of the City of Cape Town and their success in combating crime in the City.
 8. Mr P Uys: That the House deliberates on the fact that this DA-run Western Cape Provincial Legislature sinks deeper into an escalating crisis.
 9. Mr R T Olivier: That the House condemns the call by the Western Cape Education Department for schools to scrap subjects with low pupil numbers and revise their timetables to artificially deal with overcrowding as this will be a serious violation of children's rights.
 10. Mr L H Max: That the House congratulates the DA Students Organisation on their victory at Pretoria University, as well as DASO candidate Kwena Moloto on his election to the presidency of the Students Representative Committee (SRC).
 11. Mr R D Mackenzie: That the House congratulates Minister Anroux Marais and the Department of Cultural Affairs and Sport for their assistance to initiation schools in the Western Cape, which has reported no deaths or hospitalisation in the Western Cape by the end of August, the closing of the winter season.
 12. Ms P Z Lekker: That the House commends the recent community engagements conducted by the Ministers of the criminal justice and state security cluster, including the Minister of Police, with the aim of addressing crime levels, domestic abuse, police killings and vigilantism in the Western Cape.
 13. Mr N E Hinana: That the House congratulates the City of Cape Town for having successfully installed new surveillance cameras in Gugulethu, and hope that the installation of these cameras will contribute to safeguarding our communities.
 14. Ms L M Maseko: That the House congratulates Minister Bonginkosi Madikizela and his Department for excelling in the 2015 National Govan Mbeki Awards and scooping four first prizes, two second prizes and two third prizes, in the awards contested by all nine provinces, and was also awarded a merit certificate for the Western Cape Rental Housing Tribunal.
 15. Ms P Makeleni: That the House applauds the judgment by Judge Gayaat-Salie-Hlophe, that the DA-led Western Cape Government's practice to place vulnerable children in institutions with awaiting-trial delinquents amounted to a flagrant disregard of the Constitution and infringed on children's rights to security and freedom from violence, and for also rebuking the provincial Department of Social Development, and also commends the Justice Alliance of SA for taking the stand for children's rights against the gross violation by this hypocritical DA government which vainly proclaim constitutionality.

Mr R T Olivier: That the House notes with serious concern the challenges plaguing the DA-run Western Cape Education Department, as about 113 children only began formal education at the end of August, and that the province may have many more learners next year but the Department is only making provision for six additional teaching posts and there is currently an expected shortfall of R450 million in the budget for the 2016/17 financial year.

Ms B A Schäfer: That the House congratulates David Frost, CEO of South African Tourism Services Association, and Otto de Vries, CEO of Association of Southern African Travel Agents, for becoming co-recipients of the 2015 Business Travel Personality of the Year Awards presented today at the Business Traveller Africa Conference & Awards, hosted by Times Media Events and Business Traveller Africa magazine.
18. Mr R D Mackenzie: That the House supports the Western Cape Department of Cultural Affairs and Sport for recognising the following notable Western Cape athletes at the ceremony held this morning, for their successes in boxing, cycling, judo, kickboxing, netball, sailing, wrestling and table tennis, namely: Mzuvukile Magwaca, Mzonke Fana, Shamieg Salie, Wade Theunissen, Francois De Wet, Adrian van Wyk, Hermann Steyn, Marion February, Sherodene Fortuin, Toto Helebhe, Alroy Palm, Vernon Henry, Josh Cloete, Shane Overmeyer, Stan Henkeman, Nicole Makoe and Lindokuhle Duntsu.
