NOTICE OF MOTION (24 June 2021)

- 1. Ms R Windvogel: That the House commends our national government for the responsible manner in which it manages the COVID-19 pandemic in South Africa that shows it cares about the poor and vulnerable, together with more privileged citizens alike.
- 2. Mr C M Dugmore: That the House notes the outcome at the Supreme Court of Appeal in the murder case after Ahmed Timol was killed by former policeman Rodriques; and asks that all apartheid criminals and murderers should be legally prosecuted.
- 3. Mr C M Dugmore: That the House notes that, despite a provincial alcohol harm reduction policy having been gazetted in 2017, the Provincial Cabinet has still not published a bill to amend the provincial Liquor Act; notes that the DA has allowed the sale of alcohol at public schools and has allowed local municipalities in the province to extend trading hours to such an extent that we have longer trading hours than any other province; and expresses deep concern about the apparent capture of certain DA leaders by the liquor industry and the resultant high levels of foetal alcohol syndrome, gender-based violence, murder and violence.

NOTICES OF MOTION (12 August 2021)

- 1. Mr R D Mackenzie: That the House debates the current state of train operations and rail infrastructure in the Western Cape and how it has affected the province's economy, as well as the need for the rail service to be devolved to capable, financially sustainable subnational governments.
- 2. Ms G N Bakubaku-Vos: That the House notes the National Women's Day celebrations this month; and debates the role of women in the struggle for liberation, equality and justice in South Africa lead by the ANC Women's League.
- 3. Mr G Brinkhuis: That the House debates the stringent policy and rulings of certain school governing bodies, particularly at former Model C schools, to allow leeway in accepting learners transferred from other schools due to moving house, parents' job transfers or for other practical reasons.
- 4. Mr M K Sayed: That the House discusses the urgent need for uniform rules for the occurrence of serious violence, improper actions against female learners, the handling of bullies and control of delinquents at all Western Cape schools.
- 5. Mr P Marran: That the House debates inconsistencies and inequalities in local governments mostly at DA-run municipalities, such as the City of Cape Town where trendy and expensive water bicycles are getting preference in areas controlled by the metropolitan council, but severe restrictions are imposed on existing bicycle owners, also on unused expensive infrastructure.
- 6. Mr G Brinkhuis: That the House debates the Department of Social Development's assistance to places of safety for abused women and their children.
- 7. Mr A Lili: That the House considers the undesirable way in which the City of Cape Town taxes people out of their homes by over collection on too high priced water, pushing up electricity costs with hidden taxes and imposing all sorts of tariffs to make it impossible for ordinary people to afford to live decently in this DA-run city.
- 8. Ms A Bans: That the House discusses institutional racism that influences various aspects of life in the Western Cape, from jobs to housing and patterns of settlement.
