MOTIONS WITH NOTICE

1. Mr B Ngqentsu: That the House debates the chronic crisis related to the high vacancy rate in the Western Cape Government, and particularly in the Mobility Department, and its impact on the workers' service delivery.
2. Ms R Windvogel: That the House debates the prevalence of mental health illnesses in the Western Cape, and the inefficiency of government response programmes, especially among homeless people.
3. Mr B Ngqentsu: That the House debates the Western Cape's rising violent crimes, which have made the province one of the most violent and dangerous places in the country, as well as the efficiency of government programmes to combat crime, especially crime related to drugs and gang violence.
4. Ms N D Nkondlo: That the House debates food insecurity in the Western Cape.
5. Ms P Z Lekker: That the House debates informal settlement upgrade programmes in the Western Cape where persistent winter storms have led to widespread flooding in settlements, such as Masiphumelele, Lwandle, Khayelitsha and others, and where this happens every year and affects working-class communities; and clarity must be provided on what informal settlement upgrading programmes the Province is working on.
6. Ms A P Bans: That the House debates whether women in senior government positions are supported to be able to succeed in their roles; and whether women, although they hold seats, really have equal power in decision-making and budget control.

VOORSTELLE MET KENNISGEWING

1. Mnr B Ngqentsu: Dat die Huis die chroniese krisis wat met die hoë vakaturekoers by die Wes-Kaapse Regering, en veral in die Mobiliteitsdepartement, verband hou, en die impak daarvan op werkers se dienslewering debatteer.
2. Me R Windvogel: Dat die Huis die voorkoms van geestesongesteldhede in die Wes-Kaap, en die ondoeltreffendheid van regeringsreaksieprogramme, veral onder hawelose mense debatteer.
3. Mnr B Ngqentsu: Dat die Huis die Wes-Kaap se stygende geweldsmisdade, wat die provinsie een van die gewelddadigste en gevaarlikste plekke in die land maak, en die doeltreffendheid van regeringsprogramme om misdaad te bekamp, veral misdaad wat met dwelms en bendegegeweld verband hou, debatteer.
4. Me N D Nkondlo: Dat die Huis voedselonsekerheid in die Wes-Kaap debatteer.
5. Me P Z Lekker: Dat die Huis programme vir die opgradering van informele nedersettings in die Wes-Kaap debatteer waar volgehoue winterstorms wydverspreide oorstromings in nedersettings, soos Masiphumelele, Lwandle, Khayelitsha en ander, veroorsaak het, en waar dit elke jaar gebeur en werkersklasgemeenskappe raak; en duidelikheid verskaf moet word oor die programme vir die opgradering van informele nedersettings waaraan die Provinsie werk.
6. Me A P Bans: Dat die Huis debatteer of vroue in senior regeringsposisies ondersteun word om sukses in hul rolle te behaal; en of vroue, alhoewel hulle hierdie poste beklee, werklik gelyke gesag in besluitneming en begrotingsbeheer het.
