### **NOTICES OF MOTION**

1. Mr N E Hinana moved: That the House debates the socio-economic impact of the possible renaming of the Cape Town International Airport.
2. Ms S W Davids moved: That the House debates the urgent need for social housing in inner city areas and CBDs.
3. Mr B D Kivedo moved: That the House debates the ongoing sexual harassment and sexual abuse of our learners by unscrupulous teachers and staff members.
4. Ms C F Beerwinkel moved: That the House debates the victimisation of officials who speak out against the executive authority in general, but more specifically the Department of Education in Swellendam; and in this regard the ANC gives notice that it will continue to monitor the pending disciplinary hearing of a dedicated official who is attached to the above-mentioned department.
5. Mr D Joseph moved: That the House debates the completed transport infrastructure projects in the Western Cape weighed up against existing transport needs.
6. Ms D Gopie moved: That the House debates the challenges facing the youth under the DA in the Western Cape.
7. Mr N E Hinana moved: That the House debates the adverse impact of the fuel increase at midnight on Tuesday considering the economic meltdown and high unemployment rate in the country.
8. Ms C F Beerwinkel moved: That the House debates the DA's inability to discharge its constitutional mandate in holding members of the executive accountable.

9. Ms M M Wenger moved: That the House notes that private security guards outnumber the police two and a half times; that the mandate of the Private Security Industry Regulatory Authority (PSIRA) extends only to regulatory compliance and there is no legislation that provides for an oversight authority to investigate complaints against private security guards; and further debates the lack of public accountability of the private security guards.
10. Mr Q R Dyantyi moved: That the House notes the Statistics SA *Non-Financial Census of Municipalities 2017* report that revealed that the number of bucket toilets supplied by municipalities nationally had decreased in 2017; notes further that Eastern Cape municipalities managed to reduce bucket toilets by 15% and the Northern Cape by just under 13%, but that in the Western Cape there was the highest increase, more than 11%, mostly in Mossel Bay; condemns the Western Cape Government for not caring about the poor; and calls on the national Government to intervene.
11. Mr D Joseph moved: That the House debates the positive impact of the entity Wesgro on economic growth in the Western Cape.
12. Mr M Mnqasela moved: That the House notes that the report on the *Non-Financial Census of Municipalities 2017*, which was released by Statistics South Africa on 5 June, revealed that Western Cape municipalities received the highest proportion of consumer units of water and that the free basic water policy benefitted 76,4%, compared to its closest competitor, the Eastern Cape, with 41,8%; further notes that the Western Cape province had the highest proportion of beneficiaries of the free basic sewerage and sanitation policy with 67,9%, followed by the Eastern Cape with 39,2%; also notes that the Western Cape municipalities had the highest score in South Africa as regards the proportion of consumer units that benefitted from the free basic electricity policy; and congratulates the Western Cape Government for its hard work and caring approach with which it continues to deliver the best services in South Africa.
13. Mr R T Olivier moved: That the House notes and condemns the incidents of armed robbery four primary schools in the Western Cape; notes further that the Minister of Education and the Minister of Community Safety have not put adequate measures in place to prevent future incidents; and condemns the provincial government for failing to ensure the safety of teachers and learners in the Western Cape's schools.
14. Mr T A Simmers moved: That the House notes the remarkable work done by the Western Cape Government in its efforts to rebuild the Knysna municipal area after the region was engulfed by raging fires last year; and furthermore notes that although the fires in Knysna left devastation, this beautiful town never missed a beat, showed steady resilience and bounced back from adversity.
15. Mr N E Hinana moved: That the House unequivocally condemns the ANC for misleading the members of the public, parents and learners at KwaFaku Primary School during a meeting of the Standing Committee on Transport and Public Works on Tuesday 5 June 2018; notes that this has led to protest action by 100 students yesterday; further condemns that the ANC's destructive politicking holds learners' education at ransom as it delays and disrupts the work of the relevant stakeholders; and notes that the fumigation was done within four days and that the date for the demolition was brought forward to 30 June.

16. Mr K E Magaxa moved: That the House notes that irate DA leader Mmusi Maimane revealed on Sunday that it was regrettable and untenable to keep honourable Helen Zille in her position, and that she would not return to any position in the DA government when her term as Premier ends next year; welcomes the announcement that vindicates the ANC for saying she is a liability to the administration of the province; and calls on her to see all the warning signs showing that she is a stumbling block to transformation and progress in the province and leave now.
17. Ms S W Davids moved: That the House notes that the infighting in the DA is spreading to almost all the municipalities in the province; notes further that Mayco member Francis Jacobs, a confidante of Patricia De Lille in the Drakenstein Municipality, has been removed to make room for Wendy Philander, who is a so-called Madikizela supporter; condemns the infighting in the DA as it has caused a collapse of governance in several municipalities; and calls for intervention by the national government.
18. Mr Q R Dyantyi moved: That the House notes that the DA mayor of George, Melvin Naik, received a letter from the DA's federal legal commission on Monday 4 June informing him of the cessation of his DA membership; notes further that Naik is the second victim of the so-called De Lille clause and that other DA leaders may be forced out; also notes that the DA mayor of Knysna, Eleanore Spies, is also out; condemns the collapse of governance where the DA is governing; and calls for intervention by the national government.
19. Mr R T Olivier moved: That the House notes with concern the failure by the chairperson to manage the joint meeting of the Standing Committee on Transport and Public Works and the Standing Committee on Education on Tuesday, which resulted in the collapse of the meeting after representatives from Crossroads, whom he had invited, were not allowed to speak.
20. Ms D Gopie moved: That the House notes and supports demands by the communities of District Six and the Bo-Kaap that their areas should be declared full heritage sites to counter gentrification; and calls on the national Minister of Arts and Culture to intervene and assist immediately.
21. Ms S W Davids moved: That the House notes, despite denials by the DA, that evictions in the Drakenstein Municipality are continuing daily; notes further that in the latest incident, on the farm Tweespruit yesterday, people were evicted without a court order; and calls on the national government to intervene.
22. Ms N D Nkondlo moved: That the House notes and welcomes the farm eviction dialogue, which was hosted by Mcebisi Skwatsha, Deputy Minister of Rural Development and Land Reform, in partnership with the Women on Farms Project at Simondium on Monday; notes further that he visited farms and saw the living conditions of farmworkers and met those facing pending eviction; welcomes his call to consider some farms in the Drakenstein area as test cases for expropriation without compensation; and calls for an urgent review of the Extension of Security of Tenure Act (Esta).
21. Mr K E Magaxa moved: That the House notes the legal spat between the honourable Helen Zille, Premier of the Western Cape, and Tony Ehrenreich, provincial Secretary Cosatu; further notes that Ehrenreich is threatened because of his pointing out that state resources were abused to benefit the company of the Premier's son and daughter-in-law; notes that the ANC has laid a complaint in this regard with the Public Protector and also supplied evidence to Ehrenreich; and also notes that the ANC supports Ehrenreich in exposing this matter.
