Ms W F Kaizer-Philander: The failure of the South African Social Security Agency to provide services to the people of the Western Cape and the impact this has on the most vulnerable people in the society.

FURTHER BUSINESS

NOTICES OF MOTION (*14 November 2024*)

1. Mr F C Christians: That the House debates the proliferation of unregulated spaza shops in South Africa.
2. Mr B Ngqentsu: That the House debates the effectiveness of the Western Cape Safety Plan in reducing violent crime and considers additional measures to enhance public safety and to combat criminal activities in the province.

3. Ms R Windvogel: That the House urgently debates the Western Cape Government's decision to cut 2 407 teacher posts, its impact on education quality, particularly in less affluent areas, and explores alternative solutions to address the Province's funding challenges in education.
4. Ms A P Bans: That the House debates strategies to stimulate economic growth and to create jobs in the Western Cape, with the focus on addressing unemployment and promoting sustainable development across all sectors.
5. Ms P Z Lekker: That the House debates comprehensive plans to reduce the number of informal settlements in the Western Cape, focusing on providing dignified shelter and alleviating poverty through sustainable housing solutions.
6. Mr B Ngqentsu: That the House debates the merits and challenges of devolving authority over policing, rail and logistics to the Western Cape Government and municipalities, and its potential impact on service delivery and governance in the province.
7. Ms P Z Lekker: That the House debates measures to combat the "extortion mafia" phenomenon affecting infrastructure projects in the Western Cape, and considers strategies to protect businesses and to ensure the completion of critical development initiatives.
8. Ms B Stoffel: That the House debates the improvement of disaster response and prevention measures in the Western Cape, with particular focus on building regulations, enforcement and enhancing the role of the Provincial Disaster Management Centre.
9. Mr B Petrus: That the House debates the tragic collapse of a building in George, which occurred on 6 May 2024, which has raised significant concerns regarding safety, accountability and governance under the leadership of the DA-led George Municipality; notes that the recent collapse of a building in George has not only resulted in the devastating loss of life and property, but has also exposed serious questions regarding the oversight, regulatory building and compliance, including the safety standards currently maintained by the local municipality; and calls on the Premier of the Western Cape to table the preliminary report on this incident urgently in the House for debate, including instituting a judicial commission of inquiry to investigate this tragic incident further independently where any shortcomings have been identified and to report back to the House on the findings thereof.
10. Mr B Petrus: That the House notes and debates the impact of illegal foreigners on jobs, education, crime, housing, health, trading and agriculture in the Western Cape, and implements measures and a strategy that will protect the citizens of the Western Cape against the negative impact of illegal foreigners.

NOTICES OF MOTION (*7 November 2024*)

1. Ms D Stephens: That the House congratulates the PA for winning the by-election in George.
2. Ms A Cassiem: That the House notes that last week Guguletu residents took to the streets to demand the construction of a district hospital that was promised by the provincial Department of Health and Wellness a few years ago; further notes that the residents are against the idea of the hospital being constructed where their sports field is currently situated as the field serves a good purpose in the society; notes that residents further complained that the KTC Community Centre no longer serves its purpose as it can no

longer meet the needs of the growing population, and it is in a state of despair with poor services, not wheelchair-user-friendly and with no proper parking area; and calls on the provincial Department of Health and the Department of Infrastructure to work together to ensure that Guguletu has a district hospital with a trauma unit.

3. Ms R Windvogel: That the House notes with concern reports that at least 20 learners from the Mzamomtsha Primary School in Driftsands, Cape Town, were rushed to a local clinic on Wednesday morning after complaining of stomach cramps; further notes that, while 18 of the learners have since been discharged, the cause of the incident remains unconfirmed, and that circulating rumours suggest food poisoning as a possible cause; calls on the WCED and other relevant authorities to investigate the cause of the incident thoroughly and to ensure that no stone is left unturned in identifying the source of the problem; further calls on the WCED and the relevant health authorities to implement stricter measures regarding the food sold at schools and provided to learners through the National School Nutrition Programme (NSNP) to safeguard the health and well-being of all learners across the province; and expresses support for efforts to ensure that proper health and safety standards are upheld in school environments, especially in relation to food safety, and that corrective action is taken as necessary to prevent any recurrence.
4. Ms A P Bans: That the House notes the action of the Disability Revolution group, which led a picket at the Civic Centre on 5 November 2024 to demand better access to public transport for people with disabilities in the City of Cape Town; supports the group's call for the City of Cape Town to include specific measures in the Comprehensive Integrated Transport Plan (CITP) 2023–2028 to address the transport needs of people with disabilities, particularly those from poor communities and informal settlements; acknowledges the challenges faced by people with disabilities, as highlighted by the group, including inadequate public transport infrastructure, the lack of consultation on the Dial-a-Ride business plan, and the inaccessibility of certain transport services and facilities, such as taxis, trains and stations; recognises the dignity of every individual and the urgent need for equitable transport access for people with disabilities, including affordable, reliable and accessible transport options in both formal and informal areas of the city; calls on the City of Cape Town and other relevant authorities to heed the call made by the Disability Revolution group to update the CITP to include comprehensive, actionable plans for improving transport access for people with disabilities, and to ensure that their voices are properly heard in the planning and implementation of transport policies; and further calls on the City of Cape Town to ensure that future public transport services, including the Dial-A-Ride system, are designed with input from people with disabilities and that accessibility is prioritised so that no person is left behind due to their mobility needs.
5. Ms A P Bans: That the House notes with concern the protest action by the residents of Guguletu, Cape Town, who, while acknowledging the urgent need for a new healthcare facility in their community, have expressed strong opposition to the proposed site for the hospital on the existing sports field; recognises that the Guguletu community, particularly the youth, rely on the sports field for recreational activities, and that the loss of this space would have a significant impact on their well-being, especially in the light of the ongoing social challenges and the involvement of the youth in gangs; supports the community's demand for the construction of a new hospital with the necessary facilities, including a trauma unit, obstetric unit and maternity ward, to address the health needs of the growing population of Guguletu and the surrounding areas, such as Philippi, Lusaka and the informal settlements; acknowledges the critical importance of preserving existing

recreational spaces, such as the sports field in Guguletu, which serves as a vital outlet for physical activity and social cohesion, especially given the social ills affecting the youth in the area; calls on the Western Cape Department of Health and Wellness and the City of Cape Town to identify an alternative site for the construction of the new hospital, one that will meet the healthcare needs of the community without sacrificing valuable recreational spaces; urges that a consultative process be undertaken, involving the relevant stakeholders, including local sports clubs, schools and residents, to ensure that both healthcare and recreational needs are balanced and adequately addressed; and further calls on the government to prioritise the development of both essential healthcare infrastructure and accessible spaces for youth engagement in order to promote holistic community development and well-being in Guguletu.

6. Ms D Stephens: That the House notes that the Western Cape Minister of Social Development, Mr Jaco Londt, and the Department of Social Development are urgently called upon to intervene at the Benevolent Park Old-age Home in Mossel Bay; notes that the reports from the community indicate that residents who express views differing from those of the management face discrimination and victimisation; notes that this institution, which should be a haven of comfort and respect, risks failing its duty to the most vulnerable in our society – our elderly; notes that it is both a moral and legislative responsibility of our government and community to ensure that our senior citizens live in safety, dignity and free from mistreatment; this House, as the voice of the people, must prioritise the welfare of our elderly and act to eliminate any form of neglect or abuse in facilities entrusted with their care; and trusts that this matter will be handled with urgency and a comprehensive investigation be done to uphold the standards of care expected in our province.

ONDERWERP VIR BESPREKING

Me W F Kaizer-Philander: Die versuim van die Suid-Afrikaanse Agentskap vir Maatskaplike Sekerheid om dienste aan die mense van die Wes-Kaap te verskaf en die impak wat dit op die mees weerlose mense in die samelewing het.

VERDERE WERKSAAMHEDE

KENNISGEWING VAN VOORSTELLE (14 November 2024)

- Mnr F C Christians: Dat die Huis die vermeerdering van ongereguleerde huiswinkels in Suid-Afrika debatteer.
- Mnr B Ngqentsu: Dat die Huis die doeltreffendheid van die Wes-Kaapse Veiligheidsplan in die vermindering van geweldsmisdaad debatteer en bykomende maatreëls oorweeg om openbare veiligheid te verbeter en om kriminele bedrywigheede in die provinsie te bekamp.
- Me R Windvogel: Dat die Huis dringend die Wes-Kaapse Regering se besluit om 2 407 onderwysersposte te besnoei en die impak daarvan op onderwysgehalte, veral in minder gegoede gebiede, debatteer, en alternatiewe oplossings ondersoek om aandag te skenk aan die Provinsie se befondsingsuitdagings in onderwys.

4. Me A P Bans: Dat die Huis strategieë debatteer om ekonomiese groei te stimuleer en om werk te skep in die Wes-Kaap, met die fokus op die skenk van aandag aan werkloosheid en die bevordering van volhoubare ontwikkeling in alle sektore.
5. Me P Z Lekker: Dat die Huis omvattende planne om die getal informele nedersettings in die Wes-Kaap te verminder debatteer, met die fokus op die verskaffing van waardige skuilings en die verligting van armoede deur volhoubare behuisingsoplossings.
6. Mn B Ngqentsu: Dat die Huis die meriete en uitdagings van die afwenteling van bevoegdheid oor polisiëring, die spoorweë en logistiek na die Wes-Kaapse Regering en munisipaliteit debatteer, en die potensiële impak daarvan op dienslewering en bestuurstoesig in die provinsie.
7. Me P Z Lekker: Dat die Huis maatreëls debatteer om die verskynsel van die “afpersingsmafia” wat infrastruktuurprojekte in die Wes-Kaap raak, te bekamp, en strategieë oorweeg om sakeondernemings te beskerm en om die voltooiing van kritieke ontwikkelingsinisiatiewe te verseker.
8. Me B Stoffel: Dat die Huis die verbetering van rampreaksie en voorkomingsmaatreëls in die Wes-Kaap debatteer, met besondere fokus op bouregulasies, wetstoepassing en die versterking van die rol van die Provinciale Rampbestuursentrum.
9. Mn B Petrus: Dat die Huis debatteer die tragiese ineenstorting van 'n gebou in George, wat op 6 Mei 2024 plaasgevind het, wat aansienlike kommer oor veiligheid, aanspreeklikheid en bestuurstoesig laat ontstaan het oor die leierskap van die DA-geleide George-munisipaliteit laat; kennis neem dat die onlangse ineenstorting van 'n gebou in George nie net tot die tragiese verlies van lewens en eiendom gelei het nie, maar ook ernstige vrae laat ontstaan het oor bestuurstoesig, regulatoriese bouprosesse en voldoening, insluitende die veiligheidstandaarde wat tans deur die plaaslike munisipaliteit gehandhaaf word; en 'n beroep op die Premier van die Wes-Kaap doen om die voorlopige verslag oor hierdie voorval dringend in die Huis vir debat ter tafel te lê, insluitende die instelling van 'n geregtelike kommissie van ondersoek om hierdie tragiese voorval verder onafhanklik te ondersoek, en indien enige tekortkominge daar geïdentifiseer word, om aan die Huis oor daardie bevindinge verslag te doen.
10. Mn B Petrus: Dat die Huis neem kennis van en die impak van onwettige buitelanders op werkgeleenthede, onderwys, misdaad, behusing, gesondheid, handel en landbou in die Wes-Kaap debatteer, en maatreëls en 'n strategie implementeer wat die burgers van die Wes-Kaap teen die negatiewe impak van onwettige buitelanders sal beskerm.

KENNISGEWING VAN VOORSTELLE (7 November 2024)

1. Me D Stephens: Dat die Huis die PA gelukwens nadat hulle die tussenverkiesing in George gewen het.
2. Me A Cassiem: Dat die Huis kennis neem dat inwoners van Guguletu verlede week die strate ingevaar het om die bou van 'n distrikshospitaal te eis wat 'n paar jaar gelede deur die provinsiale Departement van Gesondheid en Welstand beloof is; verder kennis neem dat die inwoners teen die idee gekant is dat die hospitaal gebou word waar hul sportveld tans geleë is, aangesien die veld 'n goeie doel in die samelewing dien; kennis neem dat inwoners verder gekla het dat die KTC-gemeenskapsentrum nie meer sy doel dien nie, aangesien dit nie meer in die behoeftes van die groeiende bevolking kan voorsien nie, en dat dit vervalle

is met swak dienste, nie rolstoelgebruikersvriendelik is nie, en nie oor 'n behoorlike parkeergebied beskik nie; en 'n beroep op die provinsiale Departement van Gesondheid en die Departement van Infrastruktuur doen om saam te werk om te verseker dat Guguletu 'n distrikshospitaal met 'n trauma-eenheid kry.

3. Me R Windvogel: Dat die Huis met kommer kennis neem van berigte dat minstens 20 leerders van die Prim  re Skool Mzamomtsha in Driftsands, Kaapstad, Woensdagoggend na 'n plaaslike kliniek gehaas is nadat hulle oor maagkrampe gekla het; verder kennis neem dat, terwyl 18 van die leerders intussen ontslaan is, die oorsaak van die voorval onbevestig bly, en dat gerugte die ronde doen dat voedselvergiftiging 'n moontlike oorsaak was; 'n beroep op die WKOD en ander tersaaklike owerhede doen om die oorsaak van die voorval deeglik te ondersoek en toe te sien dat alles moontlik gedoen word om die oorsaak van die probleem te identifiseer; verder 'n beroep op die WKOD en die tersaaklike gesondheidsowerhede doen om strenger maatre  ls te implementeer met betrekking tot die voedsel wat by skole verkoop word en aan leerders deur die Nasionale Skoolvoedingsprogram (NSVP) verskaf word om die gesondheid en welstand van alle leerders in die provinsie te beskerm; en ondersteuning uitspreek vir pogings om toe te sien dat behoorlike gesondheid- en veiligheidstandaarde in skoolomgewings gehandhaaf word, veral met betrekking tot voedselveiligheid, en dat die nodige regstellende stappe gedoen word om enige herhaling te voorkom.
4. Me A P Bans: Dat die Huis kennis neem van die optrede van die Disability Revolution-groep, wat op 5 November 2024 'n betoging by die Burgersentrum geleei het om beter toegang tot openbare vervoer vir mense met gestremdhede in die Stad Kaapstad te eis; ondersteuning uitspreek vir die groep se beroep op die Stad Kaapstad om spesifieke maatre  ls in die Omvattende Geintegreerde Vervoerplan ("Comprehensive Integrated Transport Plan" of CITP) 2023–2028 in te sluit om aandag te skenk aan die vervoerbehoeftes van mense met gestremdhede, veral van diegene in arm gemeenskappe en in informele nedersettings; erkenning gee aan die uitdagings wat mense met gestremdhede in die gesig staar, soos deur die groep uitgelig, insluitende onvoldoende openbarevervoerinfrastruktuur, die gebrek aan oorlegpleging oor die Bel-'n-Rit-sakeplan, en die ontoeganklikheid van sekere vervoerdienste en fasiliteite, soos taxi's, treine en stasies; erkenning gee aan die waardigheid van elke individu en die dringende behoefté aan billike vervoertoegang vir mense met gestremdhede, insluitende bekostigbare, betroubare en toeganklike vervoeropsies in beide formele en informele gebiede van die stad; 'n beroep op die Stad Kaapstad en ander tersaaklike owerhede doen om gehoor te gee aan die beroep van die Disability Revolution-groep om die CITP by te werk om omvattende, uitvoerbare planne vir die verbetering van vervoertoegang vir mense met gestremdhede in te sluit, en om toe te dien dat hul stemme behoorlik gehoor word tydens die beplanning en implementering van vervoerbeleide; en verder 'n beroep op die Stad Kaapstad doen om toe te sien dat toekomstige openbarevervoerdienste, insluitende die Bel-'n-Rit-stelsel, ontwerp word met die insette van mense met gestremdhede en dat toeganklikheid geprioritiseer word sodat geen persoon as gevolg van hul mobiliteitsbehoeftes uitgelaat word nie.
5. Me A P Bans: Dat die Huis met kommer kennis neem van die protesaksie deur die inwoners van Guguletu, Kaapstad, wat hul sterk teenkanting uitgespreek het teen die bestaande sportveld as die voorgestelde terrein van die hospitaal, terwyl hulle die dringende behoefté aan 'n nuwe gesondheidsorgfasiliteit in hul gemeenskap erken het; erkenning gee dat die Guguletu-gemeenskap, veral die jeug, op die sportveld staatmaak vir ontspanningsaktiwiteite, en dat die verlies van hierdie ruimte 'n beduidende impak op hul

welstand sal hê, veral in die lig van die voortdurende maatskaplike uitdagings wat ondervind word en die betrokkenheid van die jeug by bendes; die gemeenskap se eis vir die bou van 'n nuwe hospitaal met die nodige fasilitete ondersteun, insluitende 'n trauma-eenheid, verloskundige eenheid en 'n kraamsaal, om in die gesondheidsbehoeftes te voldoen van die groeiende bevolking van Guguletu en die omliggende gebiede, soos Philippi, Lusaka en die informele nedersettings; erkenning gee aan die kritieke belangrikheid van die behoud van bestaande ontspanningsruimtes, soos die sportveld in Guguletu, wat dien as 'n noodsaaklike uitlaatklep vir fisiese aktiwiteite en sosiale samehorigheid, veral gegewe die maatskaplike euwels wat die jeug in die gebied raak; 'n beroep op die Wes-Kaapse Departement van Gesondheid en Welstand en die Stad Kaapstad doen om 'n alternatiewe terrein vir die bou van die nuwe hospitaal te identifiseer, een wat in die gesondheidsorgbehoeftes van die gemeenskap sal voorsien sonder om waardevolle ontspanningsruimtes in te boet; daarop aandring dat 'n oorlegplegingsproses onderneem word, wat die tersaaklike belanghebbendes, insluitende plaaslike sportklubs, skole en inwoners, sal betrek om toe te sien dat beide gesondheidsorg- en ontspanningsbehoeftes gebalanseerd en toereikend aandag ontvang; en 'n beroep op die regering doen om die ontwikkeling van beide noodsaaklike gesondheidsorginfrastruktur en toeganklike ruimtes vir jeugbetrokkenheid te prioritiseer ten einde holistiese gemeenskapsontwikkeling en -welstand in Guguletu te bevorder.

6. Me D Stephens: Dat die Huis kennis neem dat die Wes-Kaapse Minister van Maatskaplike Ontwikkeling, mnr Jaco Londt, en die Departement van Maatskaplike Ontwikkeling dringend versoek word om in te gryp by die Benevolent Park-ouetehuis in Mosselbaai; kennis neem dat berigte van die gemeenskap aandui dat inwoners wat menings uitspreek wat verskil van dié van die bestuur, diskriminasie en victimisasie in die gesig staar; kennis neem dat hierdie instelling, wat 'n hawe van vertroosting en respek moet wees, die risiko loop om sy plig teenoor die mees weerloses in ons samelewing – ons bejaardes – te versuum; kennis neem dat dit beide 'n morele en wetgewende verantwoordelikheid van ons regering en gemeenskap is om toe te sien dat ons senior burgers in veiligheid, met waardigheid en vry van mishandeling leef; hierdie Huis, as die stem van die mense, moet die welsyn van ons bejaardes prioritiseer en optree om enige vorm van verwaarloosing of misbruik uit te skakel by fasilitete wat met hul sorg toevertrou word; en die vertroue uitspreek dat hierdie aangeleentheid met dringendheid hanteer sal word en 'n omvattende ondersoek gedoen sal word om die standaarde van sorg wat verwag word in ons provinsie, te handhaaf.

1. UMnu F C Christians: Sokuba iNdlu ixoxe ngokwanda kwevenkilana ezithengisa ezilokishini ezingagunyaziswanga eMzantsi Afrika.

2. UMnu B Ngqentsu: Sokuba iNdlu ixo xe ngokusebenza kweSicwangciso sezoKhuseleko seNtshona Koloni ukunciphisa ulwaphulomthetho lobundlobongela kwaye iqwalasele amanyathelo ongezelelekileyo ukusa phambili ukhuseleko loluntu kwanokuthibaza izenzo zolwaphulomthetho ephondweni.
