MOTION

Mr M G E Wiley: That an ad hoc committee be established to investigate and report whether the Honourable Leader of the Opposition and the Honourable Member Dugmore deliberately misled the House during the sitting of the House on 4 May 2017, when they made the following statements:

- (1) "She later called Africans refugees." (Leader of the Opposition)
- (2) "Most recently she exposed her adoration for colonial apartheid." (Leader of the Opposition)
- (3) "The Premier in this very House, referring to black ANC women members, said: All they are good for is to collect "padkos" (food for the road) after meetings and drive home." (Member Dugmore)
- (4) "Then we had the refugee tweet. No sincere apology about the hurt, because in her consciousness she has done nothing wrong." (Member Dugmore)

MOTIONS (CONTINUED)

SUBJECT FOR DISCUSSION

Ms M M Wenger: The findings of the Urban Safety Report which, inter alia, places the spotlight on the failure of SAPS to reduce the availability of guns and drugs in Cape Town communities and which is contributing to a breakdown in relations with civil society due to increased crime and gang violence.

1. Mr B D Kivedo: That the House debates the implementation and execution of more stringent, pro-active and progressive measures to combat gang violence in the Western Cape.

- 12. Mr D Joseph: That the House debates the failure of the national government to implement information technology systems in all legislatures, under the project called "integrated financial management systems".

Mr Q R Dyantyi: That the House notes that anger exploded at the weekend in the West Coast town of Klawer after a white man shot and killed Hartvicht "Mannetjies" Ockhuis and wounded his friend Howard Andrews; further notes that the suspect was arrested and appeared in the Klawer Magistrate's Court on charges of murder and attempted murder; and condemns the racist attack and welcomes the arrest of the perpetrator.
- 14. Ms M N Gillion: That the House calls for an urgent solution to the financial situation at the Child Welfare Society at Albertinia, an NGO funded by the provincial government, as it turns out they don't have a proper telephone or vehicle for the work of social workers at Albertinia.
- 15. Ms M M Wenger: That the House calls on the national Police Department to increase the reservist recruitment rate and reinstate reservist levels to what they were before the recruitment moratorium.
- 16. Ms T M Dijana: That the House notes that dirty drinking water have been delivered to the Beaufort West residents of Ward 7 in an old, rusted truck for the past four weeks as the newly elected DA councillor Japie van der Linde does not care for them; and further notes that the pigs on his farm get water of a better quality
- 17. Mr R T Olivier: That the House supports calls made by the national teachers' union for an urgent summit of all stakeholders to address the challenge of attacks on teachers and other forms of violence in schools, which they say have reached a crisis point, with very minimal intervention from this provincial government.

- 18. Mr R T Olivier: That the House notes that the honourable Education Minister D Schäfer was again proved wrong about her prediction that the national government will not in the near future give money for the drought and fire crisis in the Western Cape as the national government does not understand disasters.
- 19. Mr S G Tyatyam: That the House notes that the honourable Premier and the DA forced the Conduct Committee chairperson L H Max and Registrar of Members' Interests to resign in order to protect the One & Only salary bragger Human Settlements Minister B Madikizela who failed to declare gifts he received and hospitality he enjoyed on his birthday; and further notes the law that he broke was in fact passed by the DA, the party that he leads in this province.

Ms S W Davids: That the House notes with concern that the provincial Department of Human Settlements displays an inconsiderate and uncaring attitude following an order to Ms Sylvia Beukes (77) from Parkwood to demolish a Wendy house that she erected at her house to accommodate her divorced daughter who is very sick and in need of care; further notes that she asked for the Department's approval before she erected the structure and was told that, due to a shortage of inspectors, her case would be attended to next year; and calls for an urgent intervention from the provincial government
