1. Ms M M Wenger: The O'Regan Commission of Inquiry report on policing in Khayelitsha.

NOTICE OF MOTIONS

1. Mr R B Lentit: That the House debates the impact of Eskom's 25.3% tariff increase, and the Western Cape Government's strategy for alternative energy sources to sustain the economy of the Western Cape.
2. Ms P Makeleni: That the House debates the effectiveness of the Western Cape Provincial Government's strategy to fight drug addiction and whether it has any solution to the overcrowding of drug addicts in mental institutions.
3. Ms T M Dijana: The House debates the outcomes of the Bredasdorp Gender Violence Pilot Study that was recently announced by Minister Plato at a policing Imbizo in the area, as well as the plans by the Department to mitigate the problem of gender based violence and killings.
4. Mr R T Olivier: That the House debates the plans by the DA to close more schools in the Western Cape Province.
5. Ms B A Schäfer: That the House condemns the breach of security at OR Tambo Airport where two stowaways managed to get onto a plane.
6. Mr K E Magaxa: That the House notes 48 angry Manenberg families are facing their second winter living under terrible conditions in cold shipping containers due to this DA government's mismanagement of the upgrading of their flats with the failed Filcon saga, its embarrassing failure to deal with the drug wars in the area and the payment of gangsters for so-called protection with the full knowledge of the DA leaders in the City of Cape Town.

7. Mr S G Tyatyam: That the House notes the Cuban 5 arrived as free men in the Western Cape to a hero's welcome this week touring the country to show gratitude for the solidarity shown to them whilst unlawfully and unjustly imprisoned in the USA and further notes that Cuba played a pivotal role in the liberation struggle of the Southern African countries.
8. Ms L J Botha: That the House commends Minister Mbombo and Minister Fritz and their departments for their joint proactive efforts to tackle the social ills of substance abuse in the Western Cape.
9. Ms D Gopie: That the House notes that innocent children are being raped, killed and maimed whilst this DA-led administration fails to appoint a Children's Commissioner.
10. Ms P Z Lekker: That the House notes the City of Cape Town has flip-flopped on its position from protecting the payment of gangsters for so-called protection at its building sites into at long last firing the subcontractors who in the name of the city assisted to pay the gangsters.
11. Ms B A Schäfer: That the House thanks the City of Cape Town for beating the loadshedding on 21 June 2015, and keeping the city's lights on while Eskom kept the rest of the country in the dark.
12. Ms M M Wenger: That the House notes:
 - (a) the recent utterances of President Jacob Zuma regarding the Marikana massacre and his naming of the Marikana Miners as killers;
 - (b) that the President has been in possession of the Farlam Commission of Inquiry's Report into the Massacre for three months already and has not released it publicly;
 - (c) that these utterances show contempt for the victims for this tragedy and their relatives;
 - (d) that the President's comments have exposed his bias in this matter and decimated the public's trust in the President as well as the ANC government's ability to deliver justice; and thereforecondemns the President's utterances regarding the Marikana miners as well as his threat to make a return to brutal apartheid-style policing.

KENNISGEWING VAN VOORSTELLE

1. MnR R B Lentit: Dat die Huis die impak van Eskom se 25.3% tariefverhoging en die Wes-Kaap Regering se strategie vir alternatiewe energiebronne om die ekonomie van die Wes-Kaap te onderhou, debatteer.
2. Me P Makeleni: Dat die Huis die doeltreffendheid van die Wes-Kaapse Proviniale Regering se strategie om dwelmverslawwing te beveg en of enige oplossing vir die oorbevolking van dwelmverslaafdes in geestesinrigtings het, debatteer.
3. Me T M Dijana: Dat die Huis die uitkomste van die Bredasdorp Geslagsgeweld Loods-studie wat onlangs deur Minister Plato by 'n polisiëring Imbizo in die gebied bekendgestel is, sowel as planne deur die Departement om die probleem van geslagsgebaseerde geweld-en moorde te verlig, debatteer.
4. MnR R T Olivier: Dat die Huis die planne deur die DA om meer skole in die Wes-Kaap Provinsie te sluit, debatteer.
5. Me B A Schäfer: Dat die Huis die verbreking van sekuriteit by OR Tambo Lughawe waar twee verstekelinge daarin geslaag het om op 'n vliegtuig te kom, veroordeel.

6. MnR K E Magaxa: Dat die Huis kennis neem dat 48 woedende Manenberg gesinne hul tweede winter van lewe onder haglike toestande in koue skeepsvraghouders in die gesig staar weens hierdie DA Regering se wanbestuur van die opgradering van hul woonstelle met die mislukte Filcon sage, van sy embarrasserende mislukking om die dwelmoorloë in die gebied die hoof te bied en die betaling van bendelede vir sogenaamde beskerming met die volle medewete van die DA-leiers in die Stad Kaapstad.
7. MnR S G Tyatyam: Dat die Huis kennis neem dat die Kubaanse 5 vandeesweek as vry mans te midde van ‘n heldeontvangs in die Wes-Kaap aangekom het en deur die land gaan toer om hul dankbaarheid te betoon vir die solidariteit met hulle terwyl hulle onwettig en onregverdig in die VSA gevange gehou is, en verder kennis neem dat Kuba ‘n sleutelrol in die bevrydingsbeweging van Suider-Afrikaanse lande gespeel het.
8. Me L J Botha: Dat die Huis Minister Mbombo en Minister Fritz en hul departemente loof vir hul gesamentlike pogings om die maatskaplike euwels van middelmisbruik in die Wes-Kaap aan te pak.
9. Me D Gopie: Dat die Huis kennis neem dat onskuldige kinders verkrag, vermoor en vermink word terwyl die DA-geleide administrasie misluk het om ‘n Kinderkommissaris aan te stel.
10. Me P Z Lekker: Dat die Huis kennis neem van die Stad Kaapstad se ommeswaai van sy posisie van verdediging van die betaling van bendelede vir sogenaamde beskerming by sy boutersele na die uiteindelike afdanking van die subkontrakteurs wat in die naam van die Stad bygedra het om die bendelede te betaal.
11. Me B A Schäfer: Dat die Huis die Stad Kaapstad bedank dat hy die beurtkrag op 21 Junie 2015 vermy het en die stad se ligte aangehou het terwyl Eskom die res van die land in donkerte gehul het.
12. Me M M Wenger: Dat die Huis kennis neem –
 - (a) van die onlangse uitsprake van President Jacob Zuma aangaande die Marikana-slagting en dat hy die Marikana mynwerkers as “killers” bestempel het;
 - (b) dat die President reeds vir drie maande in besit was van die Farlam Kommissie van Ondersoek se Verslag oor die slagting en dit nie aan die publiek vrygestel het nie;
 - (c) dat hierdie uitsprake minagtig wys vir die slagoffers van hierdie tragedie en hul familielede;
 - (d) dat die President se kommentaar sy vooroordeel in hierdie saak gewys het en die publiek se vertroue in die President sowel as die ANC-regering se vermoë om geregtigheid te laat geskied, vernietig het; en derhalwe die President se uitsprake veroordeel oor die Marikana mynwerkers sowel as sy dreigement om terug te keer na brutale apartheid-styl polisiëring.
