ORDER OF THE DAY

Consideration of Report of the Social Cluster study tour visit to Bavaria in Germany from 4 to 12 November 2017. (See Announcements, Tablings and Committee Reports, No 30, dated 17 May 2018, p 82).

FURTHER BUSINESS

NOTICES OF MOTION

1. Ms M N Gillion moved: That the House debates the state of healthcare under the DA government in the Western Cape.
2. Ms B A Schäfer moved: That the House debates the importance and effectiveness of public participation.
3. Ms S W Davids moved: That the House debates the upsurge in service-delivery protests in rural towns in the Western Cape under the DA.
4. Ms B A Schäfer moved: That the House debates the energy readiness of the Western Cape.
5. Ms S W Davids moved: That the House notes with resentment that Steenvilla families in Cape Town – including elderly women and children – are forced to sleep in a field outside their homes in the cold winter rain as the heartless DA government evicted them last week; notes further this is another way that the DA is proving to be more ruthless than the apartheid government; and calls on the national government to intervene.

6. Ms M N Gillion moved: That the House notes that the head of the Western Cape Health Department, Ms Beth Engelbrecht, told Parliament's portfolio committee last week that the Tygerberg Hospital was in such a dilapidated state that it would have to be shut down and replaced; notes further that Ms Engelbrecht and Keith Cloete had told the committee that the hospital had very old infrastructure and that the waiting times were the longest there; and calls on the national government to intervene before Tygerberg vanishes in front of our eyes, like the G F Jooste Hospital.
7. Ms S W Davids moved: That the House notes that shoddy workmanship and poor maintenance by DA-run municipalities are placing people's lives at risk as a pregnant woman was hospitalised on Monday night after the landing of the stairway at her Clarke Estate council flat collapsed and she fell; wishes Melissa Finch (32) a speedy recovery; and calls for an investigation into the matter, as residents are blaming the City of Cape Town for not upgrading the ageing block of flats.
8. Mr K E Magaxa moved: That the House notes that South Africa's Public Protector found that the colonialism-praising tweets of the honourable Premier of the Western Cape, Helen Zille, constituted improper conduct in terms of the Constitution; calls on the Western Cape Provincial Parliament to speed up the appropriate action to hold the honourable Zille accountable; and welcomes the verdict.
9. Ms M N Gillion moved: That the House notes that the cabinet has approved the long-awaited National Health Insurance Bill, which aims to provide free healthcare to everyone at the delivery points, and is financed in such a way that the healthy and wealthy will be subsidising the poor and sick; welcomes this move; and commends the cabinet on this announcement.
10. Mr C M Dugmore moved: That the House notes the ongoing inability of the DA provincial government to deal decisively with the taxi violence; and once again calls on the Minister of Transport and Public Works to implement the recommendations of the Farlam Commission.
11. Mr Q R Dyantyi moved: That the House notes the bitter war between the DA and Cape Town mayor, Patricia de Lille, is continuing after reports that the Mayor's right-hand man, Loyiso Nkohla, was summarily suspended; and calls on honourable Minister Bredell to rein in the City before the total collapse of government in the metropolitan municipality.
12. Ms M N Gillion moved: That the House notes the increase in violent service-delivery protests in rural Western Cape towns and the DA government's inaction.
13. Mr Q R Dyantyi moved: That the House notes with dismay that the DA's provincial leadership has ordered newly elected Knysna mayor, Mark Willemse, to resign as his election is regarded as an overthrow of the leadership; notes further that after Willemse's defiant refusal to resign, DA provincial leader, honourable Member Madikizela, was quoted as saying Willemse did not have the mandate of the DA and that the party could not be held ransom like that; condemns the hypocrisy of the DA as it has been advocating votes according to conscience and yet its members are punished for doing so; and supports Willemse as he is rescuing that municipality.

VERDERE WERKSAAMHEDE

VOORSTELLE MET KENNISGEWING

1. Me M N Gillion stel voor: Dat die Huis die toestand van gesondheidsorg onder die DA-regering in die Wes-Kaap debatteer.
2. Me B A Schäfer stel voor: Dat die Huis die belangrikheid en doeltreffendheid van openbare deelname debatteer.
3. Me S W Davids stel voor: Dat die Huis die toename in diensleweringsoptrede in landelike dorpe in die Wes-Kaap onder die DA debatteer.
4. Me B A Schäfer stel voor: Dat die Huis die energiegereedheid van die Wes-Kaap debatteer.
5. Me S W Davids stel voor: Dat die Huis met wrewel daarvan kennis neem dat die families van Steenvilla in Kaapstad – wat onder meer bejaarde vrouens en kinders insluit – geforseer is om in die koue winterreën in die veld buite hul huise te slaap, want die hartelose DA-regering het hulle verlede week uitgesit; verder daarvan kennis neem dat dit net nog 'n manier is waarop die DA wys dat hy wreder as die apartheidsregering is; en 'n beroep op die nasionale regering doen om in te gryp.

6. Me M N Gillion stel voor: Dat die Huis daarvan kennis neem dat die hoof van die Wes-Kaapse Departement van Gesondheid, me Beth Engelbrecht, verlede week die Parlement se portefeuljekomitee meegedeel het dat die Tygerberg-hospitaal in so 'n vervalde toestand is dat die hospitaal gesluit en vervang sal moet word; verder daarvan kennis neem dat me Engelbrecht en Keith Cloete die komitee ingelig het dat die hospitaal se infrastruktuur baie oud is en dat wagtye by daardie hospitaal die langste is; en 'n beroep op die nasionale regering doen om in te gryp voordat die Tygerberg-hospitaal, net soos die G F Jooste-hospitaal, voor ons oë verdwyn.
7. Me S W Davids stel voor: Dat die Huis daarvan kennis neem dat die swak vakmanskap en gebrekkige onderhoud deur munisipaliteite wat deur die DA bestuur word, mense se lewens in die gevaar stel aangesien 'n swanger vrou Maandagaand in die hospitaal opgeneem is nadat sy geval het toe die trapportaal van die trapskag by haar Clarke Estate-raadswoonstel ineengestort het; Melissa Finch (32) 'n spoedige herstel toewens; en vra dat daar ondersoek ingestel moet word na die kwessie, want inwoners neem die Stad Kaapstad kwalik omdat die verouderende woonstelblok nie opgeknop word nie.
8. Mnr K E Magaxa stel voor: Dat die Huis daarvan kennis neem dat Suid-Afrika se Openbare Beskermer bevind het dat die twiets van die agbare Premier van die Wes-Kaap, me Helen Zille, waarin sy kolonialisme prys, ingevolge die Grondwet onbehoorlike gedrag is; 'n beroep op die Wes-Kaapse Provinsiale Parlement doen om die toepaslike optrede te versnel om die agbare Zille verantwoordbaar te hou; en die uitspraak verwelkom.
9. Me M N Gillion stel voor: Dat die Huis daarvan kennis neem dat die kabinet die langverwagte Wetsontwerp op Nasionale Gesondheidsversekering ("National Health Insurance Bill") goedgekeur het, wat ten doel het om gratis gesondheidsorg aan almal by die diensleweringspunte te lewer, en dat dit op só 'n manier gefinansier sal word die gesondes en welgesteldes die armes en siekes sal subsidieer; hierdie stap verwelkom; en die kabinet vir hierdie aankondiging aanprys.
10. Mnr C M Dugmore stel voor: Dat die Huis kennis neem van die DA- provinsiale regering se voortgesette onvermoë om beslissend op te tree met betrekking tot taxigeweld; en weereens 'n beroep op die Minister van Vervoer en Openbare Werke doen om die aanbevelings van die Farlam-kommissie te implementeer.
11. Mnr Q R Dyantyi stel voor: Dat die Huis kennis neem van die bitter stryd tussen die DA en die burgemeester van Kaapstad, Patricia de Lille, wat voortduur ná berigte dat die burgemeester se staatsmaker, Loyiso Nkohl, summier geskors is; en 'n beroep op agbare Minister Bredell doen om beheer oor die Stad oor te neem voordat regering in die metropolitaanse munisipaliteit heeltemal ineenstort.
12. Me M N Gillion stel voor: Dat die Huis kennis neem van die toename in gewelddadige diensleweringssprotesaksies in die plattelandse dorpe van die Wes-Kaap en die DA-regering se gebrek aan optrede.
13. Mnr Q R Dyantyi stel voor: Dat die Huis met misnoeë kennis neem dat die DA se provinsiale leierskap die nuutverkose burgemeester van Knysna, Mark Willemse, opdrag gegee het om te bedank aangesien sy verkiesing as 'n omverwerping van die leierskap beskou word; verder daarvan kennis neem dat die provinsiale leier in die DA, agbare Lid Madikizela, ná Willemse se uitdagende weiering om te bedank, aangehaal is dat hy sou gesê het dat Willemse nie die mandaat van die DA het nie en dat die party nie so gedreig kan word nie; die skynheiligheid van die DA veroordeel, want die party is ten gunste van stem volgens gewete, maar lede word gestraf wanneer hulle dit doen; en Willemse steun aangesien hy besig is om daardie munisipaliteit te red.
