Consideration of the reports of the Conduct Committee (see Announcements, Tablings and Committee Reports, No 82, dated 28 October 2016, p 228, and No 100, dated 30 November 2016, p 409).

FURTHER BUSINESS

NOTICE OF MOTIONS (in terms of Standing Rule 147(1) (a))

1. Mr K E Magaxa: That the House debates the unbecoming behaviour of the honourable Premier Zille in the House which has led to her being booted out of the House at two consecutive sittings for undermining the authority of the Speaker and disregarding House rules by refusing to withdraw unparliamentary comments.
2. Mr D Joseph: That the House debates the mandate and sustainability of district municipalities.
3. Ms P Z Lekker: That the House debates the efficiency and effectiveness of the Western Cape Police Ombudsman.

4. Mr N E Hinana: That the House debates the progress made with the allocation of housing opportunities in the Western Cape.
5. Ms T M Dijana: That the House debates the impact that the influx of international tourists will have on water shortages in the province; and the mitigating strategies adopted by the provincial government.
6. Mr B D Kivedo: That the House debates the unscrupulous, criminal and barbaric actions of violence, protest, destruction, looting and anarchy on our campuses, in state building, in residential areas and in public open spaces.
7. Mr D Joseph: That the House debates urban and rural development relating to budget allocations.
8. Ms P Z Lekker: That the House notes with concern that the killing of women and children continues unabated in the province as a result of the honourable Premier Zille's refusal to take action as requested by the citizens; further notes that more women were killed in recent weeks: Laurina Ryk (26) from De Doorns died after she was allegedly beaten with a shovel by her boyfriend; the body of Zanele Sandlana (21) was dumped in an open field in TR Section, Lingeletu West, last week and she was found with a bottle stuffed in her mouth; Shannon Mozes was strangled to death by her boyfriend in Heinz Park; and Asive Sizani (19) was found strangled to death at her boyfriend's house in Delft on Sunday morning; condemns the senseless killing of women in the province; welcomes the arrests of killers in all the cases above; and conveys condolences to their families.
9. Ms M M Wenger: That the House condemns the Department of Agriculture, Forestry and Fisheries for its handling of fishing quotas in the Western Cape, which is resulting in the marginalisation of historic fishing communities such as at Hangberg; and requests the national government to revise the quotas and allocations.
10. Ms T M Dijana: That the House notes that Day Zero, when the province's dams run dry, could arrive in December; further notes that the province is in this predicament as a result of failures by DA-led municipalities and the provincial government to plan for and manage daily water consumption better by allowing, among others, agriculture businesses and construction to waste water while the poor are forced to abide by water limits; and calls on the national Department of Water and Sanitation to intervene.
11. Mr K E Magaxa: That the House notes that Premier Zille's latest trip to Thailand and Vietnam with three other government officials cost R540 000; condemns the waste of taxpayers' money on international journeys that have no economic benefit for the province; and calls on the Premier to give a detailed breakdown of what the money was spent on.

NOTICE OF MOTIONS (in terms of Standing Rule 147(1)(b))

Mr M G E Wiley: That an ad hoc committee be established to investigate and report whether the honourable members as indicated deliberately misled the House during the sittings of the House on 4 May 2017 (Leader of the Opposition and Member Dugmore) and 24 August 2017 (Leader of the Opposition and Member Olivier), when they made the following statements:

- (1) “She later called Africans refugees.” (Leader of the Opposition)
- (2) “Most recently she exposed her adoration for colonial apartheid.” (Leader of the Opposition)
- (3) “The Premier in this very House, referring to black ANC women members, said: All they are good for is to collect “padkos” (food for the road) after meetings and drive home.” (Member Dugmore)
- (4) “Then we had the refugee tweet. No sincere apology about the hurt, because in her consciousness she has done nothing wrong.” (Member Dugmore)
- (5) “She spends a lot of time abroad to study the good aspects of apartheid and racist colonialism ...” (Leader of the Opposition)
- (6) “It is the same MEC that forges ahead to turn our schools into shebeens.” (Member Olivier),

and that the committee consists of four members of the DA, two members of the ANC and one member of the ACDP.
