### NOTICE OF MOTIONS

- 1. Ms D Gopie moved: That the House debates the provincial government's failed strategies to address deaths from non-communicable diseases (particularly diabetes which is the number one killer) that are responsible for 68% of the deaths of women in the Western Cape.
- 2. Mr R Q Dyantyi moved: That the House debates the exorbitant increases in tariffs and rates in DA-run Western Cape municipalities.
- 3. Mr D Joseph moved: That the House debates the Western Cape Government's achievement of its strategic goals.

- 4. Mr N E Hinana moved: That the House debates the effect of Metrorail's cancellations of railway services on service delivery in the Western Cape.
- 5. Ms P Makeleni moved: That the House deliberates over the disturbing surge of child killings in the Western Cape under the DA's rule.
- 6. Mr R T Olivier moved: That the House deliberates over the school transportation system in the DA-run Western Cape which forces thousands of learners to walk long distances.
- 7. Ms N D Nkondlo moved: That the House debates the failure of the DA to deal with looming job losses in the agriculture sector in this province.
- 8. Ms S W Davids moved: That the House examines the continued and exacerbated evictions in the province under the DA's rule.
- 9. Ms T M Dijana moved: That the House discusses the unacceptably high number of illegal guns in circulation in the Western Cape and the failure of the strategies of this DA-led provincial government to address it.
- 10. Mr D G Mitchell moved: That the House condemns the various brutal acts of violence against South Africa's women by Deputy Minister of Higher Education and Training Mduduzi Manana; and call for swift justice for this horrific crime.
- 11. Ms C F Beerwinkel moved: That the House conveys condolences to the family of Shaheed Omar, the nephew of the late ANC stalwart Dullah Omar, who was murdered on Thursday last week; condemns the brutal shooting during an attempted hijack; and calls on this DA government to accept its responsibility for social issues and job creation as the core reasons for crime and gangsterism that result in such senseless killings.
- 12. Mr R Q Dyantyi moved: That the House notes another DA-deployed cadre was discovered double-dipping when Stellenbosch municipal manager Geraldine Mettler was found to have taken salaries simultaneously from Cape Town and Stellenbosch; and further notes this resembles the double-dipping by Ryan Coetzee, the honourable Premier Zille's former adviser, who took salaries from the Western Cape Government and the City of Cape Town at the same time and who was also found by the Public Protector to have been improperly deployed in this administration on the Premier's watch.
- 13. Ms S W Davids moved: That the House notes that the residents of Masiphumelele are still forced to live in squalor, amid canals filled with sewerage running between homes, despite the DA-led Western Cape Government instructing the City of Cape Town to clean the canals; condemns the DA in the City of Cape Town for their uncaring attitude; and calls on the Province to force the City to improve the living conditions of people in poor areas.
- 14. Ms L M Maseko moved: That the House notes and congratulates the Stellenbosch Municipality on being selected as a co-winner in the category Best Upgrading of an Informal Settlement for their Watergang Informal Settlement at this year's Govan Mbeki Awards, which was held at the Lord Charles Hotel in Somerset West last Friday; and further notes and congratulates the Stellenbosch Municipality for also being awarded the prize for the Best Integrated Residential Development Programme for their Jamestown Project.

- 15. Ms P Makeleni moved: That the House notes with concern that so far at least 25 children in the province have been killed at the hands of people known to them and/or to their families; further notes that, as a result of this carnage, parents, NGOs specialising in child protection and communities called for the establishment of a commission of inquiry into child murders in the Western Cape; rejects and condemns the honourable Premier Zille's attempts to stall this process by advocating for an indepth expert study into six cases of child murder; calls on stakeholders to reject her proposal out of hand; and demands the immediate establishment of a commission of inquiry.
- 16. Mr K E Magaxa moved: That the House calls on the honourable Premier Zille to share some of the key lessons learned about the legacy of colonialism and the suppression of people from her latest study tour to Ghana.
- 17. Ms P Z Lekker moved: That the House commends the visit by Deputy Minister of Police Bongani Mkongi to the gang-infested Avian Park in Worcester this week where he engaged with communities about their concerns; welcomes the commitment to increase police visibility and deploy more resources; and notes that this is how the ANC government creates a safer and more secure Western Cape, unlike the DA that is always nagging and using people's pains for political gains.
- 18. Ms L M Maseko moved: That the House notes and congratulates the City of Cape Town on being selected as the winner in the category Social Housing Programme for their Belhar Gardens Project at this year's Govan Mbeki Awards, which was held at the Lord Charles Hotel at Somerset West last Friday; and further notes and congratulates the City on being selected as co-winner in the category Enhanced People's Housing Process for their Ocean View Project.
- 19. Ms P Makeleni moved: That the House notes that UCT researchers have found that there is a need for a children's commissioner in the Western Cape even though the honourable Premier Zille broke her solemn promise to appoint one.
- 20. Ms L M Maseko moved: That the House notes and congratulates the Knysna Municipality on being selected as a co-winner in the category Enhanced People's Housing Process for their Vision 2000 Project at this year's Govan Mbeki Awards, which was held at the Lord Charles Hotel at Somerset West last Friday.
- 21. Mr R Q Dyantyi moved: That the House notes that the people of Knysna and Plettenberg Bay might not know what really caused the fires that destroyed their homes in June this year as the findings of two forensic investigations into the matter are contradicting one another; and calls for the immediate release of the findings of the AfriForum investigation that differ from the provincial government's finding that the fires were started by humans.
- 22. Ms P Z Lekker moved: That the House notes that, despite the honourable Premier Zille's political interference to prevent two of the Western Cape's most dedicated crime fighters (Major Generals Jeremy Vearey and Peter Jacob) from being promoted, the two have been reinstated by the Labour Court to their initial positions; and supports the calls by Popcru and others in the police fraternity for the two to be reinstated immediately in their rightful posts.
- 23. Ms L M Maseko moved: That the House notes and congratulates the Oudtshoorn Municipality on being selected as co-winner in the category Best Upgrading of an Informal Settlement for their Rosevalley Informal Settlement at this year's Govan Mbeki Awards, which were held at the Lord Charles Hotel at Somerset West last Friday.

- 24. Mr R T Olivier moved: That the House notes that teachers in gang-infested areas are resigning; and calls on the DA-led provincial authorities to do more to ensure the safety of learners and teachers at schools.
- 25. Mr R T Olivier moved: That the House notes that the Bill to make shebeens of schools in the Western Cape has been withdrawn due to public ridicule and pressure; further notes this follows the refusal by the honourable Premier Zille to institute a commission of inquiry into child murders; and further notes that the withdrawal of the Bill seeks to circumvent her promise to appoint a children's commissioner for the province.
- 26. Mr R D Mackenzie moved: That the House notes the recent increase in gang-related violence and shootings in Mitchells Plain; and calls on the national Ministry of Police to bring back the specialised gang units.
- 27. Mr R D Mackenzie moved: That the House strongly condemns the ANC for firing Dr Makhosi Khoza as chairperson of Parliament's Public Service and Administration Portfolio Committee; furthermore commends Dr Makhosi Khoza for continuing to show integrity; and notes that she is a shining light of the truth and an example that the ANC should follow.
- 28. Ms P Makeleni moved: That the House notes that the ANC's support for NGOs working on children's rights forced the honourable Premier Zille to change her approach from outright rejecting the calls for a commission of inquiry into child killings; notes her delay tactics of first wanting an in-depth study before she appoints a commission; calls on the NGOs to demand the commission to be set up immediately and to appoint the promised children's commissioner; and commends all who work to create a safe space for our children.
