SUBJECT FOR DISCUSSION

Mr C M Dugmore: The importance of the amendment to section 25 of the Constitution of the Republic of South Africa, the introduction of the Expropriation Bill and how helpful these will be in addressing the patterns of land ownership in the Western Cape.

NOTICE OF MOTION (17 June 2021)

- 1. Mr M K Sayed: That the House calls on the Western Cape Education Department and South African Human Rights Commission to investigate the alleged racist and discriminatory remarks made by a teacher to black learners that led to a protest at the German International School in Cape Town this week.
- 2. Mr P J Marais: That the House, in terms of its oversight function, requests the Minister of Local Government to enter into serious talks with the Mayor of the City of Cape Town to address urgently the issue of rubbish pile-ups and absence of dust bins in the areas of Nooitgedacht, The Hague, Rosendale and Eindhoven; and notes that this constitutes a serious health hazard, which is causing much distress among the people, and should be addressed without delay.
- 3. Ms R Windvogel: That the House notes that extra COVID-19 vaccine sites are provided in Gauteng and senior citizens may go without an appointment for their jabs; and calls on the Western Cape to get on with the job speedily.
- 4. Mr C M Dugmore: That the House notes another internal DA fight at local-government level is destabilising George, where Councillor Charleen Titus (60) brought a charge of crimen injuria against the DA's Melvin Roelfztra of ward 14 (Rosedale) for various alleged derogatory references to her.

5. Mr M K Sayed: That the House expresses concern about the fact that the majority of schools in our province, especially in poor and working-class communities, will not be ready to welcome back learners full-time while still maintaining COVID-19 physical distancing requirements due to already overcrowded classrooms; notes that the number of mobile classrooms being provided is not enough; and notes that Western Cape Education Department should engage with the Provincial Treasury for additional emergency funding for more classrooms and teaching posts.
