Mr M Mnqasela: Outstanding achievement of the Democratic Alliance in the recent local government elections.

NOTICE OF MOTIONS

- 1. Mr D G Mitchell moved: That the House debates youth development in the Western Cape.
- 2. Ms D Gopie moved: That the House debates the horrendous state of healthcare facilities in the Western Cape under the DA and the low levels of satisfaction experienced by patients.
- 3. Ms P Z Lekker moved: That the House joins the NPA, the Western Cape High Court, and the Development Community in condemning the deceptive claims of the DA Premier, Helen Zille, that the gang conviction rate in the Mitchells Plain Magistrate's Court is a mere 0,7%; and calls on the Premier to correct the figures and desist from using baseless claims to score cheap political points.
- 4. Mr R T Olivier moved: That the House debates the high incidence of corporal punishment at schools in the Western Cape; and why the WCED ignored the social-audit findings by Equal Education.
- 5. Mr K E Magaxa moved: That the House debates the unacceptable high number of bucket toilets still used in Western Cape, despite the enormous resources this province have.
- 6. Mr C M Dugmore moved: That the House institutes an investigation into whether the conduct of the DA-run Cape Town-appointed Straatwork Ministry Projects are legal, after allegations that employees are not formally employed and that they are treated like slaves.

- 7. Mr K E Magaxa moved: That the House notes with dismay reports that Syferfontein residents in the DA-run George must share a bucket toilet between ten households and share four taps between 86 households on average; notes that this further affirms the StatsSA report that the use of bucket toilets was the worst in Western Cape; and calls on the national Department of Water and Sanitation to intervene to assist these neglected people.
- 8. Mr R T Olivier moved: That the House notes the growing support for and calls from the public for the reinstatement of Brian Isaacs, principal of the South Peninsula High School; and calls on the WCED to bring back their principal.
- 9. Mr K E Magaxa moved: That the House welcomes clarity provided by the Statistician-General to the lies peddled by the DA that methods and standards used to measure sanitation in the recent General Household Survey are out-dated; and encourages the DA to accept the fact and reality that the use of bucket toilets has increased in this province under its control.
- 10. Mr K E Magaxa moved: That the House notes that there is consensus among domestic workers in Sea Point that the Tafelberg School site be used to champion a new model of low-cost housing; notes further that this is an opportunity to undo the legacy of segregation which is still evident in the province; and commends the workers for their activism.
- 11. Mr S G Tyatyam moved: That the House debates the illegal watermelon market next to the Breede Valley Municipality that is used to raise funds for the DA election campaign by the husband of the mayor of the Breede Valley Municipality.
- 12. Ms M N Gillion moved: That the House notes with concern that Minister Schäfer has raised her objection to the motion by Member Olivier calling for the reinstatement of Mr Brian Isaacs given that she will in all likelihood sit in on the appeal of this matter.
- 13. Mr M Mnqasela moved: That the House congratulates the Western Cape for once again being the province that received the most clean audits in South Africa where it received 73% clean audits, while the second-best-performing province was Gauteng at 33% and KwaZulu-Natal was third with 30%.
- 14. Mr C M Dugmore moved: That the House notes with deep concern that a former Minister of this House and current member of the DA, Mr Theuns Botha, has actually encouraged his son to stand against the DA in ward 7 in the Hessequa Municipality.
- 15. Mr M G E Wiley moved: That the House expresses its disappointment with the "Working on Fire" firefighting teams who were sent to help combat fires in Canada and who have now decided to down tools over a wage dispute.
- 16. Mr D G Mitchell moved: That the House wishes the Molander kids from Mitchells Plain well for the National Karate Championship taking place in Bloemfontein later this year; and notes with gratitude the Minister and her department's assistance to make this possible.
