SUBJECT FOR DISCUSSION

1. Mr B D Joseph: The renaming of towns with colonial names and the removal of colonial and apartheid statues from public spaces in light of their irrelevance in post-apartheid South Africa, with specific focus on the Western Cape, values and identity.

FURTHER BUSINESS

NOTICE OF MOTIONS

1. Ms B A Schäfer: That the House debates the Winelands toll roads.
2. Mr R T Olivier: That the House debates the school infrastructure backlogs in the Western Cape as stipulated in the WCED plan released on 12 June 2015, and the mitigation plans by the department.
3. Mr L H Max: That the House debates the importance to reduce road traffic and to increase the use of public transport and rail freight services.
4. Mr Q R Dyantyi: That the House debates the effectiveness of this DA government's recently launched Winter Preparedness Program and the plight of ordinary people affected by the winter season in all the informal settlements.
5. Mr M Mnqasela: That the House debates the successes and challenges of the Western Cape Municipalities at the hand of the audits as discussed in the Auditor-General's report of 2013/14 and propose solutions to streamline problem areas.

6. Ms M M Wenger: That in June, which is Youth Month, the House debates youth unemployment and ways to provide our young people with work opportunities.
7. Mr D Joseph: That the House debates the national allocation of funding to local government in relation to the National Development Plan.
8. Mr M Mnqasela: That the House takes note of the swift and transparent steps taken by the Democratic Alliance to bring two of its public representatives to account for conduct related matters.
9. Mr R T Olivier: That the House notes the poor condition of the bus that was recently hired to transport Members of this Legislature to George in the pouring rain and cold weather and that the policy be reviewed on the procurement of such vehicles for official use by the relevant oversight committees.
10. Mr D Joseph: That the House commends the DA Leader, Mmusi Maimane, for calling for an urgent debate on President Omar Al-Bashir's unconstitutional departure from the Republic.
11. Mr N E Hinana: That this House notes:-
 - (a) that the chaotic and violent culture when losers of elections in the ANC, ANC Youth League and EFF conferences become the trademark where pangas, guns and machetes are brought in;
 - (b) that new factions are forever exposing themselves on how intolerant they become when confronted by defeat in fair elections;
 - (c) the re-run of the ANCYL conference in eThekweni, and the consequent assistance through court interventions; and
 - (d) these are the alarming indications that South Africa can expect when the ANC has to relinquish its power.
12. Ms D Gopie: That the House notes with concern the deteriorating state of public health in the province, especially the Wesfleur Hospital in Atlantis where at least 3 dubious deaths were reported in the past month alone.
13. Mr S G Tyatyam: That the House notes a patently untruthful statement by the DA national leader Mmusi Maimane that claimed the DA has created millions of jobs in Khayelitsha, an area that according to Census 2011 has less than 400 000 residents.
14. Mr M Mnqasela: That the House acknowledges Paul Mashatile, the ANC leader in Gauteng, for his courageous stand against the ANC-led government's findings on the Nkandla report;
15. Mr C M Dugmore: That the House welcomes and commends the initiative of Deputy Minister of Public Service and Administration, comrade Ayanda Dlodlo to arrange a youth career expo on Saturday, 20 June 2015 in Albertinia and believes that this intervention will be a fitting event as part of the Youth Month.
16. Mr M Mnqasela: That the House celebrates the excellent work done by the Western Cape Municipalities and congratulate them on the excellent performance in the Annual Auditor-General's Report of 2013/14. The DA-governed Western Cape Municipalities received 55% (18 auditees) unqualified with no findings reports, and 42% (or 14 auditees) for receiving unqualified with findings reports.
