MOTIONS

SUBJECT FOR DISCUSSION

Ms C Murray: The national government's lack of urgency in securing South Africa's status in terms of the African Growth and Opportunity Act (AGOA) and the subsequent implications for trade and economic growth in the Western Cape.

FURTHER BUSINESS

NOTICES OF MOTION (25 May 2023)

1. Mr G Bosman: That the House debates the inefficiencies within the South African Police Service (SAPS) and how it has affected and hamstrung the current state of safety and policing in the Western Cape.
2. Mr F C Christians: That the House debates the delay in getting the railway lines and resultant infrastructure in the Western Cape in working condition to benefit the community.

NOTICES OF MOTION (20 April 2023)

1. Mr C M Dugmore: That the House notes and commends the South African President, HE Cyril Matamela Ramaphosa, for the sterling job he and his government are doing to attract investment to our country, despite the present-day challenges; notes further that, in wrapping up the country's Investment Conference on Thursday, the President announced that South Africa has exceeded its initial R1,2 trillion investment target that was set in 2018 by over 25%; and notes further and welcomes the President's new investment target of R2 trillion by 2028. inspectors to inspect workplaces and to issue employers with compliance orders.
2. Ms D M Baartman: That the House notes with great concern the reductions to the Western Cape's provincial equitable share (PES) Health component; notes that, when the Western Cape Department of Health and Wellness provides home care to our most needy citizens, this care is not considered at all in PES calculations; rejects the system whereby capable governments are penalised for serving the interest of the people and incompetent governments are rewarded with additional funding; and notes that the PES formula is flawed and must be reviewed in order to ensure the Western Cape receives its fair share and can continue to provide quality services to the people of this province.
3. Mr T M Klaas: That the House notes that the Zwelihle Public Clinic in Hermanus is on the brink of collapse as it is failing to execute its service delivery duties; notes that the clinic experience long queues on a daily basis and the majority of these patients are turned away by the staff at the clinic due to inadequate staff at the facility; notes that nurses and staff at the clinic are complaining that they are overworked and are unable to attend to every patient as the Western Cape Department of Health and Wellness does not want to hire more staff to assist patients at the clinic; calls on the Western Cape Minister of Health to attend to this issue as a matter of urgency and also to make sure that we have clinics operating 24/7; and notes that cities, such as Ekurhuleni in Gauteng, have clinics operating for 24 hours from Monday to Saturday, while the Western Cape Department of Health and Wellness spends most of its time bragging about clean audits and not responding to patients' needs.
4. Mr C M Dugmore: That the House congratulates Ms Desiree Ellis, who hails from the Western Cape, on being awarded the national order, the Order of Ikhamanga (Gold), for her sustained encouragement and advancement of women to succeed in their respective fields after she herself contributed excellently to the field of football; and further congratulates long-standing ANC activist and member, Keith Gottschalk, on being awarded the same order but in silver; notes that Mr Gottshalk, as the notation points out, used "his creativity to draw critical attention to oppressive and unjust laws through performative political poetry; work that motivated many to fight for liberation", while some on the opposite side of this House supported the apartheid system.
5. Ms A P Bans: That the House notes and is shocked at the decision taken by the City not to replace street lighting along Baden Powell Drive in Strandfontein; notes that, since the lights went off in that area, the area has been a crime scene; notes that bodies are found almost daily, and that motorists are hijacked and assaulted; notes that the Strandfontein crime-fighters (CPF) have promised to fight the City for such negligence as former Mayor Dan Plato promised to improve lighting on the notorious coastal road and now the City is refusing, saying replacing street light lamps at this time due to the repeat cases of vandalism and the continued replacement of infrastructure is not feasible; and demands that the City to fix the lights, as this is a danger to society.

Me C Murray: Die nasionale regering se gebrek aan dringendheid om Suid-Afrika se status ingevolge die Wet op Groei en Geleentheid in Afrika ("African Growth and Opportunity Act" of AGOA) te verseker en die gevolglike implikasies vir handel en ekonomiese groei in die Wes-Kaap.

VERDERE WERKSAAMHEDE

KENNISGEWING VAN VOORSTELLE (25 Mei 2023)

1. Mr G Bosman: Dat die Huis die ondoeltreffendheid binne die Suid-Afrikaanse Polisie diens (SAPD) en hoe dit die huidige toestand van veiligheid en polisieëring in die Wes-Kaap beïnvloed en gekniehalter het, debatteer.
2. Mnr F C Christians: Dat die Huis oor die verdrag om die spoorlyne en gevolglike infrastruktuur in die Wes-Kaap in 'n werkende toestand te kry tot voordeel van die gemeenskap, debatteer.

KENNISGEWING VAN VOORSTELLE (20 April 2023)

1. Mnr C M Dugmore: Dat die Huis kennis neem van die Suid-Afrikaanse President, Sy Eksellensie Cyril Matamela Ramaphosa, aanprys vir die puik werk wat hy en sy regering doen om belegging na ons land te lok, ondanks die hedendaagse uitdagings; verder kennis neem dat, met die afsluiting Donderdag van die land se Beleggingskonferensie, die President aangekondig het dat Suid-Afrika sy aanvanklike beleggingsteiken van R1,2 triljoen wat in 2018 gestel is, met meer as 25% oorskry het; en verder kennis neem van en dit verwelkom dat die President se nuwe beleggingsteiken R2 triljoen teen 2028 is.
2. Me D M Baartman: Dat die Huis met groot kommer kennis neem van die vermindering van die Wes-Kaapse provinsiale billike deel (“provincial equitable share” of PES) se Gesondheidskomponent; kennis neem dat, wanneer die Wes-Kaapse Departement van Gesondheid en Welstand tuisversorging aan ons mees behoeftige burgers verskaf, hierdie sorg glad nie in PES-berekening in ag geneem word nie; die stelsel verwerp wat bekwame regerings penaliseer omdat hulle die belange van die mense dien en onbevoegde regerings met bykomende befondsing beloon; en kennis neem dat die PES-formule gebrekkig is en hersien moet word om te verseker dat die Wes-Kaap sy billike deel ontvang en kan voortgaan om gehatedienste aan die mense van hierdie provinsie te verskaf.
3. Mnr T M Klaas: Dat die Huis kennis neem dat die Zwelihle- openbare kliniek by Hermanus op die randjie van ineenstorting is omdat hy versuim om sy diensleweringsovername uit te voer; kennis neem dat die kliniek daagliks lang rye ervaar en die meerderheid van hierdie pasiënte deur die personeel by die kliniek weggewys word as gevolg van onvoldoende personeel by die fasiliteit; kennis neem dat verpleegkundiges en personeel by die kliniek kla dat hulle oorwerk is en nie in staat is om na elke pasiënt om te sien nie, aangesien die Wes-Kaapse Departement van Gesondheid en Welstand nie nog personeel wil aanstel om pasiënte by die kliniek by te staan nie; ’n beroep op die Wes-Kaapse Minister van Gesondheid doen om dringend aan hierdie kwessie aandag te skenk en ook seker te maak dat ons klinieke het wat 24/7 oop is; en kennis neem dat stede, soos Ekurhuleni in Gauteng, klinieke het wat 24 uur lank van Maandag tot Saterdag oop is, terwyl die Wes-Kaapse Departement van Gesondheid en Welstand die meeste van sy tyd bestee om met skoon oudits te spog en nie op pasiënte se behoeftes te reageer nie.
4. Mnr C M Dugmore: Dat die Huis me Desiree Ellis, wat van die Wes-Kaap afkomstig is, gelukwens met haar ontvangs van die nasionale orde, die Orde van Ikhamanga (Goud), vir haar volgehoue aanmoediging en bevordering van vroue om sukses op hul onderskeie terreine te behaal nadat sy self uitstekend bygedra het tot die veld van sokker; en verder die jarelange ANC-aktivis en -lid, Keith Gottschalk, gelukwens met sy ontvangs van dieselfde orde, maar in silwer; kennis neem dat mnr Gottschalk, soos die aanprysing aandui, “sy kreatiwiteit gebruik het om kritiese aandag op onderdrukkende en onregverdige wette te vestig deur performatiewe politieke poësie; werk wat baie gemotiveer het om te veg vir bevryding”, terwyl sommige aan die ander kant van hierdie Huis die apartheidstelsel ondersteun het.
5. Me A P Bans: Dat die Huis kennis neem van en geskok is oor die besluit wat die Stad geneem het om nie die straatbeligting langs Baden Powell-rylaan in Strandfontein te vervang nie; kennis neem dat die gebied ’n misdadaatoneel geword het sedert die ligte in daardie gebied afgegaan het; kennis neem dat lyke feitlik daagliks gevind word, en dat motoriste gekeer en aangerand word; kennis neem dat die Strandfontein-misdadbestryders (GPF) belowe het om die Stad die stryd aan te sê vir sulke nalatigheid

aangesien Dan Plato, die voormalige burgemeester, belowe het om beligting op die berugte kuspadd te verbeter en nou weier die Stad deur aan te voer dat die vervanging van straatliglampe weens die herhaalde voorvalle van vandalisme en die voortgesette vervanging van infrastruktuur op hierdie tydstip nie haalbaar nie; en eis dat die Stad die ligte moet regmaak, aangesien dit 'n gevaar vir die samelewing inhou.
