### NOTICE OF MOTIONS

1. Mr R D Mackenzie moved: That the House notes that during the debate on the State of the Province Address, the honourable Mr Fransman alleged that –
  - (i) the Premier of the Western Cape led a walkout of Members during the State of the Nation Address on 12 February;
  - (ii) employment equity has regressed to the extent that 72% of senior management in the Public Sector in the Western Cape are white;
  - (iii) 1000 children in Mitchells Plain are not in class and thousands are struggling to get access to schools;
  - (iv) hundreds of children in Kraaifontein were not in class;
  - (v) school learners in Gugulethu did not receive their books by February 2015;
  - and

therefore resolves that an ad hoc committee be appointed to investigate whether Mr Fransman deliberately misled the House in making the above statements, the committee to have the power to take evidence and call for papers.
2. Mr M L Fransman moved: That the House debates institutionalised forums of racism under the DA provincial government in the Western Cape.
3. Mr R T Olivier moved: That the House debates the disconcerting flaws in the school transport system of the province under this DA government and the bakkie system used especially by students in the townships.
4. Mr M N Paulsen moved: proposes that we end the on-going separation of members and staff in this legislature. We work together, we dine together as equals.
5. Ms M M Wenger moved: That the House debates mandatory debriefings for law enforcement agencies to assist with managing stressful and traumatic events.
6. Ms D Gopie moved: That the House debates the provincial government's lack of results, long queues and the bad attitudes of staff at health facilities across the province.
