Mr B D Joseph: Women and children are constantly at the receiving end of abuse caused by societal challenges and badly managed economic, natural and sociopolitical disasters.

The Leader of the Opposition – Mr K E Magaxa: That the House has no confidence in the Premier.

1. Ms B A Schäfer: That the House debates the impact of the fourth industrial revolution on job creation in the Western Cape.
2. Ms D Gopie: That the House debates the risk of gentrification on the heritage of historic sites in the province, like the coveted Bo-Kaap.
3. Ms P Makeleni: That the House debates the need for a commission of inquiry into child killings in the province.
4. Mr B D Kivedo: That the House debates the impact of the damage caused by the recent storms and fires to 172 schools in the Western Cape and the Reconstruction Plan of the WCED, while taking cognisance of budget constraints.
5. Mr R D Mackenzie: That the House debates the impact of the equitable share of the national budget not being distributed equitably to South Africa's provinces.

6. Mr R T Olivier: That the House debates the sanitation crisis in schools around the Western Cape.
7. Mr R D Mackenzie: That the House debates the impact of early childhood development organisations, as funded by the government, on our communities.
8. Mr M Mnqasela: That the House debates the impact of meritocracy on the public sector and on its benefit on good governance.
9. Mr R D Mackenzie: That the House debates the impact of corruption on job creation.
10. Mr R D Mackenzie: That the House debates the measures the Western Cape Government has introduced to curb unemployment in comparison with the national government.
11. Mr R D Mackenzie: That the House debates the impact of unfunded mandates on provinces and municipalities.

Mr N E Hinana: That the House condemns the acts of criminality, the burning of a MyCiti bus on Tuesday in Dunoon and the burning of the community hall in Phoenix in Milnerton; and calls on the City of Cape Town and all law enforcement agencies to do everything in their power to bring the perpetrators to book.
13. Ms D Gopie: That the House notes that the initiation season has started; wishes the boys who will be going through this rite of passage well; and calls on the Western Cape Government to stop undermining this important tradition of the AmaXhosa (Xhosa people).
14. Mr S G Tyatyam: That the House condemns the regrettable involvement of Wesgro in cheap politics; reminds the entity that it is only an investment arm of the government and does not need to be involved in politics; and calls on the relevant authorities to ensure that this is not repeated.
15. Mr R T Olivier: That the House notes with grave regret the outbreak of violent protests – partly caused by the provincial government’s unwillingness to consult meaningfully with residents in poor townships – in Joe Slovo; and calls on the Western Cape Government to come up with meaningful strategies to engage with communities in order to prevent the recurrence of such violent protests.
16. Mr R T Olivier: That the House notes with concern that about 400 learners at the Khozi Primary School have not receive formal education this year as the WCED had declared their school illegal; and calls on the SAHRC to investigate whether the rights of these children were not infringed upon.
17. Mr S G Tyatyam: That the House notes that the ANC yesterday was victorious in the West Rand local municipality of Mogale City and that the DA and EFF coalition’s mayor was rejected; and congratulates the ANC on winning this municipal leadership election.
18. Ms P Makeleni: That the House condemns the suspension of Ronelle Prins (30) from Strandfontein, a dispatch clerk at Pinnacle, because her bosses thought her shoulder-length curls were not professional enough; and call on relevant authorities to intervene urgently in this matter.
