NOTICES OF MOTION (27 July 2023)

1. Ms N G Bakubaku-Vos: That the House debates the Western Cape's Growth for Jobs Strategy.
2. Ms R Windvogel: That the House debates the wasteful R12 million spent in the past three months on 200 healthcare facilities that have not been exempted from load-shedding in the Western Cape.
3. Mr L L Mvimbì: That the House debates Cape Town's housing crisis.
4. Mr M K Sayed: That the House debates the financial breakdown of the Western Cape Government's budget to improve safety and security at schools in the next five years.

NOTICES OF MOTION (20 July 2023)

1. Mr M I Sileku: That the House notes the results of last night's by-elections, 19 July 2023, that took place in George; acknowledges that the DA prevailed victoriously at these by-elections, despite many attempts by opposition parties to derail our campaign efforts; notes that the by-elections were hotly contested in wards 16, 20 and 27, of which the DA won wards 16 and 27, and significantly increased its support in ward 20; notes that, in ward 16, the DA more than doubled its support; further notes that these wards are now in the capable hands of Theresa Jeyi and Marchell Kleynhans, and we are confident that they will serve their respective communities with passion and integrity; and notes that the GOOD party truly is in crisis, as they have lost three of their wards in one day.
2. Ms C A T Murray: That the House notes with approval the withdrawal of Vladimir Putin from the BRICS Summit to be held in South Africa; notes that Mr Putin, the accused war criminal, should never have been allowed access to a free and democratic nation such as South Africa; notes that this development has given a major boost to South Africa's chances of being included in the renewal of the African Growth and Opportunity Act; recognises that President Cyril Ramaphosa showed no sense of justice in handling this matter and proved himself to be beholden to Russian rather than to South African interests; and notes that the Western Cape Government took a clear position on this matter by vowing to arrest Mr Putin were he to set foot in the Western Cape.
3. Ms C A T Murray: That the House notes the tremendous achievement of the City of Cape Town in being named the Greatest City in the World in the *Telegraph*'s 2023 Travel Awards; further notes that this is a well-deserved accolade for one of the most beautiful cities in the world; also notes that this will provide a boost to our booming tourism industry, which is the source of thousands of jobs in the city; and recognises the successful efforts of the City of Cape Town Metropolitan Municipality, the Western Cape Department of Economic Development and Tourism and Wesgro in promoting the city as an international travel destination.
4. Ms N D Nkondlo: That the House notes the City of Cape Town's 17,6% electricity tariff hike, a hike that is 2% more than the increase approved by the National Energy Regulator of South Africa (Nersa), which is an odd contradiction in the provincial government, proving yet again how the DA is not in synchronisation; notes that, in March this year, Cape Town Mayor Geordin Hill-Lewis said that Eskom's Nersa-approved 18,49% price hike is unfair, unaffordable and unjust for residents struggling with the rising cost of living, but four months later the City of Cape Town is fighting tooth and nail for an increase over the agreed one; and calls for the DA government to sort out its house and stop playing with the livelihoods of our citizens as 17,6% is too much for people to be paying.
5. Mr M K Sayed: That the House notes the provincial government's plan to convert the Tafelberg Crèche into a homeless shelter, while the community's advocacy for a much-needed and called-for community centre is instead supported; notes that, while we acknowledge the importance of addressing homelessness, we believe that the proposed utilisation of the Tafelberg Crèche in particular is not suitable and other unused provincial government buildings in the city bowl should seriously be considered; notes that, instead, we advocate for the conversion of the Tafelberg Crèche into a community centre, which will serve as a hub for the residents to engage in educational, cultural and

recreational activities; notes that a community centre will foster a sense of belonging and unity, offering a safe space for residents of all ages to come together, share ideas, and develop strong social ties; and calls on the Western Cape Government to consider this alternative approach and to work collaboratively with the community to realise a vision that empowers, uplifts and enriches the lives of its residents while at the same time providing dignity to the homeless.

6. Mr M Kama: That the House strongly opposes the City of Cape Town's decision to cancel the lease agreement with the Gugulethu Sports and Development Trust for a piece of land used for sport and recreation; notes that the City's actions have sparked widespread anger and condemnation from the community, who have utilised the facility for decades; notes that, while the need for a health facility is understood, disposing of this historic sport and recreation centre without adequate public consultation is unfair and disrespectful; supports the community's efforts to reverse this decision; and calls for meaningful engagement with stakeholders before deciding the facility's future as the City's approach has alienated the people of Gugulethu and the decision must be reconsidered.
7. Ms P Z Lekker: That the House vehemently condemns the Democratic Alliance (DA) in the Western Cape for its silence and lack of accountability regarding the serious accusations of voter-registration fraud during this week's by-elections in George; notes that, as a pillar of democracy, political parties must uphold the principles of fairness, transparency and the integrity of electoral processes; notes that the allegations of voter-registration fraud raise grave concerns about the democratic process and the protection of citizens' voting rights; calls on the DA to address these accusations promptly and to cooperate fully with investigations to ensure the credibility and legitimacy of the electoral outcomes; notes that the failure to do so erodes public trust in the democratic system and undermines the foundation of our democratic governance; notes that it is the duty of the DA to be transparent and to uphold the highest standards of ethical conduct in order to ensure that the people's voices are heard and respected; and demands accountability and transparency in this matter in order to safeguard the fundamental tenets of democracy for the benefit of all citizens.

KENNISGEWING VAN VOORSTELLE (27 Julie 2023)

1. Me N G Bakubaku-Vos: Dat die Huis die Wes-Kaapse Strategie vir Werkgeleenthede deur Groei (“Growth for Jobs Strategy”) debatteer.
2. Me R Windvogel: Dat die Huis die verkwistende besteding in die afgelope drie maande van R12 miljoen aan 200 gesondheidsorgfasiliteite wat nog van beurtkrag in die Wes-Kaap vrygestel is nie, debatteer.
3. Mnr L L Mvimbi: Dat die Huis die behuisingskrisis in Kaapstad debatteer.
4. Mnr M K Sayed: Dat die Huis die finansiële ontleding van die begroting van die Wes-Kaapse Regering om veiligheid en sekuriteit by skole in die volgende vyf jaar te verbeter debatteer.

KENNISGEWING VAN VOORSTELLE (22 Junie 2023)

1. MnR M I Sileku: Dat die Huis kennis neem van die uitslag van gisteraand, 19 Julie 2023, se tussenverkiesing wat in George plaasgevind het; daaraan erkenning gee dat die DA by hierdie tussenverkiesings gesêvier het, ten spyte van baie pogings deur opposisieparty om ons veldtoggings te ontspoor; kennis neem dat die tussenverkiesings sterk betwis is in wyk 16, 20 en 27, waarvan die DA wyk 16 en 27 gewen het, en sy steun in wyk 20 aansienlik vergroot het; kennis neem dat die DA in wyk 16 sy steun meer as verdubbel het; verder kennis neem dat hierdie wyke nou in die bekwame hande van Theresa Jeyi en Marchell Kleynhans is, en ons is vol vertroue dat hulle hul onderskeie gemeenskappe met passie en integriteit sal dien; en kennis neem dat die party GOOD werklik in 'n krisis verkeer, aangesien hulle drie van hul wyke op een dag verloor het.
2. Me C A T Murray: Dat die Huis met goedkeuring kennis neem van die onttrekking van Wladimir Poetin aan die BRICS-beraad wat in Suid-Afrika gehou gaan word; kennis neem dat mnR Poetin, die beskuldigde oorlogsmisdadiger, nooit toegang tot 'n vrye en demokratiese nasie soos Suid-Afrika toegelaat moes geword het nie; kennis neem dat hierdie ontwikkeling 'n groot hupstoot gegee het aan Suid-Afrika se kanse om by die hernuwing van die Wet op Groei en Geleenthede in Afrika ingesluit te word; erken dat President Cyril Ramaphosa geen sin vir geregtigheid getoon het in die hantering van hierdie aangeleentheid nie en bewys het dat hy aan Russiese eerder as aan Suid-Afrikaanse belang gehoor gee; en kennis neem dat die Wes-Kaapse Regering 'n duidelike standpunt oor hierdie aangeleentheid ingeneem het deur te onderneem om mnR Poetin in hegtenis te neem indien hy sy voete in die Wes-Kaap sou sit.
3. Me C A T Murray: Dat die Huis kennis neem van die uitstekende prestasie van die Stad Kaapstad om as die beste stad ter wêreld ("Greatest City in the World") in die *Telegraph* se 2023-reistroekennings aangewys te word; verder kennis neem dat dit 'n welverdiende toekenning is vir een van die mooiste stede ter wêreld; ook kennis neem dat dit 'n hupstoot sal gee aan ons bloeiende toerismebedryf, wat die bron van duisende werkgeleenthede in die stad is; en erkenning gee aan die suksesvolle pogings van die Stad Kaapstad-metropolitaanse munisipaliteit, die Wes-Kaapse Departement van Ekonomiese Ontwikkeling en Toerisme en Wesgro om die stad as 'n internasionale reisbestemming te bevorder.
4. Me N D Nkondlo: Dat die Huis kennis neem van die Stad Kaapstad se elektrisiteitstariefverhoging van 17,6%, 'n verhoging wat 2% meer is as die verhoging wat deur die Nasionale Energiereguleerde van Suid-Afrika (Nersa) goedgekeur is, wat 'n vreemde teenstrydigheid in die provinsiale regering is, wat weereens bewys hoe die DA nie sinchroniseer nie; kennis neem dat Kaapstad se burgemeester, Geordin Hill-Lewis, in Maart vanjaar gesê het dat Eskom se Nersa-goedgekeurde prysverhoging van 18,49% onbillik, onbekostigbaar en onregverdig is vir inwoners wat sukkel met die stygende lewenskoste, maar vier maande later veg die Stad Kaapstad hand en tand vir 'n verhoging bo die ooreengekome een; en 'n beroep op die DA-regering doen om sy huis in orde te kry en op te hou om met die lewensbestaan van ons burgers te speel, aangesien 17,6% te veel is vir mense om te betaal.
5. MnR M K Sayed: Dat die Huis kennis neem van die provinsiale regering se plan om die Tafelberg-crèche in 'n skuiling vir haweloses te omskep, terwyl die gemeenskap se beywering vir 'n broodnodige en versoekte gemeenskapsentrum eerder ondersteun word;

kennis neem dat, alhoewel ons die belangrikheid daarvan erken om aandag aan haweloosheid te skenk, ons glo dat die voorgestelde benutting van die Tafelberg-crèche in die besonder nie geskik is nie en dat ander ongebruikte provinsiale regeringsgeboue in die stadskom ernstig oorweeg moet word; kennis neem dat ons eerder pleit vir die omskepping van die Tafelberg-crèche in 'n gemeenskapsentrum, wat sal dien as 'n middelpunt vir die inwoners om by opvoedkundige, kulturele en ontspanningsaktiwiteite betrokke te raak; kennis neem dat 'n gemeenskapsentrum 'n gevoel van samehorigheid en eenheid sal bevorder, wat 'n veilige ruimte sal bied vir inwoners van alle ouderdomme om blymekaar te kom, idees uit te ruil en sterk sosiale bande te ontwikkel; en 'n beroep op die Wes-Kaapse Regering doen om hierdie alternatiewe benadering te oorweeg en om saam met die gemeenskap te werk om 'n visie te verwesenlik wat die lewens van sy inwoners bemagtig, ophef en verryk en terselfdertyd waardigheid aan haweloses verskaf.

6. Mn M Kama: Dat die Huis die Stad Kaapstad se besluit sterk teenstaan om die huurooreenkoms met die Gugulethu Sports and Development Trust vir 'n stuk grond wat vir sport en ontspanning gebruik word, te kanselleer; kennis neem dat die Stad se optrede wydverspreide woede en veroordeling van die gemeenskap, wat die fasilitet al vir dekades gebruik, ontlok het; kennis neem dat, alhoewel die behoefté aan 'n gesondheidsfasilitet verstaan word, dit onregverdig en oneerbiedig is om weg te doen met hierdie geskiedkundige sport- en ontspanningsentrum sonder voldoende openbare oorlegpleging; die gemeenskap se pogings om hierdie besluit om te keer ondersteun; en 'n beroep doen vir betekenisvolle skakeling met belanghebbendes voordat daar oor die fasilitet se toekoms besluit word, aangesien die Stad se benadering die mense van Gugulethu vervreem het en die besluit heroorweeg moet word.
7. Me P Z Lekker: Dat die Huis die Demokratiese Alliansie (DA) in die Wes-Kaap ten sterkste veroordeel vir sy stilswye en gebrek aan verantwoordingpligtigheid oor die ernstige beskuldigings van kiesersregistrasiebedrog tydens vandeelsweek se tussenverkiesing in George; kennis neem dat, as 'n steunpilaar van die demokrasie, politieke partye die beginsels van regverdigheid, deursigtigheid en die integriteit van die verkiesingsprosesse moet handhaaf; kennis neem dat die bewerings van kiesersregistrasiebedrog ernstige kommer wek oor die demokratiese proses en die beskerming van burgers se stemreg; 'n beroep op die DA doen om onmiddellik aan hierdie beskuldigings aandag te skenk en om ten volle met ondersoekte saam te werk om die geloofwaardigheid en legitimiteit van die verkiesingsuitslag te verseker; kennis neem dat die versuum om dit te doen, die publiek se vertroue in die demokratiese stelsel erodeer en die grondslag van ons demokratiese regering ondervind; kennis neem dat dit die DA se plig is om deursigtig te wees en om die hoogste standarde van etiese gedrag te handhaaf ten einde te verseker dat die mense se stemme gehoor en gerespekteer word; en verantwoordingspligtigheid en deursigtigheid in hierdie aangeleentheid eis om die grondbeginsels van die demokrasie tot voordeel van alle burgers te beskerm.
