## MOTIONS

- 1. The Chief Whip of the Majority Party (Ms L J Botha): That, in terms of section 6(3)(*b*) of the Remuneration of Public Office Bearers Act, 1998 (Act 20 of 1998), the upper limits of the salary and allowances of the Premier of the Western Cape, as proclaimed by the President of the Republic of South Africa by Proclamation No 67 of 2022, published in *Government Gazette* No 46545, dated 14 June 2022, be determined as the salary and allowances of the Premier of the Western Cape with effect from 1 April 2021.
- 2. The Chief Whip of the Majority Party (Ms L J Botha): That the House, noting:
  - 1. The report of the Conduct Committee published in the ATC on 2 June 2022;
  - 2. That the Speaker is the subject of the Committee's enquiry;
  - 3. The intention by the Speaker to appeal against the penalty recommended by the Committee;
  - 4. That, in accordance with paragraph 18 of the Code of Conduct, a member who is the subject of a conduct investigation must recuse himself or herself from the deliberations of the Committee;
  - 5. The Speaker's recusal from the Appeals Committee, as contemplated in paragraph 18 of the Code of Conduct, affects the composition, chairpersonship and the procedure of the Appeals Committee as far as it pertains to the submission to the Appeals Committee of an appeal stipulating the basis for the appeal; and
  - 6. That the Code of Conduct is silent on matters where the Speaker, as the Chairperson of the appeals structure, is the subject of the Conduct Committee's enquiry and wishes to appeal a recommendation of the Conduct Committee,

Therefore resolves that:

- 1. The Hon F C Christians be appointed to serve on the Appeals Committee and that the Hon F C Christians be appointed as Chairperson of the Appeals Committee for the duration of its deliberations on the above-mentioned enquiry;
- 2. The Speaker submit his written submissions stipulating the basis for his appeal to the Chairperson of the Appeals Committee; and
- 3. The Conduct Committee, assisted by the Secretary to Parliament, be instructed to review the Code of Conduct and make recommendations to the House on the membership of the Appeals Committee, the recusals of members from the Appeals Committee who are subjects of Conduct Committee enquiries, and other matters incidental thereto.

Mr M Xego: That the House condemns the continued threats by the Drakenstein Municipality's Mayor to the Minister of COGTA over the intended legal action regarding a municipal manager who should have retired a long time ago, but stayed on with the intention to cash in on bigger pension money; notes that this follows the actions of the Municipality in allowing a 65-year-old municipality manager, Johan Leibrandt, to stay on as manager beyond the six-month extension period he was granted by the Minister of COGTA; notes that, now that COGTA refuses to pay his retirement for the unaccounted years, the Municipality is threatening court action in order to make sure that their white friend cashes in with a hefty pay-out; and notes that it would be unfortunate if this matter goes to court, because this would be tax payers' money that will be used, money that should be spend on service delivery for the poor and not on some old white man who should have retired a long time ago.
