Mr K E Magaxa: The recent Singapore tweets by the Premier – The public response and the ramifications thereof.

FURTHER BUSINESS

NOTICE OF MOTIONS

- 1. Mr R T Olivier: That the House deliberates on the various cases of collusion by contractors and price fixing of tenderers or corrupt companies under the DA's rule, which amounts to bribery, kickbacks and donations to DA leaders and the DA.
- 2. Mr M Mnqasela: That the House debates the ANC's obsession with causing chaos and instability in local governments in the Western Cape, and the party's perceptible disposition to violence and rampant corruption.
- 3. Mr K E Magaxa: That the House debates the Premier's belief that the majority of murders and assaults in the province is not perpetrated by white people against black people.
- 4. Mr R T Olivier: That the House debates the admission policies of Western Cape schools and the impact this has on the persistent late enrolment of learners in school and on related problems encountered by parents.
- 5. Mr R T Olivier: That the House debates the overcrowding in school in the Western Cape.

- 6. Mr R T Olivier: That the House debates the increases in bullying incidents in schools in the province, its ramifications and the failures if the Western Cape Education Department to deal with the problem.
- 7. Ms M N Gillion: That the House debates the increase in unnatural and other deaths in the Western Cape as recorded in the 2015 Report on Mortality and Causes of Death in South Africa.
- 8. Mr D G Mitchell: That the House condemns the abusive behaviour of Beaufort West ANC Councillor Evelyn Lawrence who aggressively assaulted a female journalist from *Die Courier*.
- 9. Mr K E Magaxa: That the House:
 - (a) noting that South Africa celebrates 20 years since the adoption of the Constitution and the establishment of the National Council of Provinces this year;
 - (b) further noting that the Western Cape Legislature has not done anything tangible to commemorate this national event;
 - (c) notes that it was the DA that removed a display on the evolution of our Constitution from the lobby of the Legislature and now hides it in a passage on the seventh floor; therefore
 - proves that the DA only pays lip service in pledging loyalty to and reverence for the Constitution.
- 10. Ms L M Maseko: That the House congratulates MPL Masizole Mnqasela on being acknowledged and recognised by an online magazine, Avance Media, as one of the 100 most influential young South Africans for 2016, and notes that this achievement represents his service to humanity and an outstanding commitment to influencing change and creating a better South Africa.
- 11. Mr K E Magaxa: That the House notes that the national Anti-racism Week starts on Tuesday, calls on the Western Cape Government to disclose any programmes it may present to advance social cohesion and to speak out against growing intolerance under the DA's rule.
- 12. Ms S W Davids: That the House notes that the Premier is again touring abroad and that the trip to Singapore coincides with her birthday, calls on the Premier to report urgently to this House on her overseas trips.
- 13. Mr R T Olivier: That the House, noting that the DA-run Cape Town Municipality still employs a company found guilty of collusion and price fixing, further notes that another questionable company was also employed by the provincial Department of Transport and Public Works until 2016 after its corrupt practises were uncovered in 2014, calls on the Cape Town Municipality to terminate its continued contract immediately.
- 14. Ms S W Davids: That the House institutes an urgent inquiry into Premier Zille's use of government staff, time and resources in writing her memoirs for which she receives royalties, including a forensic audit of all IT equipment that could have been involved.
- 15. Ms M N Gillion: That the House notes with concern the ordeal of Graham van der Hoven (59), who was admitted to Groote Schuur Hospital, robbed after being discharged from the hospital and told to find his way to a shelter in Green Point, further noting that this government, which had been grandstanding on the Esidimeni issue, is failing to protect people suffering from mental illnesses, condemns the government for negligence and calls on the Legislature to investigate this matter.

16. Mr M Mnqasela: That the House condemns the ANC's insatiable appetite for corruption and maladministration in the Western Cape and their insistence on destroying the Kannaland Municipality and causing instability and distress in the communities in Ladismith, Calitzdorp and Vanwyksdorp.
