### **FURTHER BUSINESS**

#### **NOTICES OF MOTION**

1. Ms D M Baartman: That the House debates the impact of the COVID-19 pandemic and the COVID-19 regulations on the Western Cape economy, and efforts to save jobs.
2. Ms R Windvogel: That the House, having noted recent developments in the province – including over 10 000 COVID-19 cases, 183 deaths and 440 people in hospital, of which 128 are in ICU or high care – urgently debates the handling of COVID-19 outbreak by the Western Cape Government.
3. Mr R I Allen: That the House debates the influx of cases of police brutality and heavy-handedness in the enforcement of the lockdown regulations, and the impact it has on the residents of the Western Cape.

4. Mr A P van der Westhuizen: That the House debates the impact of COVID-19 on food security in the Western Cape, and the regulations made and support provided in this regard.
5. Mr L L Mvimbì: That the House notes with concern and condemns with the strongest contempt the reckless utterances by Bonginkosi Madikizela, DA provincial leader, who on Sunday called for the province to be moved down to level 3 because the number of infections in the Western Cape occurred under level 5 and 4 of the lockdown, that death is something that will visit all of us at some stage, and that we can't stop living our lives because we are scared; and debates the calls for the province to move down to level 3.
6. Mr P J Marais: That the House debates the efficacy and sustainability of the Cape Agency for Sustainable Integrated Development in the Rural Areas (Casidra) with special emphasis on job creation, food security and the empowerment of emerging farmers; and considers requesting a thorough investigation by the Western Cape Service Commission in this regard and asks that its report be tabled in this House within six months.
7. Ms P Z Lekker: That the House debates the many successes by the SAPS in its battle with abalone and marine poaching in the Western Cape.
8. Ms A Bans: That the House discusses the failure of the Western Cape Department of Social Development to maintain safe social distances between poor visitors in and around its offices.
9. Mr G Bosman: That the House condemns the national Department of Social Development's attempt to centralise the distribution of cooked food and to control nutrition programmes being run in communities across the country; and further notes that the South African Human Rights Commission (SAHRC) has labelled this a violation of human rights after the Democratic Alliance lodged a complaint against the national Department.
10. Ms A Bans: That the House notes that the Central Karoo District Municipality flouts honourable Minister Anton Bredell's instruction to host virtual video meetings, that DA mayor Annelie Rabie calls regular contact meetings and rakes in subsistence and travel allowance by almost daily commuting between Prince Albert and Beaufort West; and calls on the Minister to investigate and urgently report to the legislature on this matter.
11. Mr R I Allen: That the House notes the commemoration of the International Day against Homophobia, Transphobia and Biphobia on 17 May 2020; and supports events to raise awareness of the violation of LGBT rights in the Western Cape.
12. Ms R Windvogel: That the House notes the overloading of hospitals and health staff's large workloads due to the serious COVID-19 contamination; and requests that honourable Minister Nomafrench Mbombo reports to this legislature on the current situation and readiness ahead of a possible upsurge in cases.

13. Ms N D Nkondlo: That the House notes and laments the poor services delivered to informal traders in townships and the absence of an inclusive database of all informal traders in the City of Cape Town despite the City having the highest concentration of informal traders in the province; notes further that this has led to the exclusion of and difficulties for informal traders to trade with businesses for essential services and goods during the lockdown as the City, supported by this provincial government, flatly refused to issue permits to these traders as the City chose those to whom it referred to as “suitably vetted” pre-COVID-19; condemns this practice as it further entrenches the inequality that exists in this province and as it further perpetuates the inequality by keeping informal traders out of the economy with such abuse and misuse of regulations; and calls for enhanced efforts, similar to the City’s and DEDAT’s investments in urban markets, such as in Sea Point, Woodstock and in the CBD.
14. Mr M K Sayed: That the House notes that Roberto Quintas, ward councillor of Hout Bay, has downplayed Hout Bay as a COVID-19 hotspot as identified by the Western Cape Government; and notes that he actually undermined the Premier and the provincial government by releasing a statement stating that the provincial government provided the wrong statistics for Hout Bay.

#### VERDERE WERKSAAMHEDE

#### VOORSTELLE MET KENNISGEWING

1. Me D M Baartman: Dat die Huis die impak van die COVID-19-pandemie en die COVID-19 regulasies op die Wes-Kaapse ekonomie, en pogings om werkgeleenthede te red, debatteer.
2. Me R Windvogel: Dat die Huis, nadat kennis geneem is van onlangse ontwikkelings in die provinsie – insluitende meer as 10 000 COVID-19-gevalle, 183 sterftes en 440 mense in hospitale, waarvan 128 in intensiewesorg- of hoësorgeneenhede is – dringend die Wes-Kaapse Regering se hantering van die uitbreek van COVID-19 debatteer.
3. Mnr R I Allen: Dat die Huis die toestroom van gevalle van polisiebrutaliteit en - hardhandigheid met die toepassing van inperkingsregulasies, en die impak wat dit op die inwoners van die Wes-Kaap het, debatteer.

4. MnR A P van der Westhuizen: Dat die Huis die impak van COVID-19 op voedselsekerheid in die Wes-Kaap, en die regulasies gemaak en ondersteuning verskaf in hierdie verband, debatteer.
5. MnR L L Mvimbì: Dat die Huis met kommer kennis neem van en met die sterkste minagting die roekeloze uitlatings veroordeel van Bonginkosi Madikizela, DA-provinsiale leier, wat Sondag 'n beroep gedoen het vir die provinsie om na vlak 3 te skuif as gevolg van die getal infeksies wat in die Wes-Kaap tydens vlak 5 en vlak 4 van die inperking voorgekom het, dat die dood iets is wat vir ons almal op 'n sekere tydstip wag, en dat ons nie kan ophou om ons lewens te leef omdat ons bang is nie; en beroepe vir die provinsie om na vlak 3 te skuif, debatteer.
6. MnR P J Marais: Dat die Huis die doeltreffendheid en volhoubaarheid van die Kaapse Agentskap vir Volhoubare, Geïntegreerde Ontwikkeling in Landelike Gebiede (Kavolg), met spesifieke nadruk op werkskepping, voedselsekerheid en die bemagtiging van ontluikende boere, debatteer; en oorweeg om 'n deeglike ondersoek in hierdie verband deur die Wes-Kaapse Dienskommissie aan te vra en te vra dat sy verslag binne ses maande in hierdie Huis ter tafel gelê word.
7. Me P Z Lekker: Dat die Huis die SAPD se talle suksesse in sy stryd teen perlemoen- en mariene stropery in die Wes-Kaap debatteer.
8. Me A Bans: Dat die Huis die nalating van die Wes-Kaapse Departement van Maatskaplike Ontwikkeling om veilige sosiale afstande tussen arm besoekers by en om sy kantore te handhaaf, bespreek.
9. MnR G Bosman: Dat die Huis die nasionale Departement van Maatskaplike Ontwikkeling se poging om die verspreiding van gaargemaakte kos te sentraliseer en beheer uit te oefen oor voedingsprogramme wat deur gemeenskappe dwarsoor die land bedryf word, veroordeel; en verder kennis neem dat die Suid-Afrikaanse Menseregtekommisie (SAMRK) dit as 'n skending van menseregte beskryf het nadat die Demokratiese Alliansie 'n klagte teen die nasionale Departement ingedien het.
10. Me A Bans: Dat die Huis kennis neem dat die Sentraal-Karoo-distriksmunisipaliteit agbare Minister Anton Bredell se instruksie om virtuele vergaderings aan te bied, verontgasaam deurdat DA-burgemeester Annelie Rabie gereeld kontakvergaderings belê en verblyf- en reistoelaes invorder omdat sy feitik daagliks tussen Prins Albert en Beaufort-Wes pendel; en 'n beroep op die Minister doen om ondersoek in te stel en dringend aan die wetgewer oor hierdie aangeleentheid verslag te doen.
11. MnR R I Allen: Dat die Huis kennis neem van die herdenking van die Internasionale Dag teen Homofobie, Transfobie en Bifobie op 17 Mei 2020; en geleenthede wat bewustheid oor die skending van LGBT-regte in die Wes-Kaap aanwakker, ondersteun.
12. Me R Windvogel: Dat die Huis kennis neem van die oorlaai van hospitale en gesondheidspersoneel se groot werkladings tydens die ernstige COVID-19-besmetting; en versoek dat agbare Minister Nomafrench Mbombo aan hierdie wetgewer oor die huidige situasie en gereedheid vir 'n moontlike styging in gevalle verslag doen.

13. Me N D Nkondlo: Dat die Huis kennis neem van en die slegte dienste wat aan informele handelaars in informele nedersettings gelewer word en die afwesigheid van 'n inklusiewe databasis van alle informele handelaars in die Stad Kaapstad, ten spyte daarvan dat die Stad die hoogste konsentrasie van informele handelaars in die provinsie het, betreur; verder kennis neem dat dit tot uitsluiting en moeilikheid vir informele handelaars gelei het om met sakeondernemings tydens die inperkingstydperk vir noodsaklike dienste en goedere handel te dryf omdat die Stad, met die ondersteuning van hierdie provinsiale regering, botweg geweier het om permitte aan hierdie handelaars uit te reik aangesien die Stad diegene verkies het na wie die Stad as "behoorlik gekontroleer" voor COVID-19 verwys het; hierdie praktyk veroordeel omdat dit die ongelykheid verskans wat in hierdie provinsie voorkom en omdat dit die ongelykheid voortsit deur informele handelaars met sodanige misbruik en wanaanwending van regulasies buite die ekonomie hou; en 'n beroep doen vir verbeterde pogings, soortgelyk aan die Stad en die Departement van Ekonomiese Ontwikkeling en Toerisme (DEDAT) se beleggings in stedelike markte, soos by Seepunt, Woodstock en in die SSG.
14. MnR M K Sayed: Dat die Huis kennis neem dat Roberto Quintas, wyksraadslid van Houtbaai, die identifisering van Houtbaai as 'n COVID-19-brandpunt deur die Wes-Kaapse Regering as onbelangrik afgemaak het; en kennis neem dat hy in werklikheid die Premier en die provinsiale regering ondermyn het deur 'n verklaring uit te reik wat aanvoer dat die provinsiale regering die verkeerde statistiek vir Houtbaai verstrek het.
