**ORDERS OF THE DAY**

1. Consideration of Report of the Standing Committee on Finance on its oversight visit to Kenilworth dated 19 April 2017 (See Announcements, Tablings and Committee Reports, p 266, dated 4 September 2017).
2. Consideration of Report of the Standing Committee on Transport and Public Works on its oversight visit to the George Provincial Traffic Centre, the George Municipality and George Link (Pty) Ltd dated 25 July 2017 (See Announcements, Tablings and Committee Reports, p 280, dated 14 September 2017).

**MOTIONS (Continued)**

1. The Chief Whip: That notwithstanding the provision of Rule 18, the hours of sitting on Friday, 29 September 2017 shall be: 09:00 to adjournment.
2. Mr M G E Wiley: That an ad hoc committee be established to investigate and report whether the honourable members as indicated deliberately misled the House during the sittings of the House on 4 May 2017 (Leader of the Opposition and Member Dugmore) and 24 August 2017 (Leader of the Opposition and Member Olivier), when they made the following statements:
  - (1) "She later called Africans refugees." (Leader of the Opposition)
  - (2) "Most recently she exposed her adoration for colonial apartheid." (Leader of the Opposition)
  - (3) "The Premier in this very House, referring to black ANC women members, said: All they are good for is to collect "padkos" (food for the road) after meetings and drive home." (Member Dugmore)
  - (4) "Then we had the refugee tweet. No sincere apology about the hurt, because in her consciousness she has done nothing wrong." (Member Dugmore)
  - (5) "She spends a lot of time abroad to study the good aspects of apartheid and racist colonialism ..." (Leader of the Opposition)
  - (6) "It is the same MEC that forges ahead to turn our schools into shebeens." (Member Olivier),
 and that the committee consists of four members of the DA, two members of the ANC and one member of the ACDP.

**FURTHER BUSINESS****NOTICE OF MOTIONS (in terms of Standing Rule 147(1))**

1. Mr Q R Dyantyi moved: That the House notes that tax payers in the Eden Municipality will fork out more than R100 000 for an overseas trip to Sweden led by DA Mayor Memory Booysen; and calls for an investigation into all international trips by Western Cape municipalities as they try to emulate Premier Zille's overseas junkets.
2. Mr B D Kivedo moved: That the House debates efforts and initiatives to stimulate, generate, intensify, expand and implement the embracing and inculcation of cultural diversity and the fostering of social cohesion and nation-building in the Western Cape.
3. Ms P Z Lekker moved: That the House debates the bad state and effectiveness of the Western Cape Government's youth care facilities where drug addicts and juveniles awaiting trial are housed.
4. Ms T M Dijana moved: That the House debates the effectiveness of the City of Cape Town's ShotSpotter devices as well as other ineffective strategies to fight gang activities and crime in the province.
5. Ms P Z Lekker moved: That the House debates the eventual closure of Cape Town's rogue Special Investigations Unit, established with other so-called specialist units under the tenure of then Mayor Helen Zille.

6. Mr R D Mackenzie: That the House notes the resignation of Dr Makhosi Khosa as a member of the ANC and as Member of the National Parliament, referring to her now former party as alien, corrupt and unable to self-correct; and we wish her well in her future endeavours as it is clear that the ANC has no place for people with integrity, honesty and a good value system.
7. Mr K E Magaxa: That the House condemns the Office of the Premier's continued disrespect and intimidation of journalists who are doing their work by reporting facts without fear or favour, this after *The Times* reporter was vilified on Twitter by Premier Zille's chief of staff for reporting that tax payers forked out R90 000 for Zille's water purifier at her house; and calls for measures to be put in place to ensure media freedom in the province.
8. Mr N E Hinana: That the House congratulates the DA for holding peaceful, successful and democratic Metro Congress elections last Saturday.
9. Ms P Z Lekker: That the House notes that the ANC won another by-election in the province yesterday when it received 71% of the votes, with DA and its bed partner the EFF receiving 6% each; notes further that this indicates the DA is seriously losing ground as suggested by the Ipsos market research; and congratulates the ANC on the landslide victory in Ward 37.
10. Ms B A Schäfer: That the House congratulates and commends David Green, CEO of the V&A Waterfront and visionary behind the Zeitz Museum of Contemporary Art Africa. The museum is the continent's first museum dedicated to contemporary African art and is a welcome addition to the Cape Town's tourism and investment portfolio.
11. Mr C M Dugmore: That the House notes that, despite public promises by Premier Zille and Mayor De Lille that the Green Point Athletics Stadium would be renamed after the Olympic champion Wayde van Niekerk, this will no longer happen after their bitter fight and that the City will only erect a so-called Heroes' Wall to bear the names of South African Olympians; and calls for another method to honour our heroes, such as Wayde van Niekerk and Luvo Mayonga.
12. Mr K E Magaxa: That the House notes that *The Times* newspaper today took a position against the honourable Premier Zille's office staff for defaming and attacking the reporter who wrote about her water consumption at Leeuwenhof; also notes that it is described as her more natural demeanour, exemplified by her ill-advised colonialism tweets and allegations of putting pressure on officials to help her son's business; also notes that the paper says she behaved like that another thin-skinned occupier of a state-owned mansion, Donald Trump; and further notes that she – like Trump – insists on being a slow learner when it comes to handling real or perceived criticism.
13. Ms T M Dijana: That the House notes that the ANC over months called the water crisis a self-fabricated catastrophe as the DA-led administration failed to spend its budget on improving water infrastructure for more than a decade; and notes further that the City of Cape Town is now set to spend R8 billion over the next 10 years mostly on its funders.
14. Ms T M Dijana: That the House expresses its concern about the badly planned and poorly attended public hearings which do not properly involve the participation of communities, as seen this week in George with the discussion of housing matters.

15. Mr K E Magaxa: That the House notes that the deeply divided DA's MPL Lennit Max accepted the nomination and will stand against Minister Madikizela for the position of their party's provincial leader on 7 October.
16. Mr C M Dugmore: That the House unequivocally condemns the utter lawlessness displayed by certain taxi associations and drivers during their strike on Monday in which they attacked other modes of transport, injuring innocent passengers and vandalising property; and notes further that what we witnessed on Monday could have been avoided if Minister Grant had been more proactive and worked more closely with the national and local government.
