Consideration of the Report of the Standing Committee on Economic Opportunities, Tourism and Agriculture on the public hearings held to determine the impact of abalone poaching on small-scale fishing communities in the Western Cape, dated 14 June 2017 (see Announcements, Tablings and Committee Reports, p 179).

### **FURTHER BUSINESS**

### NOTICE OF MOTIONS

- 1. Mr R T Olivier: That the House debates the high teacher–learner ratio in this DA-run province and the negative impact it has on learning in poor areas.
- 2. Mr R D Mackenzie: That the House debates the impact of corruption on service delivery in South Africa.
- 3. Mr T A Simmers: That the House debates the provincial youth development strategy.
- 4. Mr R D Mackenzie: That the House debates the continuous bailouts of state-owned entities with guarantees and the impact these bailouts have on the capacity for service delivery.
- 5. Mr Q R Dyantyi: That the House debates factors contributing to the steep rates increases in the province, especially Woodstock and Salt River in Cape Town's, which force owners to sell their properties.

- 6. Ms T M Dijana: That the House debates the spate of evictions in the province, as well as the influence of property developers in these evictions, as 14 families in Albert Road, Woodstock, are being evicted from their homes and an eviction in Joostenbergvlakte was halted last night by the intervention of South African Human Rights Commissioner Chris Nissen.
- 7. Mr R T Olivier: That the House debates the high number of disabled children on the waiting list to be placed in special schools in the province and the reasons why the DA government fails these vulnerable learners.
- 8. Ms P Z Lekker: That the House debates the ineffectiveness of the DA-preferred neighbourhood watches in the fight against gangs and drug-related crimes in the province.
- 9. Ms T M Dijana: That the House debates the failure of municipalities in the province to utilise fully the Urban Settlements Development Grant, especially the City of Cape Town which never fully took up the budget since its inception to build much-needed houses.
- 10. Mr B D Joseph: That the House debates the closure of the Wolwekloof in Ceres.
- 11. Ms L M Maseko: That the House notes and congratulates the Robertson-based Graham Beck Wine Cellars for winning four awards at the recently held Decanter World Wine Awards where its Brut Zero 2011 received a silver award and the Blanc de Blanc, Cuvée Clive and Brut Rose, all 2011 wines, received bronze awards; and further congratulates the cellar for also being awarded the gold trophy at the Vinordic Wine Challenge for its brut non-vintage champagne.
- 12. Mr D G Mitchell: That the House condemns the EFF leader Julius Malema's blatant racist remarks that the Deputy President does not qualify for South African tenders because he is not black enough and that he has done everything in his life to please white people.
- 13. Ms P Makeleni: That the House commends the role of Police Minister Fikile Mbalula in restoring calm and law and order in Imizamo Yethu following days of unrest in Hout Bay; and further notes that a peace deal was made after his visit to and interaction with community leaders.
- 14. Ms T M Dijana: That the House notes with concern and investigates allegations that tenants at the De Waal Drive flats are forced to sign new lease agreements that are only valid for three years and that they were threatened with evictions by the DA government if they did not sign those agreements.
- 15. Ms P Makeleni: That the House notes with concern the allegations that the reason for the unrest in Imizamo Yethu and residents' reluctance to move is Minister Madikizela's reckless statement that residents would be moved to Wolwerivier, 30 km away from Cape Town; calls for an investigation into these allegations; and, therefore, condemns the Minister for his irresponsible utterances.
- 16. Mr R T Olivier: That the House calls on Basic Education Minister Angie Motshekga to intervene and nullify the Western Cape Provincial School Education Amendment Bill that allows alcohol to be sold and consumed on provincial school premises or at school activities, even if this means she has to amend national legislation.
- 17. Mr C M Dugmore: That the House notes with concern that more than 560 road deaths, including more than 268 pedestrians, have been reported on Western Cape roads since January this year; and calls for urgent measures, including employing more traffic enforcement officials, to be taken to curb the carnage.

- 18. Ms P Makeleni: That the House welcomes the Western Cape High Court ruling which found the provincial Department of Social Development and the Aunty Dawn Day Care Centre in Pinelands were jointly responsible for the death of 5-month-old Ava Barley who rolled off a bed and died when she was left unsupervised in 2010; condemns Minister Fritz's appeal against the ruling as another form of delay tactics by this provincial government; and conveys condolences with the parents.
- 19. Ms P Makeleni: That the House calls for an urgent intervention to support NGOs that assist the poor and vulnerable who have been evicted from community centres in Hanover Park and Bonteheuwel; and condemns the DA for allowing its factional battles to undermine the work of community organisations and making them unable to do their work, thereby leaving the elderly and young people with disabilities stranded.
