Introduction and First Reading – Western Cape Appropriation Bill [B 4–2025] (Minister of Finance).

FURTHER BUSINESS

NOTICES OF MOTION (29 May 2025)

1. Mr G Brinkhuis: That the House notes that, on a farm known as Nantes on the R45 in Paarl in the Drakenstein Municipality, farm dwellers are living under shocking conditions; further notes that the seven families are fenced in on their portion on the farm and forced to use a narrow alley to enter and exit the property; recognises that the families have waged a three-year battle for their rights to clean water, refuse removal and for the removal of the fence; further recognises that the long, uneven and narrow alley is causing great harm to the lives of the families; acknowledges that, under such conditions, the families are unable to park their vehicles on the precinct of their dwellings and emergency vehicles cannot enter the property; further acknowledges that this narrow alley gets flooded during the winter and this prevents children from going to school as they cannot access transport; notes that the elderly, the sick and people with disabilities often miss their hospital appointments as they find the walk down the alley too challenging especially during winter; and condemns the farm owner for violating the human rights of the families.
2. Mr B Ngqentsu: That the House notes today's official opening of the central line from Chris Hani to the Cape Town station by the Minister of Transport, Barbara Creecy, and her Deputy Minister, Mkhuleko Hlengwa; notes that the launch follows extensive upgrades to the central line and the station; notes that the central line is one of the largest commuter rail corridors in the city; notes that this will certainly enhance public transport, boost economic activities and improve daily commutes; and maintains that there should be public consultation on the Service Level Plan between Prasa and the City of Cape Town.

3. Ms P Z Lekker: That the House notes with concern the multi-vehicle collision at the intersection of Spine Road and Merrydale Road, which left twelve learners from various schools in Mitchells Plain injured; further notes that the accident involved seven vehicles, including two taxis and an unlicensed learner transport vehicle with no professional driving permit; acknowledges that this incident reflects a wider crisis of unregulated and unsafe learner transport across the province; and calls on the Western Cape Government to review and strengthen the enforcement of safety protocols for learner transport urgently, including the vetting of drivers and the roadworthiness of vehicles, to ensure that no child's life is put at risk on their way to school.
4. Mr B Ngqentsu: That the House notes the provisional withdrawal of the R1 billion tender fraud case against Malusi Booi, the former DA Member of the Mayoral Committee, and his co-accused; further notes that the National Prosecuting Authority's confirmed that the police had discovered new evidence, and that the charges have only been withdrawn pending the finalisation of investigations; calls for a thorough independent investigation and swift reinstatement of charges; and requests a response to a letter written by the ANC and its alliance partners, in particular the SACP, calling on the President to sign a proclamation for the Special Investigating Unit to probe corruption networks entrenched in the City of Cape Town's housing tenders and also solid waste management.
5. Ms P Z Lekker: That the House notes with dismay the arrest of two City of Cape Town law enforcement officers for kidnapping and extorting a man in Khayelitsha; further notes that the officers allegedly demanded a ransom after unlawfully detaining the victim under the pretext of checking his asylum documents; condemns this criminal abuse of authority in the strongest possible terms; and calls on the provincial government and the City to clean out corruption in the enforcement units and to restore community trust.
6. Ms N D Nkondlo: That the House notes with deep concern and strongly condemns the racist remarks made by Councillor J Miller of Cape Exit against Capetonians from the Eastern Cape, describing them as labour migrants who should be ejected from Cape Town; further notes that such xenophobic, racist and divisive statements were made in this House and province by DA leader Helen Zille and former FF+ MPP Peter Marais who called us refugees from the Eastern Cape and foreigners from Zimbabwe respectively; calls on this House to attend to the growing cases of blatant and overt racism in the City of Cape Town public spaces, such as schools, restaurants and now in council chambers, that are supposed to uphold the supreme law of the country, the Constitution and the Bill of Rights; notes that these racial hate incidents are spreading through the province with a recent attack on black young females in Beaufort West by a white male; notes that citizens of this province must refuse to be taken back to the times of racial segregation under apartheid; and asks the Premier to call an inquest on racism in this province as a way of recommitting his government to the constitutional principle that "South Africa belongs to all who live in it, black and white", and to guarantee the human rights of all citizens.
7. Ms N D Nkondlo: That the House notes and highlights the cover-up that is currently taking place in the City of Cape Town; notes that the DA-led City of Cape Town is allegedly protecting a network of contractors and officials implicated in irregular, fruitless and wasteful expenditure of R30 million; notes that, as a cover-up, Patricia van der Ross, Member of the Mayoral Committee for Community Services and Health, was removed to contain the corruption scandal; and repeats the caution expressed multiple times in the House regarding the DA's misgovernance.

VERDERE WERKSAAMHEDE

VOORSTELLE MET KENNISGEWING (29 Mei 2025)

1. Mn G Brinkhuis: Dat die Huis kennis neem dat plaasbewoners op die plaas bekend as Nantes op die R45 in die Paarl in die Drakenstein-munisipaliteit in haglike omstandighede woon; verder kennis neem dat die sewe families 'n heining om hul deel van die plaas het en noodgedwonge 'n nou stegie moet gebruik om by die eiendom in te kom en uit te gaan; erkenning gee dat die familie al drie jaar vir hul reg op skoon water, vullisverwydering en die verwydering van die heining veg; verder erkenning gee dat die lang, ongelyke en nou stegie die families se lewens groot skade berokken; erkenning gee dat die families onder hierdie omstandighede nie hul voertuie in die omgewing van hul wonings kan parkeer nie en noodvoertuie nie by die eiendom kan inkom nie; verder erkenning gee dat hierdie nou stegie in die winter oorstrom en die kinders dus nie skool toe kan gaan nie omdat hulle nie vervoer kan bereik nie; kennis neem dat die bejaardes, siek mense en mense met gestremdhede dikwels hul hospitaalafsprake misloop omdat hulle veral in die winter te veel sukkel om in die stegie te stap; en die plaaseienaar veroordeel vir die skending van die families se menseregte.
2. Mn B Ngqentsu: Dat die Huis kennis neem van die amptelike opening vandag van die sentrale lyn vanaf Chris Hani na die Kaapstad-stasie deur die Minister van Vervoer, Barbara Creecy, en haar Adjunkminister, Mkhuleko Hlengwa; kennis neem dat die opening ná omvattende opgraderings aan die sentrale lyn en die stasie plaasvind; kennis neem dat die sentrale lyn een van die grootste pendelaarspoorgange in die stad is; kennis neem dat dit openbare vervoer beslis sal verbeter, ekonomiese bedrywighede 'n hupstoot sal gee en

daaglikse pendel sal verbeter; en volhou dat daar openbare raadpleging oor die Diensvlakplan tussen Prasa en die Stad Kaapstad moet wees.

3. Me P Z Lekker: Dat die Huis met kommer kennis neem van die kettingbotsing by die kruising by Spine- en Merrydaleweg waarin 12 leerders van verskeie skole in Mitchells Plain beseer is; verder kennis neem dat sewe voertuie by die botsing betrokke was, insluitende twee taxi's en 'n leerdervervoervoertuig sonder lisensie met geen professionele bestuurspermit nie; erkenning gee dat hierdie voorval 'n groter krisis met betrekking tot ongereguleerde en onveilige leerdervervoer in die provinsie weerspieël; en 'n beroep op die Wes-Kaapse Regering doen om die toepassing van veiligheidsprotokolle vir leerdervervoer dringend te hersien en verbeter, insluitende die kontrolering van bestuurders en die padwaardigheid van voertuie om toe te sien dat geen leerder se lewe op pad skool toe in gevaar gestel word nie.
4. MnR B Ngqentsu: Dat die Huis kennis neem van die voorlopige terugtrekking van die tenderbedrogstaak van R1 miljard teen Malusi Boo, die voormalige DA-lid van die Burgemeesterskomitee, en sy medebeskuldigdes; verder kennis neem dat die Nasionale Vervolgingsgesag bevestig het dat die polisie nuwe bewyse ontdek het, en dat die aanklagte net teruggetrek is terwyl die ondersoek afgehandel word; 'n beroep doen om 'n deeglike ondersoek en vinnige herinstelling van die aanklagte; en reaksie versoek op 'n brief wat deur die ANC en sy alliansievennote, veral die SAKP, geskryf is wat 'n beroep op die President doen om 'n proklamasie te onderteken dat die Spesiale Ondersoekeeenheid korupsienetwerke moet ondersoek wat by die Stad Kaapstad se behuisingsstenders en ook vasteafvalbestuur ingewortel is.
5. Me P Z Lekker: Dat die Huis met ontsteltenis kennis neem van die inhegtenisneming van twee wetstoepassingsbeamptes van die Stad Kaapstad vir die ontoeroering en afpersing van 'n man in Khayelitsha; verder kennis neem dat die beamptes na bewering 'n losprys geëis het nadat hulle die slagoffer wederregtelik aangehou het onder die voorwendsel dat sy asieldokumente nagegaan word; hierdie kriminele magsmisbruik op die sterkste manier denkbaar veroordeel; en 'n beroep doen op die provinsiale regering en die Stad om korruksie in die toepassingseenhede uit te roei en om die gemeenskap se vertroue te herstel.
6. Me N D Nkondlo: Dat die Huis met diepe kommer kennis neem en die rassistiese uitlatings ten sterkste veroordeel wat raadslid J Miller van Cape Exit teenoor Kapenaars van die Oos-Kaap gemaak het toe hy hulle as trekarbeiders bestempel het wat uit Kaapstad verwijder moet word; verder kennis neem dat sulke xenofobiese, rassistiese en verdelende uitlatings in hierdie Huis en provinsie gemaak is deur die DA-leier Helen Zille en voormalige VF+LPP Peter Marais wat ons onderskeidelik vlugtelinge uit die Oos-Kaap en buitelanders van Zimbabwe genoem het; 'n beroep doen op hierdie Huis om aandag te skenk aan die stygende gevalle van blatante en openlike rassisme in die Stad Kaapstad se openbare ruimtes, soos skole, restaurante en nou in raadsale, wat veronderstel is om die hoogste wet van die land, die Grondwet en die Handves van Menseregte, te handhaaf; kennis neem dat hierdie voorvalle van rasshaat in die provinsie versprei met 'n onlangse aanval deur 'n wit man op jong swart vroue in Beaufort-Wes; kennis neem dat inwoners van hierdie provinsie moet weier om na die tyd van rasseskeiding gedurende apartheid teruggevoer te word; en die Premier versoek om 'n geregtelike ondersoek oor rassisme in hierdie provinsie aan te vra om sy regering weer te verbind tot die grondwetlike beginsel dat "Suid-Afrika aan almal behoort wat daarin woon, swart en wit", en om die menseregte van alle burgers te verseker.

7. Me N D Nkondlo: Dat die Huis kennis neem en die toesmeerdery beklemtoon wat tans by die Stad Kaapstad plaasvind; kennis neem dat die Stad Kaapstad onder die beheer van die DA na bewering 'n netwerk kontrakteurs en amptenare beskerm wat by onreëlmatige, vrugtelose en verkwistende besteding van R30 miljoen betrokke is; kennis neem dat, om dit toe te smeer, Patricia van der Ross, Burgemeesterskomiteelid belas met Gemeenskapsdienste en Gesondheid, verwyder is om die korruptsieskandaal in toom te probeer hou; en die waarskuwing herhaal wat verskeie kere in die Huis oor die DA se wanbestuur uitgespreek is.
