- 1. Ms B A Schäfer moved: That the House debates BEE and its failure in the Western Cape's economy.
- 2. Mr B D Kivedo moved: That the House debates the criminal elements as well as external turmoil that hold our schools, and specifically learners, to ransom.
- 3. Mr C M Dugmore moved: That the House debates the prevalence of sexual violence in schools in the province under the DA.

- 4. Mr N E Hinana moved: That the House debates the implications of 59% of submissions being against the expropriation of land without compensation, as released by the Constitutional Review Committee.
- 5. Mr Q R Dyantyi moved: That the House debates the punitive water and electricity tariffs charged by municipalities under the DA in the province.
- 6. Ms B A Schäfer moved: That the House condemns the EFF's attempts to nationalise the Reserve Bank and the ANC's failure unequivocally to reject it.
- 7. Mr S G Tyatyam moved: That the House debates growing unemployment in the DA-run province.
- 8. Mr Q R Dyantyi moved: That this House debates the regression in audit outcomes of DArun municipalities in the province.
- 9. Ms B A Schäfer moved: That the House debates the impact of policies, in particular the Protection of Investment Act, 2015 (Act 22 of 2015), and the impact of foreign direct investment on the Western Cape Economy.
- 10. Mr C M Dugmore moved: That the House debates tensions in the taxi industry and the failure of the DA-led provincial government to intervene meaningfully.
- 11. Ms B A Schäfer moved: That the House condemns the EFF wanting to capture the Reserve Bank of South Africa and the ANC for not coming out to protect the independence of the SARB.
- 12. Mr N E Hinana moved: That the House notes the preliminary committee report that 59% of South Africans are against amending section 25 of the Constitution as 89 000 of the 149 000 written submissions that have already been reviewed are not in favour of the expropriation of land without compensation.
- 13. Mr K E Magaxa moved: That the House notes that Cape Town Mayor Patricia de Lille vacates her office on 31 October 2018 after a protracted battle between her and her party; notes further that De Lille, who faced a litany of charges by the party, had won her battle; notes that the deal between De Lille and the DA is an agreement to avoid further exposing the levels of corruption in the City under the DA government; condemns the DA for sweeping corruption under the carpet.
- 14. Ms P Z Lekker moved: That the House notes that gang violence in the province is worsening, and gangs don't have respect for honourable Minister Plato as a man was shot dead and three others wounded in Lavender Hill while Minister Plato was addressing a public meeting about gang violence in the area; condemns the senseless killing; and calls on the provincial government to allocate more resources to the fight against drugs and gang violence.
- 15. Mr C M Dugmore moved: That the House notes and welcomes the widespread rejection of the DA's plans to privatise education and to allow the sale of alcohol at schools in the province; notes further that at all the public hearings about the amendment bill the proposed amendments were rejected outright; applauds the parents, teachers and activists in the province for taking a stand against the draconian bill the DA wanted to introduce.
- 16. Mr K E Magaxa moved: That the House notes that the continued praise of some of the legacies of apartheid and colonialism by Premier Helen Zille shows signs of an irredeemably arrogant and conservative person; notes further that despite the Public Protector's findings against her, the Premier continues embarrassing the province and sowing division among the people; condemns this unbecoming conduct by the Premier; and calls on the Speaker to initiate a process to take remedial action against the Premier.

- 17. Mr Q R Dyantyi moved: That the House notes with concern that Cape Town incurred R47 million in irregular spending, topping the list of three municipalities in the province that together spent R173 million in 2016/17 without following the legal prescripts; notes that the Auditor-General blamed this on the City's weaknesses, including political instability; and condemns the DA for the non-compliance, which resulted in Cape Town, Bitou and Eden losing their clean audits.
- 18. Ms P Z Lekker moved: That the House notes the "blue lies" that the Minister of Human Settlements waved at the public meeting in Nyanga last night, when he could not respond to the people of Nyanga about the following last night:
 - (1) Nyanga upgrade: almost 7 years behind;
 - (2) White-black city: 28 RDP houses delayed for almost 4 years;
 - (3) Hostel-to-homes unit development;
 - (4) Here in the House on 14 June 218 he indicated the contractor was moving in to finish the 7 houses at Freedom Square, but yesterday he did not know about the 7 unfinished houses, which are havens for criminals involved in rapes, murders, etc.
