NOTICE OF MOTION (in accordance with Standing Rule 151)

The Premier – Mr A R Winde:

That, in the light of the serious allegations of service delivery failures (including refuse collection, infrastructure maintenance, water supply and wastewater treatment works), non-adherence to prescribed governance processes, unethical recruitment processes and mismanagement of budgetary processes in the municipalities of Knysna, Kannaland and Theewaterskloof, the House requests the Minister of Local Government to consider such options as are imparted to the Minister by the Western Cape Monitoring and Support of Municipalities Act to investigate whether the said municipalities cannot or do not fulfil their statutory obligations or whether maladministration, fraud, corruption, irregular appointments or other serious malpractices have occurred or are occurring in those municipalities. The standing committee for local government must be apprised of the Minister's actions so that it may conduct active oversight in line with its responsibility.

Dat, in die lig van die ernstige bewerings van dienslewingsmislukkings (insluitende vullisverwydering, infrastruktuurinstandhouding, watervoorsiening en afvalwaterverwerkingsaanlegte), nienakoming van voorgeskrewe bestuurstoetsingprosesse, onetiese werwingsprosesse en wanbestuur van begrotingsprosesse in die munisipaliteite van Knysna, Kannaland en Theewaterskloof, die Huis die Minister van Plaaslike Regering versoek om sodanige opsies te oorweeg wat deur die Wes-Kaapse Wet op Monitering en Ondersteuning van Munisipaliteite aan die Minister opgedra word, om ondersoek in te stel of die genoemde munisipaliteite nie hul statutêre verpligtinge kan nakom nie of nie nakom nie en of wanadministrasie, bedrog, korrupsie, onreëlmatige aanstellings of ander ernstige wanpraktyk in daardie munisipaliteite voorgekom het of voorkom. Die staande komitee oor plaaslike regering moet oor die Minister se optrede ingelig word sodat hy aktief toesig kan uitoefen in ooreenstemming met sy verantwoordelikheid.
