### FURTHER BUSINESS

#### NOTICES OF MOTION (*8 June 2023*)

1. Mr F C Christians: That the House debates the learnerships offered by big business and the benefits thereof.
2. Ms A P Bans: That the House debates the fact that the Western Cape has more drug dens than schools.
3. Ms N G Bakubaku-Vos: That the House debates the fact that more than 30 000 children are in the foster care system in the Western Cape.
4. Ms R Windvogel: That the House debates the NICD reports of an increase in Western Cape influenza cases.
5. Mr P Marran: That the House debates a worrying flare-up of animal diseases in the Western Cape.

6. Mr L L Mvimb: That the House debates racial discrimination in property rental market in the Western Cape.
7. Ms P Z Lekker: That the House debates the sanitation backlog causing people to still make use of the unsanitary bucket system.

## **NOTICES OF MOTION (1 June 2023)**

1. Ms A Cassiem: That the House notes that on 16 May 2023 elderly people went out in their numbers to protest outside the Nyanga Clinic demanding better healthcare services, such as adequate doctors and adequate supply of medicine; further notes that these elderly people have been subjected to long queues over the years while there is also a high rate of medical files going missing in that clinic; and asks the Western Cape Department of Health and Wellness to start having 24-hour clinics across the province, especially in townships and rural areas, which continue to experience high demand of medical services, as such an initiative will also assist in making sure that residents do not queue the whole day to receive medical attention.
2. Mr T M Klaas: That the House notes that the security of tenure is of paramount importance when it comes to security guards, cleaners, porters, temporary nurses and gardeners who work in different Western Cape Government departments as outsourced workers; further notes that most of these workers are denied access to loans and other benefits by the mainstream financial sector markets for purposes of bonds and other needs incidental thereto due to lack of job security; and asks all Western Cape Government departments to insource all workers falling in similar categories so that they can have security of tenure, which will improve their lives to escape perpetual poverty.
3. Mr K Brinkhuis: That the House notes that the outcome of the arbitration hearings of sacked Heathfield High School Principal Mr Wesley Neumann will be known within one week from now; further notes that Mr Neumann was victimised, harassed and sacked by the Western Cape Education Department for abiding by a school governing body's decision not to re-open the school during the first wave of COVID-19 in 2020; recognises that the decision taken by Mr Neumann was in the best interest of the learners, educators and the school community considering the vast differences in resources and challenges from school to school; further recognises the solidarity and support displayed for Mr Neumann by the Special Action Committee, progressive educators and the public at large; and joins the Special Action Committee in saluting Mr Neumann and his family for enduring this persecution by the Western Cape Education Department for more than three years.
4. Ms A Cassiem: That the House takes notice of the Andries Tatane Clean-up Campaign introduced by the EFF to keep communities clean in the whole of South Africa, including the Western Cape; further notes that the campaign was launched in response to failures by all spheres of government, including municipalities that cannot execute the service-delivery mandate of keeping communities clean by picking up waste; and concludes that in the Western Cape the campaign has a positive impact not only in keeping township communities clean but also in forcing DA-run municipalities to execute their service-delivery mandate.

5. Mr T M Klaas: That the House takes notice of the recently released fourth quarter South African Crime Statistics covering the period 1 January 2023 to 31 March 2023; further notes that the Cape Town Central Police Station remains the number 1 station in the country when it comes to stations with a high number of reported crimes, while Delft also continues to remain at number 3 in the country when it comes to high murder rates, with the murder ratio increasing by 11,9 in the whole Western Cape in the period under review; and concludes that the Western Cape remains the crime capital of South Africa as it is clear that the Safety Plan is useless.
6. Mr I Sileku: That the House acknowledges and commends the exceptional performance of the majority of municipalities in the province that have achieved remarkable results in both the Auditor-General's annual audit outcomes report and the Ratings Afrika report; extends its heartfelt congratulations to the municipalities of Saldanha Bay, George, Mossel Bay and

Swartland for their remarkable achievement in securing their positions among the top five best-run municipalities in the entire country; notes that their dedication to effective governance and sound financial management deserves admiration and recognition; and takes note of the Kannaland, Beaufort West and Laingsburg municipalities that continue to fall behind.

7. Mr L L Mvimbzi: That the House notes and is saddened by the death of five schoolchildren who passed away in the most tragic way; notes that a bakkie that was transporting the children to school crashed into a bus; notes that this relates to the bigger issue of accessibility to schools in our poor and working-class areas; notes that there are very little safety checks for various transport operators and that the DA government is doing very little in this regard; demands that the Western Cape's Department of Mobility's law enforcement unit impounds all bakkies and unsafe learner-transport vehicles; and appreciates that the driver has arrested and that justice will be served.
8. Ms P Z Lekker: That the House notes and is shocked that the Herzlia High School in Cape Town is indoctrinating and publicly admits to influencing their learners about racism and prejudice against Palestinians; condemns this school and its management for encouraging its learners to join the Israeli defence force that is currently killing innocent Palestinians and expanding a racist imperialist state; and calls on the Premier to intervene in this matter.
9. Mr M K Sayed: That the House notes the struggles of the poor and working-class Bitterfontein community on the West Coast to keep their children in school due to learner-transport challenges; notes that the school in Nuwerus is 16 km from Bitterfontein and parents cannot afford to pay for the transport to school, resulting in a high early dropout rate; and calls on the Western Cape Education Department to make provisions for these learners as the matter has been brought to its attention.
10. Mr M K Sayed : That the House notes with serious concern the high number of applications of black children (black, coloured and Indian) that are being rejected by the so-called prestigious former model C schools in the province; further notes that the ANC is already inundated by complaints from concerned parents, many of whom applied to eight different schools and have been rejected by all eight schools, this includes Mr Adams who applied to eight public government schools for his son Ayaan only to receive rejection letters from all of them; notes that Mr Adams says this outcome left him deeply troubled and raises serious concerns about the fairness and transparency of the application process; notes that Mr Adams who resides 2,2 km from the Wynberg Boys' Junior School and the Wynberg Girls'

Junior School has had applications for his daughter Ariana rejected by the girls' school even though she is top in her Grade 4 class at the Golden Grove Primary School and actively participating in sports; further notes that a similar case is that of Ms Galada, a teacher by profession, who applied timeously and correctly to five different schools and was rejected by all five schools; notes that the first option was the Rouxville Primary School and the second was the De Kuilen Primary School, both of which are within a five minutes' drive from her home, and two other schools that rejected her child are in Brackenfell; further notes that she wrote to us seeking assistance, stating: "This application system is failing us as parents because I applied a day after the applications were opened in March and submitted all what was required, and yet my child has been rejected by all schools"; acknowledges that the online application system and admissions policies of schools, especially in the former model C schools, are used to discriminate and keep out black, coloured and Indian learners to keep their schools white; calls on Minister Maynier and Premier Winde to intervene directly and bring to an end this racist practice by schools to keep out black learners; and supports the BELA Bill to deal decisively with these discriminatory practices – a bill opposed by the racist DA.

11. Mr M K Sayed: That the House commemorates the 100th anniversary of the ending of the Irish Civil War; continues to call for the unity of all republicans in Ireland; calls on the Irish government to convene and resource an all-island Citizen's Assembly on Irish unity to plan

and prepare for constitutional change; encourages the Irish government to use its international diplomatic resources to secure a date for a unity referendum; and calls on all progressive international political and civic forces to support the process of constitutional change and the achievement of Irish unity.

##### KENNISGEWING VAN VOORSTELLE (*8 Junie 2023*)

1. Mnr F C Christians: Dat die Huis die leerderskappe wat deur groot sakeondernemings aangebied word, en die voordele daarvan debatteer.
2. Me A P Bans: Dat die Huis dat feit dat die Wes-Kaap meer dwelmneste as skole het, debatteer.
3. Me N G Bakubaku-Vos: Dat die Huis die feit dat meer as 30 000 kinders in die pleegsorgstelsel in die Wes-Kaap is, debatteer.
4. Me R Windvogel: Dat die Huis NIOS-verslae oor 'n toename in Wes-Kaapse gevalle van griepe debatteer.

5. Mnr P Marran: Dat die Huis die kommerwekkende toename in dieresiektes in die Wes-Kaap debatteer.
6. Mnr L L Mvimbi: Dat die Huis rassediskriminasie in die huureindomsmark in die Wes-Kaap debatteer.
7. Me P Z Lekker: Dat die Huis die sanitasie-agterstand debatteer wat veroorsaak dat mense steeds van die onhigiëniese emmerstelsel gebruik maak.

##### KENNISGEWING VAN VOORSTELLE (*1 Junie 2023*)

1. Me A Cassiem: Dat die Huis kennis neem dat bejaarde mense op 16 Mei 2023 in groot getalle buite die Nyanga-kliniek betoog het om aan te dring op en beter gesondheidsorgdienste, soos genoeg dokters en die voldoende voorsiening van medisyne, te eis; verder kennis neem dat hierdie bejaardes deur die jare aan lang rye onderwerp is, terwyl daar ook 'n hoë getal mediese leers by daardie kliniek vermis word; en die Wes-Kaap Departement van Gesondheid en Welstand versoek om 24-uur-klinieke in die provinsie te open, veral in informele nedersettings en in landelike gebiede, wat steeds 'n groot aanvraag na mediese diensteervaar, aangesien só 'n inisiatief ook sal help om seker te maak dat inwoners nie die hele dag toustaan om mediese hulp te ontvang nie.
2. Mnr T M Klaas: Dat die Huis kennis neem dat eiendomsreg van kardinale belang is vir sekuriteitswagte, skoonmakers, portiers, tydelike verpleegkundiges en tuiniers wat by verskillende Wes-Kaapse regeringsdepartemente as uitgekontrakteerde werkers werk; verder kennis neem dat die meeste van hierdie werkers toegang tot lenings en ander voordele deur die hoofstroom finansiëlesektormarkte geweier word vir doeleindes van verbande en ander produkte wat daarvan verband hou weens 'n gebrek aan werksekerheid; en alle Wes-Kaapse regeringsdepartemente versoek om alle werkers wat in soortgelyke kategorieë val, in diens te neem sodat hulle eiendomsreg kan geniet, wat hul lewens sal verbeter om aan voortdurende armoede te ontsnap.
3. Mnr K Brinkhuis: Dat die Huis kennis neem dat die uitslag van die arbitrasieverhoor van die afgedankte hoof van die Hoëskool Heathfield, mnr Wesley Neumann, binne een week van nou bekend sal wees; verder kennis neem dat mnr Neumann deur die Wes-Kaapse Onderwysdepartement geviktimpiseer, geteister en afgedank is omdat hy gehoor gegee het aan 'n skoolbeheerliggaambesluit om nie die skool tydens die eerste vlaag van COVID-19 in 2020 te heropen nie; erken dat die besluit wat deur mnr Neumann geneem is, in die beste belang van die leerders, opvoeders en die skoolgemeenskap was, met inagneming van die

groot verskil in hulpbronne en uitdagings van skool tot skool; verder erkenning gee aan die solidariteit en ondersteuning wat die Spesiale Aksiekomitee, progressiewe opvoeders en die publiek in die algemeen met mnr Neumann toon; en aansluit by die Spesiale Aksiekomitee om mnr Neumann en sy gesin te salueer omdat hulle hierdie vervolging deur die Wes-Kaapse Onderwysdepartement vir meer as drie jaar verduur het.

4. Me A Cassiem: Dat die Huis kennis neem van die Andries Tatane-skoonmaakveldtog wat deur die EFF ingestel is om gemeenskappe skoon te maak in die hele Suid-Afrika, insluitend die Wes-Kaap; verder kennis neem dat die veldtog van stapel gestuur is in reaksie op mislukkings deur alle regeringsfere, insluitende munisipaliteite wat nie die diensleveringsmandaat kan uitvoer om gemeenskappe skoon te hou deur afval op te tel nie; en tot die gevolgtrekking kom dat die veldtog in die Wes-Kaap 'n positiewe impak het, nie net om gemeenskappe in informele nedersettings skoon te maak nie, maar ook om DA-bestuurde munisipaliteite te dwing om hul diensleveringsmandaat uit te voer.

5. Mnr T M Klaas: Dat die Huis kennis neem van die onlangs vrygestelde Suid-Afrikaanse Misdaadstatistiek vir die vierde kwartaal wat die tydperk 1 Januarie 2023 tot 31 Maart 2023 dek; verder kennis neem dat die Kaapstad-Sentraal-polisiestasie steeds die nommer 1-stasie in die land is wanneer dit by stasies met 'n hoë getal aangemelde misdade kom, terwyl Delft ook steeds op nommer 3 in die land bly wanneer dit by hoë moordsyfers kom, met die moordverhouding wat in die oorsigtydperk met 11,9 in die hele Wes-Kaap toegeneem het; en tot die gevolgtrekking kom dat die Wes-Kaap die misdaadhoofstad van Suid-Afrika bly aangesien dit duidelik is dat die Veiligheidsplan nutteloos is.
6. Mnr I Sileku: Dat die Huis erkenning gee aan en die uitsonderlike prestasie van die meerderheid munisipaliteite in die provinsie aanprys wat merkwaardige resultate behaal het in beide die Ouditeur-generaal se jaarlikse oudituitkomstverslag en die Ratings Afrika-verslag; die munisipaliteite van Saldanhabaai, George, Mosselbaai en Swartland hartlik gelukwens met hul merkwaardige prestasie om hul posisies onder die vyf top munisipaliteite wat die beste in die hele land bestuur word, te verseker; kennis neem dat hul toewyding tot doeltreffende bestuurstoesig en gesonde finansiële bestuur bewondering en erkenning verdien; en kennis neem van die Kannaland-, Beaufort-Wes- en Laingsburg-munisipaliteit wat voortgaan om agteruit te gaan.
7. Mnr L L Mvimbi: Dat die Huis kennis neem van en is bedroef is oor die dood van vyf skoolkinders wat op die mees tragiese manier gesterf het; kennis neem dat 'n bakkie wat die kinders skool toe vervoer het, in 'n bus vasgery het; kennis neem dat dit verband hou met die groter kwessie van toeganklikheid tot skole in ons arm en werkersklasgebiede; kennis neem dat daar baie min veiligheidskontroles vir verskeie vervoeroperateurs is en dat die DA-regering baie min in hierdie verband doen; eis dat die Wes-Kaapse Departement van Mobiliteit se wetstoepassingseenheid alle bakkies en onveilige leerdervervoer voertuie skut; en waardering uitspreek omdat die bestuurder in heftigheid geneem is en dat geregtigheid sal geskied.
8. Me P Z Lekker: Dat die Huis kennis neem en geskok is dat die Herzlia High School in Kaapstad sy leerders indoktrineer en in die openbaar erken dat hulle beïnvloed word oor rassisme en vooroordeel teen Palestyn; hierdie skool en sy bestuur veroordeel omdat leerders aangemoedig word om by die Israeliese weermag aan te sluit wat tans onskuldige Palestyn doodmaak en 'n rassistiese, imperialistiese staat uitbrei; en 'n beroep op die Premier doen om by hierdie aangeleenthed in te gryp.
9. Mnr M K Sayed: Dat die Huis kennis neem van die stryd van die arm en werkersklas-Bitterfontein-gemeenskap aan die Weskus om hul kinders op skool te hou weens leerdervervoeruitdagings; kennis neem dat die skool in Nuwerus 16 km vanaf Bitterfontein is en ouers nie kan bekostig om vir die vervoer skool toe te betaal nie, wat tot 'n hoë vroeë uitvalsyfer lei; en 'n beroep op die Wes-Kaapse Onderwysdepartement doen om maak vir hierdie leerders voorsiening te aangesien die aangeleenthed reeds onder sy aandag gebring is.

9. Mnr M K Sayed: Dat die Huis met ernstige kommer kennis neem van die groot getal aansoeke van swart kinders (swart, bruin en Indiërs) wat deur die sogenaamde voormalige model C-prestigeskole in die provinsie afgekeur word; verder kennis neem dat die ANC reeds oorval word deur klagtes van bekommende ouers, van wie baie by agt verskillende skole aansoek gedoen het en deur al agt skole afgekeur is, insluitende mnr Adams wat by agt staatskole vir sy seun Ayaan aansoek gedoen het net om afkeurbriewe van hulle almal te ontvang; kennis neem dat mnr Adams sê dat hierdie uitslag hom diep ontsteld gelaat het

en ernstige kommer wek oor die regverdigheid en deursigtigheid van die aansoekproses; kennis neem dat mnr Adams wat 2,2 km van die Wynberg Boys' Junior School en die Wynberg Girls' Junior School woon, se aansoeke vir sy dogter Ariana deur die meisieskool afgekeur is alhoewel sy eerste in haar graad 4-klas by die Golden Grove Primary School is en aktief aan sport deelneem; verder kennis neem dat 'n soortgelyke geval dié is van me Galada, 'n onderwyseres van beroep, wat betyds en korrek by vyf verskillende skole aansoek gedoen het en deur al vyf skole afgekeur is; kennis neem dat die eerste opsie die Laerskool Rouxville was en die tweede die Laerskool De Kuilen, wat albei binne vyf minute se ry van haar huis af is, en twee ander skole wat haar kind afgekeur het, is in Brackenfell; kennis neem dat sy aan ons geskryf het om hulp te vra en gesê het: "Hierdie aansoekstelsel faal ons as ouers omdat ek 'n dag nadat die aansoeke in Maart oopgemaak het, aansoek gedoen het en alles ingedien het wat vereis is, en tog is my kind deur alle skole afgekeur.>"; erken dat die aanlyn aansoekstelsel en toelatingsbeleide van skole, veral by die voormalige model C-skole, gebruik word om teen swart, bruin en Indiër-leerders te diskrimineer en hulle uit te sluit ten einde die skole wit te hou; 'n beroep op Minister Maynier en Premier Winde doen om regstreeks in te gryp en hierdie rassistiese praktyk deur skole te beëindig om swart leerders uit te sluit; en die BELA-wetsontwerp ondersteun wat beslissend teen hierdie diskriminerende prakteke sal optree – 'n wetsontwerp waarteen die rassistiese DA gekant is.

11. Mnr M K Sayed: Dat die Huis die 100e herdenking van die einde van die Ierse burgeroorlog herdenk; voortgaan om 'n beroep te doen op die eenheid van alle republikeine in Ierland; 'n beroep op die Ierse regering doen om 'n hele-eiland-burgervergadering oor Ierse eenheid byeen te roep en vir grondwetlike verandering te beplan en voor te berei; die Ierse regering aan te moedig om sy internasionale diplomatieke hulpbronne te gebruik om 'n datum vir 'n eenheidsreferendum vas te stel; en 'n beroep op alle progressiewe internasionale politieke en burgerlike magte te doen om die proses van grondwetlike verandering en die behaling van Ierse eenheid te ondersteun.
