Ms L T Botha: The looming crisis around SASSA and the impact on the Western Cape.

#### **FURTHER BUSINESS**

#### NOTICE OF MOTIONS

- 1. Mr D Joseph: That the House debates the state of our country, reflecting on our constitutional democracy after our Constitution was passed on 10 December 1996.
- 2. Ms Z P Lekker: That the House notes with concern the killing of foreign shopkeepers in the province, particularly in Khayelitsha Site C, with more than 15 reported incidents since the beginning of the year.
- 3. Mr C M Dugmore: That the House debates the failure of the Western Cape Government to implement plans to curb the road carnage in the province fully, and the impact on said road fatalities of the failure to fill the large number vacancies.
- 4. Ms Z P Lekker: That the House debates the lack of implementation plans by this Western Cape Government to curb the death of innocent, young children who are being killed in gang crossfires in Cape Flats communities.

- 5. Ms L J Botha: That the House debates the provision of health services in the Western Cape.
- 6. Mr R T Olivier: That the House notes the report on the Sans Souci Girls' High School in which it was found that a number of discriminating practices existed at the school that gave to understandable unhappiness among learners, and calls on Minister Schäfer to report what remedial actions were taken to effect the recommendation of the report.
- 7. Ms M N Gillion: That the House debates the closure of the G F Jooste Hospital in Manenberg and the absence of plans to replace it.
- 8. Ms B A Schäfer: That the House notes with concern the dismissive attitude of Rashid Kahn, Regional Director of Water Affairs, regarding the water crisis in the province, and supports the call by the Western Cape Government to declare the province a drought disaster area.
- 9. Mr R T Olivier: That the House notes that, despite claims by the WCED that there is an influx of thousands of learners into the province, the WCED has no plans to provide new teaching posts to meet the demand, and, therefore, call on the national Minister Angie Motshekga to institute an investigation into the state of education in this province.
- 10. Mr L E Magaxa: That the House, affirming that the Republic of South Africa is a unitary state led by the ANC government, condemns the visit by DA leaders to countries like Israel and Taiwan as undermining our country's international relations policies, and condemns DA leader Mmusi Maimane and his delegation and the DA Tshwane mayor Solly Msimanga for their recent defiant visits.
- 11. Mr R T Olivier: That the House institutes and investigation into the Rusthof Secondary School in Strand after parents and learners protested over the misuse of funds to renovate the school while learners still do not have access to water and male and female learners are forced to use the same toilets.
- 12. Ms S W Davids: That the House debates the skewed land-ownership patterns in the province and the government's lack of satisfactory progress with land reform.
- 13. Mr C M Dugmore: That the House notes and condemns the racist incident that occurred at Rondebosch Boys' High School where an audio recording of a group of learners using racist remarks against their fellow black learners was circulated on WhatsApp, and welcomes the speedy action by the school principal, and calls on all schools to intensify efforts to create a culture of non-discrimination, and to review codes of conduct at all schools.
- 14. Ms S W Davids: That the House debates the resisted relocation of Bromwell Street families to the harsh conditions at Wolwerivier.
- 15. Ms T M Dijana: That the House debates the lack of proper plans to address the continuous legacy of apartheid's spatial development in the province.
- 16. Ms N D Nkondlo: That the House debates the alarming loss of jobs in the Western Cape textile and clothing industry during the last five years under the DA government, and whether there are any effective strategies to mitigate this.

- 17. Ms M N Gillion: That the House debates the unhealthy close relations between the DA-run government and private property developers.
- 18. Ms M N Gillion: That the House debates the causes and challenges of the growing number of mental illnesses in the Western Cape.
- 19. Ms S W Davids: That the House debates the unwillingness of the government to supply affordable housing at the Tafelberg School site in Sea Point.
- 20. Ms T M Dijana: That the House debates the interference, obstruction and destabilisation by some DA members in the smooth running of committees, especially those members who arrange for DA-run municipalities not to appear when invited or called to give information, like yesterday, when the drought emergency and water shortage due to low dam levels were discussed, but with the Cape Town municipality glaringly absent.
- 21. Ms L J Botha: That the House condemns the carelessness of SASSA which, by their own accord, will not be ready to process grant payments to all beneficiaries by 1 April 2017.
- 22. Ms T M Dijana: That the House serves Cape Town mayor Patricia de Lille with a summons for failing to appear before the Standing Committee on Environmental Affairs to brief this constitutional oversight structure on the usage of water amidst the low dam levels experienced at present, and to explain why she defeats the work of this legislature.
- 23. Mr R T Olivier: That the House notes that more than 18 000 learners missed out on the first week of school as they were unplaced, further notes that the WCED always blames learners from the Eastern Cape to cover up its poor planning, and calls on the WCED to improve its registration processes to prevent the recurrence of this challenge next year.
- 24. Mr R T Olivier: That the House notes the refusal of the WCED to maintain and renovate properly the Uitsig Secondary School after it was vandalised during school holidays and its plans to close down the school, commends the learners and parents for their continued fight against the looming loss of their community school.
- 25. Mr K E Magaxa: That the House congratulates the ANC for winning two by-elections on 1 February 2017, taking both ward 11 and 25 in George.
- 26. Mr M Mnqasela: That the House notes that former ANC mayor Gordon April and municipal employee Raymond Wagenaar were found guilty in the Oudtshoorn court for theft and for abusing municipal resources.
- 27. Mr K E Magaxa: That the House notes that Hon Minister B Madikizela is now set to become the Premier of the Western Cape after being elected provincial leader of the DA, that it was untenable that a provincial leader of the party serves in a subordinate position to an expended former leader, and further notes that many in the party calls for the honourable Premier Helen Zille to step down and not frustrate the party from installing Minister Madikizela.
- 28. Mr C M Dugmore: That the House notes the corruption rot in the provincial Department of Transport and Public Works following the arrest of four more officials who formed part of the vehicle-registration syndicate, commends the police for making the arrests, and calls for a full investigation into corruption in the said Department.

- 29. Mr T R Olivier: That the House notes that the KwaFaku Primary School in Crossroads was found to be structurally unsafe, calls for an investigation into why so many school in the province are declared structurally unsafe, commends the parents who closed down the school to protect their children, and calls for the resignation of Minister Debbie Schäfer for failing to address this issue properly.
- 30. Mr S G Tyatyam: That the House notes the damning forensic report that served at SCOPA indicating corrupt actions and other problems at the provincial Department of Cultural Affairs and Sport, and calls for a thorough investigation into shenanigans by DA councillors at Swellendam.
- 31. Mr Q R Dyantyi: That the House notes that Cape Town merely wants the present low supply of water to be declared a disaster in order to milk the national fiscus for more money, also notes that this municipality had, on several occasions, issued municipal bonds to improve capital projects but is now shifting responsibility to the national government whereas it is in a position to raise loans to improve its water and reticulation systems on its own.
- 32. Mr M Mnqasela: That the House notes that the ANC failed to support a moment of silence for the more than 100 disabled patients who were moved from state institutions in Gauteng to allegedly unregistered NGOs where they eventually perished.
