2. Consideration and adoption of the draft Committee Report on the Negotiating Mandate on the *Protection, Promotion, Development and Management of Indigenous Knowledge Bill* [B 6D-16] (NCOP) (S76)

The Chairperson informed the Committee that the Select Committee on Cooperative Governance and Traditional Affairs has considered all the input of the Provinces and considered the following amendments at their negotiating mandate stage and has accepted the following amendments as per the C-list distributed to all Members. The Committee will submit a Negotiating Mandate on the *Protection, Promotion, Development and Management of Indigenous Knowledge Bill* [B 6D-16] (NCOP) (S76), which is a D-version of the Bill.

The Chairperson submitted the Draft Committee Report to the Committee, for its consideration.

Mr R Mackenzie moved to support the Bill. The Committee agreed to the motion.

The Committee further proposed that the Intellectual Property Laws Amendment Act, 2013 (Act 28 of 2013) be repealed as it does not appear to be compatible with the *Protection, Promotion, Development and Management of Indigenous Knowledge Bill* [B 6D-2016] (NCOP) (S76).

3. Consideration and adoption of Draft Committee Meeting Minutes of 12 June 2018

The Chairperson submitted the Draft Committee Minutes of the meeting held on 12 June 2018, which was considered and adopted.

4. Resolutions/Actions

The Committee RESOLVED to seek clarity on the advice given by the Committee staff relating to the negotiating mandate on the different versions of the Bill and if necessary, the Committee would rescind any decisions taken on the negotiating mandate at the next meeting.
