**3. Consideration and adoption of the draft Committee Minutes of a meeting held on 14 November 2018**


The Chairperson submitted the draft Committee Minutes of a meeting held on 14 November 2018, which was considered and adopted.

- 4.1.2 A list of names including designations of all employers that resigned from the Department of the Premier in the 2017/18 financial year;
- 4.1.3 A report on the funding that was utilised for the CCTV equipment fitted by the Department of Transport and Public Works;
- 4.1.4 A breakdown of the events including the amounts that the Department would be sponsoring for the remaining 2017/18 financial year; and
- 4.1.5 The financial breakdown of the non-profit institutions which includes the names of these institutions as referred to on page 2 of the Adjusted Estimates of Provincial Revenue and Expenditure.
